Project Name: Palabras De Dios (UP2025-0004)

- Location: 2511 Delta Fair Blvd/APN 076-432-032
- **Description:** The applicant is requesting a Minor Use Permit to establish a new church, Palabras de Dios, in an existing commercial unit of 28,984 square feet located at 2511 Delta Fair Blvd. The proposal includes interior tenant improvements and the addition of 16 new parking spaces located at the rear of the building, which would result in a total of 170 parking spaces.
- **CEQA:** The project is Categorically Exempt under California Environmental Quality Act Guidelines under Article 19 Section 15301, Existing Facilities. Class 1 consists of the operation, repair, maintenance, permitting, leasing, licensing, or minor alteration of existing public or private structures, facilities, mechanical equipment, or topographical features involving negligible or no expansion of existing or former use. The proposed use will be occupying an existing tenant space with negligible expansion of use.
