Description: The applicant requests approval of a use permit to operate a new tattoo studio within an existing commercial unit at 3658 Lone Tree Way (Raley's Shopping Center). The studio will operate 7 days a week between 10am – 6pm and by appointment during other hours. The studio will employ approximately 3 artists who would each serve one customer at a time.

CEQA: This project has been deemed Categorical Exempt from CEQA under Article 19, Section 15301, Class 1 Existing Facilities, because the project involves negligible expansion of the existing use.
