NOTICE IS HEREBY GIVEN that the City Council of the City of Antioch will hold a public hearing **on TUESDAY**, **JUNE 9**, **2020**, **at 7:00 P.M. or thereafter**, on the following matter:

MAYOR PRO TEM – Amending Sections 1.401 and 1.402 of Title 2 of the Antioch Municipal Code relating to the selection and term of service of the Mayor Pro Tempore to provide an alternative method of choosing a willing councilmember to serve as Mayor Pro Tempore that provides a preference for councilmembers who have not previously served as Mayor Pro Tempore and, if there is no councilmember or more than one councilmember who has not served as Mayor Pro Tempore, selects the councilmember who received the highest percentage of votes from his or her district in the most recent general municipal election at which the councilmember was elected. The ordinance would also change the Mayor Pro Tempore term of service from two years to one year.

If any person challenges the decision of the City in these matters in court, he or she may be limited to raising only those issues that were raised at the public hearing described in this notice.
