Sealed proposals will be received at the Office of the City Clerk in the City Hall, City of Antioch, California, until 2:00 p.m. on March 30, 2021, and publicly opened and read at the parking lot directly south of Antioch City Hall located at 200 "H" Street Antioch, California 94509 at 2:00 p.m. on March 30, 2021.

CITY HALL PLAZA IMPROVEMENTS AND LEO FONTANA FOUNTAIN P.W. 247-R

DESCRIPTION OF WORK

- A. Work to be Performed: The work includes the exterior remodeling of a portion of the existing City Hall Plaza including the construction of a new water feature; the demolition and removal of the existing fountain structure, steps, planter, planting area and related brick and concrete paving; removal and or relocation of existing lights and flagpole; construction of new fountain with stone cladding and installation of all related electrical and plumbing; construction of new on grade and above grade planters with requisite waterproofing, drainage, irrigation and soils; construction of new concrete and brick paving, including new steps and handrail and all other work specified in the Standard Specifications.
- B. Location: City of Antioch City Hall, 200 H Street, Antioch, CA 94531.

There is a mandatory pre-bid meeting on March 16, 2021 at City Hall Plaza, located directly north of Antioch City Hall, located at 200 H Street, Antioch, CA, 94531. The estimated cost of construction is \$400,000.00.

Attention is directed to the Contract Documents for complete details and bid requirements. Copies of the Contract Documents may be obtained by logging on www.blueprintexpress.com/antioch or by calling BPXpress Reprographics at (707) 745-3593. These may be obtained at a set price of \$100.00, plus shipping and handling, and is non-refundable. All bidders must purchase a complete bid set from BPXpress Reprographics in order to be considered responsive and to receive addenda notifications.

All Contractors and subcontractors listed on the bid proposal must be registered with the Department of Industrial Relations. No contract will be awarded to a Contractor or subcontractor unless registered with Department of Industrial Relations.

Notice is hereby given that the City Council of the City of Antioch, California, has obtained the general prevailing rate of per diem wages to be paid to the various craftsmen and laborers required to construct said improvements, a copy of which may be viewed at www.dir.ca.gov/DLSR/PWD.

Award of the contract, if it is to be awarded, will be to the lowest responsible bidder whose proposal complies with all the requirements described. Such award, if made, will be made at a meeting of the Antioch City Council within 90 days after the opening of the proposal.

No bidder may withdraw his bid after the time announcement for the opening, on or before the award and execution of the contract, unless the award is delayed for a period exceeding one hundred ten days.

No bid will be accepted from a contractor who has not been licensed in accordance with the provisions of Chapter 9, Division III of Business and Professions Code.

For any moneys earned by the contractor and withheld by the City of Antioch to ensure the performance of the contract, the Contractor may, at his request and expense, substitute securities equivalent to the amount withheld in the form and manner and subject to the conditions provided in Chapter 13 (commencing with Section 4590), Division 5, Title 1 of the Government Code of the State of California.

The special attention of prospective bidders is called to the "Proposal Requirements and Conditions" included in the General Provisions for full directions as to bidding, etc.

The City of Antioch reserves the right to reject any and all bids or portions thereof; to accept a bid or portion thereof; to postpone making the award for a reasonable length of time; or to waive irregularities not affecting substantial rights.
