DESCRIPTION OF WORK

- A. <u>Work to be Performed</u>: The work shall generally consist of replacing the existing wood retaining wall with a keystone retaining wall. Additional work shall include, but not be limited to, demo and removal of the wood retaining wall, excavation and backfill, remove tree and stump, installation of new keystone wall with drain rock and drain pipe, water pollution control and all other work shown on the plans, specified in the Standard Specifications, these Special Provisions and as directed by the Engineer.

Award of the contract, if it is to be awarded, will be to the lowest responsible bidder whose proposal complies with all the requirements described. Such award, if made, will be made at a meeting of the Antioch City Council within 90 days after the opening of the proposal.
