Sealed proposals will be received at the Office of the City Clerk in the City Hall, City of Antioch, California, until 2:00 p.m. on November 17, 2020, and publicly opened and read at the parking lot directly south of Antioch City Hall located at 200 "H" Street Antioch, California 94509 at 2:00 p.m. on November 17, 2020.

DESCRIPTION OF WORK

- A. Work to be Performed: The work shall generally consist of replacing the City's existing river intake facilities with a new intake pump station and fish screen consisting of three 8 million gallons per day (mgd) pumps (two duty, one standby), two intake pipelines and fish screens, and associated appurtenances, installation of a new raw water pipeline approximately 3,000 feet long that connects the City's existing raw water pipeline directly from the River to the City's Water Treatment Plant (WTP), a desalination plant with a finished water capacity of 6 mgd and related facilities, including reverse osmosis (RO); post-treatment systems; chemical feed and storage facilities; brine conveyance facilities; and other associated non-process facilities. A new pipeline, approximately 4.3 miles in length, will be constructed to convey brine from the desalination facility to the existing outfall at Delta Diablo.
- B. Locations: Water Treatment Plant located at 401 Putnam Street, River Pump Station located at 225 Fulton Shipyard Road, and Delta Diablo located at 2500 Pittsburg-Antioch Highway in Antioch, California.

A mandatory virtual pre-bid meeting will be held via video conference on October 13, 2020 at 9:00 a.m. or the pre-bid meeting must be viewed at www.blueprintexpress.com/antioch. Pre-bid site tours will be provided by appointment only.

The estimated cost of construction is \$67,000,000.

Attention is directed to the Contract Documents for complete details and bid requirements. Copies of the Contract Documents may be obtained by logging on www.blueprintexpress.com/antioch or by calling BPXpress Reprographics at (707) 745-3593. These may be obtained at a set price of \$750.00, plus shipping and handling, and is non-refundable. All bidders must purchase a complete bid set from BPXpress Reprographics in order to be considered responsive and to receive addenda notifications.

All Contractors and subcontractors listed on the bid proposal must be registered with the Department of Industrial Relations. No contract will be awarded to a Contractor or subcontractor unless registered with Department of Industrial Relations.

Notice is hereby given that the City Council of the City of Antioch, California, has obtained the general prevailing rate of per diem wages to be paid to the various craftsmen

and laborers required to construct said improvements, a copy of which may be viewed at www.dir.ca.gov/DLSR/PWD.

Award of the contract, if it is to be awarded, will be to the lowest responsible bidder whose proposal complies with all the requirements described. Such award, if made, will be made at a meeting of the Antioch City Council within 90 days after the opening of the proposal.

No bidder may withdraw his bid after the time announcement for the opening, on or before the award and execution of the contract, unless the award is delayed for a period exceeding one hundred ten days.

No bid will be accepted from a contractor who has not been licensed in accordance with the provisions of Chapter 9, Division III of Business and Professions Code.

For any moneys earned by the contractor and withheld by the City of Antioch to ensure the performance of the contract, the Contractor may, at his request and expense, substitute securities equivalent to the amount withheld in the form and manner and subject to the conditions provided in Chapter 13 (commencing with Section 4590), Division 5, Title 1 of the Government Code of the State of California.

The special attention of prospective bidders is called to the "Proposal Requirements and Conditions" included in the General Provisions for full directions as to bidding, etc.

The City of Antioch reserves the right to reject any and all bids or portions thereof; to accept a bid or portion thereof; to postpone making the award for a reasonable length of time; or to waive irregularities not affecting substantial rights.
