□ <b>Quantity</b> : Three (3) plan sets, 24 x 36
☐ <b>Conditions of Approval:</b> If applicable, a letter responding to each of the listed conditions of approval from the Planning Division permit, if applicable (Conditional Use Permit, Special Design Permit, Planned Development, Variance, etc.)
☐ <b>Cover Sheet:</b> Provide scope of work, project address, location map, flood zone, type of construction, square footage, occupancy classification(s), area calculations, applicable codes.
☐ <b>Architectural Plans:</b> Site/Plot plan, existing construction, demolition plan, new construction, floor plans, exiting plans, door schedules, equipment schedules, accessibility upgrades, details & sections, elevations and finishes, and roof plan.
☐ <b>Foundation Plan:</b> Foundations shall match the existing construction for additions.
☐ <b>Structural Plans:</b> Show floor framing plan, roof framing plan, and structural details.
Mechanical Plans: Cal-Green requires Heating & Cooling Systems be designed to meet energy standards
☐ <b>Electrical Plans:</b> Show the location of all receptacles, lights, motors, switches, disconnects, panels, services, transformer, Gensets, one line diagram showing conduit/conductor size and insulation type, exit signs, emergency lighting. Include a panel schedule showing all new and existing loads, building service size, and grounding/bonding.

☐ <b>Plumbing Plans:</b> Provide isometric plans for waste/vent, type of piping material, gas lines, water lines, water heaters with their input BTU rating.
☐ <b>Energy Calculations (Title 24):</b> Provide signed energy forms with calculations on a plan sheet for alteration, addition of shell lighting, and interior/exterior mechanical systems.
☐ <b>Civil Plans:</b> Show all site work, grading, storm drainage, and utilities
☐ <b>Storm Water Pollution Prevention Plan</b> : Refer to the <u>Checklist</u> for submittal requirements.
☐ <b>Waste Management Plan:</b> Required for all new structures; commercial additions and alterations; residential additions and alterations that add to conditioned space; demolition of any structure greater than 120 sq. ft.
☐ California Green Building Code with Check List on plans: Denote where on the plans all mandatory requirements are met.
