**WHAT IS BEING PROPOSED?**

**Cannabis Zoning Overlay Expansion** – The City of Antioch proposes amendment to the Zoning Map, Chapter 5 of Title 9 of the Antioch Municipal Code, and the Downtown Specific Plan to allow the expansion of the Cannabis Zoning Overlay and re-classification of cannabis uses. Specifically, the Cannabis Zoning Overlay would be expanded to include portions of downtown Antioch and the Somersville / Buchanan area.

The Planning Commission of the City of Antioch will hold a public hearing to review this proposal at 6:30 p.m. on Wednesday, SEPTEMBER 15, 2021.
