Project Description

The applicant is seeking Use Permit approval to operate a new retail cannabis dispensary at 2615 Somersville Rd. The subject site is a 25,000 sq. ft. lot with an existing 4,057 sq. ft. commercial building built in 1975. Tenant improvements include a new lobby, a large retail showroom, secure storage, order processing area, and office space. The business is proposed to operate from 9am-8pm, seven (7) days a week. The business will employ up to thirty-five (35) employees including management, security personnel, and delivery drivers.
