**Project Description**

The applicant is seeking Use Permit, and Design Review approval for a new automated car wash at 2410 Mahogany Way. The subject site is 0.81 acres and partially developed with a parking lot and building pad. The site was previously a restaurant use. The building was demolished in 2019. The project scope includes construction of an automated 3,628 sq. ft. car wash, with development of the parking lot to include vacuum stalls. The building will be comprised of "Mindful Gray" painted stucco in, "Mindful Gray" color, "sealskin" trim, brick veneer, and a prefab metal roof. Hours of operation are proposed to be 7 AM to 9 PM, 7 days a week. There will be 2 shifts and 2 employees per shift during business hours.
