## **Project Description**

The applicant is seeking Use Permit approval to conduct a Type-11 "Cannabis Distribution" operation at 2701 W. 10<sup>th</sup> St. The existing building includes a retail cannabis dispensary (UP-18-15) that was approved in 2019. The current operator is proposing to expand the business operation to include distribution services in an 8,482 sq. ft. unused portion of the existing building. Distribution is proposed to operate from 8am-8pm, seven days a week. There will be eight (8) employees associated with the distribution operation.
