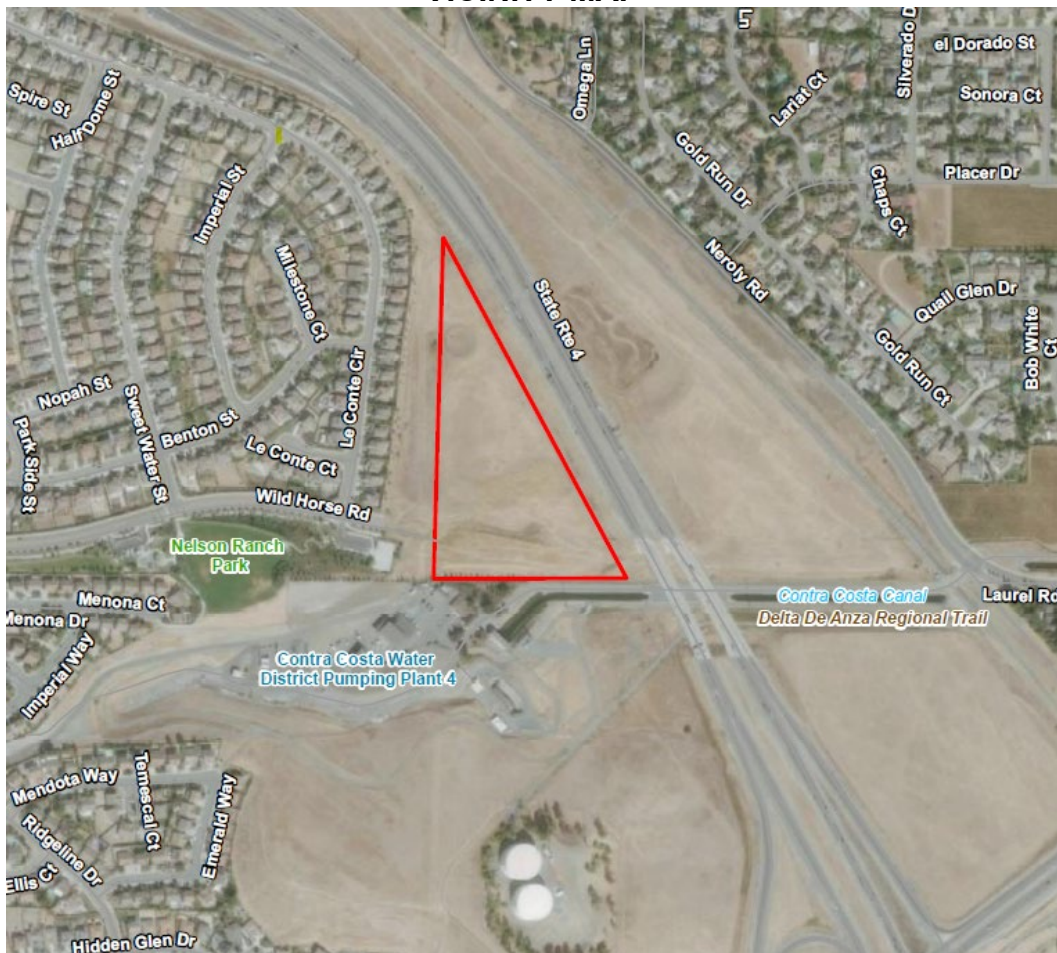
WHAT IS BEING PROPOSED?

Wild Horse Multifamily Project (PD-20-01, GP-20-03, AR-21-17) – The applicant, CCP-Contra Costa Investor, LLC (Applicant), seeks approval of the following: EIR Certification, General Plan Amendment, Rezone to Planned Development District, Vesting Tentative Map, Final Development Plan, and Design Review for the development of a 126 multifamily unit and associated improvements on approximately 12 acre project site.

The project is located at the terminus of Wild Horse Road, between Le Conte Circle and State Route (SR) 4. **Assessor's Parcel Number (APN) 041-022-003.**
