


## NOTICE OF PUBLIC HEARING ON NOVEMBER 3, 2021

## WHAT IS BEING PROPOSED?

**UP-21-06 – Delta Labs, Inc –** The applicant, Rick Hoke/Delta Labs Inc, requests approval of a Use Permit for a cannabis operation of a non-hydrocarbon (non volatile) extraction lab that produces THC concentrate. The proposed project would consist of operating out of an existing suite and occupy is less than 2,000 sf and located on the southwest corner of the building. The operations would include using cold extraction equipment to produce the product. The Project is located at 2101 W. 10<sup>th</sup> Street (APNs 074-051-005). This project has been found Categorically Exempt from the requirements of the California Environmental Quality Act.
