Laurel Ranch Use Permit and Landscaping (UP-21-15, AR-21-13) – The applicant, KB Home, is requesting a use permit and design review for project landscaping, soundwalls, minor revisions to the previously approved Stormwater Control Plan, and associated project improvements for the Laurel Ranch residential project. The proposed project is consistent with the 2016 approvals, therefore, further review under the California Environmental Quality Act (CEQA) is not required.
