Pursuant to Antioch Municipal Code §1-5.09 the City may collect any past due Administrative Citation fines, Abatements or late payment charges by use of special assessment liens and all action for recovery of money.

A Notice of Intent to Record Lien (Attachment B) was sent to each property owner who is entitled to notice reflecting the property address directly connected to conditions or activities on the subject real property, assessor's parcel number, the municipal code violation, administrative citation fine and copy of the administrative citations.

REQUEST:

Ray C. Jackson and Anne Brewer, has requested a hearing to appeal Citation #28521, issued August 11, 2021 for the following violations of the Antioch Municipal Code:

§ 5-1.202 SPECIFIC NUISANCES PROHIBITED.

It is unlawful and a public nuisance for any property owner or any person leasing, occupying or having possession or control or dominion of any premises in this city to maintain such premises or to permit, suffer or allow such premises to be maintained in such a manner that any one or more of the conditions or activities described in the following divisions are found to exist, with such list not intended to be exclusive:

- (A) Property inadequately maintained.
- (2) Premises on which overgrown, dead or decayed trees, weeds or other vegetation pose a risk of harm to the public, or constitute visual blight or reduce the aesthetic appearance of the neighborhood, or are offensive to the senses, or are detrimental to the use and enjoyment of nearby properties, or reduce nearby property values due to its visibility from the public right-of-way;

§7-2.623 NO ENCROACHMENT OF PUBLIC RIGHT OF WAY

- (A) Planting or erection
 - (2) No tree, hedge, shrub, or other planting whatever, fence, or similar structure shall be maintained across any existing walkway in a sidewalk area or shoulder. No encroachment of any nature which impedes/obstructs the public right-of-way or which impedes adequate sight distance.

§ 9-5.1210 REGULATIONS ON TREE LOCATIONS. Trees planted on private property, outside of a city right-of-way, shall be at least five feet from the sidewalk. Branches from such trees shall be trimmed to clear the sidewalk by at least seven feet and to clear the street by at least 14 feet.

BACKGROUND INFORMATION:

On <u>07/13/2021</u>, I performed an inspection of the property located at 1123 Cook St. I noted massive overgrown encroaching trees, shrubs, and weeds. The trees, shrubs, and weeds were encroaching upon the public right of way and there is a line-of-sight issue in regard to the vehicles entering/exiting the driveway. The garbage cans were placed upon the edge of the driveway and there was an unregistered vehicle parked in the driveway. There appeared to be junk and misc. debris in the inner landscape portion of the yard. I issued a notice of violation advising of the violations and requesting all violations be corrected within 10 days. True and accurate copies of the notice of violation and photographs from July 13, 2021, are attached as "ATTACHMENT 1".

On <u>07/13/2021</u>, I attempted phone contact with the property owner. I spoke with his sister Rebecca Jackson who currently resides in the home and takes care of her elderly mother. She was completely offended that I worked in Antioch but did not live in Antioch. She wanted the complete bio of all code officers, names, cities in which they reside, and how long they had been working for the City of Antioch. I declined to answer. "Code Officers are misinterpreting the municipal codes, and her property is in full compliance." I offered to meet her at her property, and she declined the invitation. "We are in the middle of a pandemic, and I am compromised." She agreed to meet me at the office. I have created a hardship because COVID is far from over and she is still in full lockdown. If I make her cut her trees it is leaving her, as the current resident, unsafe. I stated that I am more than happy to explain the violations upon the property in person. "All other code officers have cleared my property in the past." I attempted to explain the line-of-sight issue with the hedges and trees blocking her view when exiting her driveway. She will call me back later today or tomorrow to set a time to meet me at the office. She has 10 days to bring the property into compliance unless an extension is requested. She requested the Code Enforcement Manager's phone number. I provided the information. No extension was requested.

On <u>07/19/2021</u>, I attempted phone contact with Rebecca to discuss all violations on the property. I left a message requesting a call back. I requested a date and time she would like to come into the office to discuss the violations on the property.

On <u>07/19/2021I</u>, I received a call back with a message from Rebecca. She was extremely upset. She cannot believe my expectation was to meet with her this soon. She does not have time for me or my issuance of the notice of violation... The line disconnected.

On <u>08/12/2021</u>, Upon reinspection of the property, I noted all violations remained except for two, the vehicle that was now registered current. (License plate #4WBR779, valid till 06/22) The house numbers were visible on the mailbox and curb. The weeds, shrubs, and trees were overgrown surrounding the property and encroaching upon the public right of way creating a line-of-sight issue when entering or exiting the driveway. I issued a citation, citation #28521, in the amount of \$540.00.

True and accurate copies of the citation and photographs from July 13, 2021, are attached as "ATTACHMENT 2".

On <u>08/23/2021</u>, I received a phone call from Ray Jackson, the property owner and brother of the tenant, Rebecca Jackson. He advised me that his sister was appealing the citation. She has had many dealings with code enforcement, and she believes she is not in the wrong. Her house is in full compliance with the Antioch Municipal Code, and she will not be correcting any of the vegetation or line of sight issues. He stated she is difficult to deal with and stubborn at times. She will need to have her say and hear she is wrong before she corrects anything. I offered to meet the property owner Ray, at the property to show him why the line-of-sight issues were so important to correct. He declined. I advised the property owner that the property belonged to him, and we inevitably hold the property owner accountable for all remaining violations. He wanted to verify that all citations will stop until the hearing scheduled for October 7th. The house remains out of compliance.

On <u>09-28-2021</u>, I reinspected the property for compliance. The property remains out of compliance. There are trees, shrubs, and overgrown vegetation encroaching upon the public right of way and street. There is overgrown vegetation on both side yards. The line-of-sight issue remains when entering/exiting the driveway and pulling onto Cook St from Macaulay St. True and accurate copies of the citation and photographs September 28, 2021, are attached as "ATTACHMENT 3".


ARTICLE 11: SITE OBSTRUCTIONS AT INTERSECTIONS

§ 9-5.1101 SITE OBSTRUCTIONS AT INTERSECTIONS.


No structure, vehicle, trailer, wall, fence, hedge or vegetation greater than three feet in height shall be permitted within a clear vision zone, with the exception of tree canopies featuring branches no lower than eight feet above the edge of pavement (see Figure 4). Clear vision zones at uncontrolled, non-signalized intersections shall be located within a triangular area bounded by the curb lines and a diagonal line joining points on the curblines located 50 feet back from what would be the point of these curblines' intersection. At controlled signalized intersections a triangle having 25 foot tangents at the curblines shall apply. For driveways a similar clear vision triangle shall be utilized featuring 25 foot tangents at the outside line of the driveway and the curbline (see Figure 5). These provisions shall not apply to existing public utility poles, traffic signs and signals, or corners where the contour of the land itself prevents visibility.



ADMINISTRATIVE BOARD OF APPEALS

GENERAL INFORMATION FOR PERSONS APPEALING CITATIONS

The Administrative Board of Appeals is comprised of five Antioch residents, who are appointed by the Mayor and have volunteered their time to hear your appeal. The Board Members do not receive monetary compensation for their time and they are not employees of the City. They do not make or control the law. They are hearing officers who will review your appeal because you have requested the City do so. As the person making the appeal (the appellant) please keep in mind the following:

Schedule of Hearing:

- When an appeal is requested, it is typically scheduled for the first Thursday of every month.
- You will receive written notice of the date and time of the appeal hearing from the City Clerk's office.
- The Agenda and Staff Reports will be posted onto our City's Website 72 hours before
 the Board of Administrative Appeals Hearing date. To view the Board of
 Administrative Appeals Agenda information, click on the following link:

When You Don't Show For Your Hearing:

If you do not appear at the hearing time and date you have been notified of, and unless you have provided the City Clerk seventy-two (72) hour notice <u>before</u> the hearing that you are requesting a postponement, your appeal will be heard without your participation.

How You Will Act At Your Appeal Hearing:

- You, and anyone else who is participating the appeal at your request, will maintain a respectful attitude at all time.

- The Board will read your item of appeal from its Agenda.
- The Board will then ask City staff to present an oral report with regard to your citation. The Board may ask questions of City staff after the oral report. This oral report will be for five (5) minutes.
- After staff has provided its report, and the Board is finished with its questions of staff, you will then be called upon to speak.
- You will have five (5) minutes to present the reasons why you are appealing the citation.
- Any other additional persons who may oppose or support your appeal will have three (3) minutes to speak.
- The Board may then ask City staff for a rebuttal to the statements you or others made in support or opposition of your appeal. This rebuttal is only for **three (3) minutes**.
- Then the hearing is completed and the Board will then issue its ruling on your appeal.

Your Burden:

- It is your appeal and therefore you bear the burden to prove that the citation was wrongfully issued.
- To win your appeal, you must have a majority of the Board uphold your appeal (3 of 5, or 2 of 3).
- If the Board determines there was in fact good reason to issue the citation, your appeal will be denied and the citation amount that you deposited to have your appeal will not be refunded.

How The Board Will Rule:

The Board can only rule one of two ways:

- To uphold your appeal and dismiss the citation.
- To deny your appeal and uphold the citation.

Written Findings and Order:

- The Board will render their findings and recommendations after the hearing is concluded or as soon as possible.
- You will be mailed the written decision of hearing within ten (10) days of the hearing.

Appeal re: Administrative Code Citation No. 28521, Case No. CE-2107-123; C. Ray Jackson, Anne Brewer, property owners. Rebekah Jackson, resident.

Note that the Citation No. 28521, dated 8-11-2021, was postmarked 8-16-21 and received at both the Antioch and Sonoma residence addresses associated with the 1123 Cook St, Antioch, CA property on 8-18-2021, leaving only 3 days to respond/appeal, with the tenth day, 8-21-2021, being a weekend day.

The citation references the following code sections (see below) and in writing on the citation references the following in this order and wording:

5-1-202(A)(2)- "overgrown veg" 7-2623(A)(2)- "encroachment" 9.5.1210- "trees overgrown"

The citation continues in the note section in the following manner in writing:

"Cut, trim and dispose of all overgrown, encroaching vegetation including trees hanging too low over the sidewalk and street."

Appeal Response is below each referenced Code Section below and is indicated as "RESPONSE:"

§ 5-1.202 SPECIFIC NUISANCES PROHIBITED.

- (A) Property inadequately maintained.
- (2) Premises on which overgrown, dead or decayed trees, weeds or other vegetation pose a risk of harm to the public, or constitute visual blight or reduce the aesthetic appearance of the neighborhood, or are offensive to the senses, or are detrimental to the use and enjoyment of nearby properties, or reduce nearby property values due to its visibility from the public right-of-way;

RESPONSE: (photo attached). In reference to the citation as noted above- "overgrown veg." The term "overgrown" can be subjective and can also suggest messy and unkept. The two trees, a Mulberry and a Berry tree- as there is no other vegetation that could apply- are lush and healthy, they are well maintained and kept up. They are completely on private property and pose absolutely no risk to the public in any possible way. They are maintained such that not only do they not reduce the aesthetic appearance of the neighborhood, it is quite the opposite in that they enhance the neighborhood. The immediate neighbors- Mike Quintana, Joseph and Connie Langston- who affront the property, have no objections to the trees in any manner and indicate that they look nice and are not offensive in any way. The trees in no way present any type of detriment to any other property- they have a very wide clearance from any other nearby property and again, are on private property. The trees in no way reduce property values- the house directly across on Cook St sold this past December for \$50,000 over asking price and the house to the rear recently sold for full price which was over \$100,000 over appraised value. Rebekah Jackson has resided at the residence for over ten years and received regular compliments about the trees- they are beautiful, etc.- and has never received any complaints from neighbors. They also provide needed shade, actually reduce noise and contribute to the value of the area.

Note that in 2017 a code enforcer- a retired police officer- cleared the trees, saying they were "no problem" and per notes "everything is fine here," and also stating they were on

private property, away from other properties. In 2019 a code enforcer also cleared the trees, noting the same as above: on private property, not a problem, etc.

§ 7-2.623 TREES, HEDGES, FENCES, AND SHRUBBERY.

- (A) Planting or erection.
- (2) No tree, hedge, shrub, or other planting whatever, fence, or similar structure shall be maintained across any existing walkway in a sidewalk area or shoulder. The intent of this restriction is to keep free a walkway for pedestrian or other lawful public travel without interference by or with vehicular travel. No encroachment of any nature shall be permitted or maintained which impedes, obstructs, or denies such pedestrian or other lawful travel within the limits of the right-of-way of a public street or which impairs adequate sight distance for safe pedestrian or vehicular traffic.

RESPONSE: "encroachment." Does not apply. The trees are not impeding the sidewalk, travel or sight distance in any form per this section whose intent is to "keep free a walkway for pedestrian or other lawful public travel without interference by or with vehicular travel." The code enforcer in 2019 explained this section using a pre-printed diagram and the trees are not impeding. The two trees- again a Mulberry and a Berry tree- are completely on private property and are well-maintained and kept up. They are both regularly trimmed away from the public right-of-way.


§ 9-5.1210 REGULATIONS ON TREE LOCATIONS.

Trees planted on private property, outside of a city right-of-way, shall be at least five feet from the sidewalk. Branches from such trees shall be trimmed to clear the sidewalk by at least seven feet and to clear the street by at least 14 feet.

RESPONSE: (photos with tape measure). "trees overgrown." The trees are already maintained at the proper height clearance over the sidewalk/street, per the code, on an ongoing and regular basis and have always been maintained as such. This is assuming that the "at least 7 feet" and "at least 14 feet" over the sidewalk and street respectively are the same standard 7 and 14 feet as measured by the Craftsman brand tape measure. (See photos with tape measure at the 7 foot height). The photos provided by the code enforcer from 8/10/2021, as dated on the photos, were seemingly taken from the street or a car without benefit of measurement. The attached photos have a tape measure that is set at the 7 foot marker for the sidewalk. The street area for the Berry and Mulberry trees does not have anything over the street.

Of further note- the trees are well on private property and use thereof, and are maintained in a manner that is for the benefit, enjoyment and protection of the resident; they do not impede or bother any other areas.

REQUEST:

Laura Cochnauer has requested a hearing to appeal Citation #28523, issued 08-10-2021 for the following violations of the Antioch Municipal Code:

§ 5-1.201.1 WHEN STORAGE OF A RECREATIONAL VEHICLE IS A PUBLIC NUISANCE.

It is hereby declared a public nuisance for any person owning, leasing, occupying, or having charge or possession of any premises in the city to park or store any recreational vehicle, including but not limited to, a trailer, boat, fifth-wheel trailer, motorhome, motorized cart, tent trailer, travel trailer, utility trailer, travel coach, bus, unmounted camper shell, or other mobile recreational equipment or watercraft or any empty trailer intended for or capable of carrying any of the above, in any front or side yard in a residential district, including the driveway, subject only to the following exceptions:

BACKGROUND INFORMATION:

On <u>06-22-2021</u>, upon inspection of the property, I noted an RV/Camper parked upon an unpaved surface, and on the landscape portion of the property on the side yard. I took and uploaded photographs. I issued a notice of violation advising of the violation and requiring the violation be corrected within 10 days. A true and accurate copy of the Notice of Violation from June 22, 2021, is attached as "ATTACHMENT 1".

On <u>07-28-2021</u>, upon reinspection of the property, I noted the RV/camper had been removed from public view. There were three cars parked upon the landscape portion of the property. The third vehicle was encroaching upon the public right of way, blocking the sidewalk completely. There was junk and misc. debris in the driveway and placed upon the sidewalk. and a huge dirt mound piled upon the driveway. I attempted contact via knock and talk and via telephone with negative results. I left a message requesting a call back. I issued an additional NOV representing the additional violations upon the property. True and accurate copies of the Notice of Violation and photographs from the inspection on July 28, 2021, are attached as "ATTACHMENT 2".

On <u>08-04-2021</u>, I received a phone call from the PO, Laura Cochnauer. She was very upset and did not see how her property was in violation. I explained the junk and misc. debris on the side yard and sidewalk need to be removed and cannot be stored upon the public right of way. The vehicle parked upon the sidewalk needs to be placed so not to impede upon the public right of way. I explained that the surface the vehicles were parked upon is considered landscape and could not be parked upon whether improved or not. She asked what I was doing about the tree in the center dog bone. It is practically growing into the power lines. I advised that the trees would be the Public Works Department. I took a photograph of the center dog bone and reported the complaint to our Community Development Technician and had her pass along the complaint to Public Works. She went on to tell me how if I don't stop harassing her and her neighbors the situation will escalate the next time I drive through the neighborhood. The line disconnected.

On <u>08-12-2021</u>, upon reinspection of the property, I noted all junk and misc. debris had been removed from public view and the vehicle encroaching upon the public right of way was parked elsewhere. The RV/camper was back parked upon the side yard landscape in public view. I took and uploaded photographs. I issued a citation, citation #28523, in the amount of \$340.00.

True and accurate copies of the citation and photographs of the property from the inspection on August 12, 2021, are attached as "ATTACHMENT 3".

On <u>08-23-2021</u>, Curt Michael, Code Enforcement Manager, spoke with Laura Cochnauer who had questions about appealing the citation and enforcement activity. He advised that the citation amount must be paid and an appeal fee of \$50 must be submitted for a hearing per the City Clerk's office. She stated that the RV is her only source of transportation and then discussed vehicles that she owns but are for sale so they aren't driven. He explained the code requirements for front yard RV storage and the appeal process again. She then wanted to complain that the officer has discretion to enforce and should not be enforcing

this violation. She then advised it was harassment. He explained that there are violations present, enforcement action was taken and that she can appeal the citation and present her case before the BOAA. He granted her a seven day extension to August 27, 2021 to appeal citation #28523.

On <u>08-24-2021</u>, upon reinspection of the property. I noted all violations had been cleared. The large RV/Camper parked upon the side yard landscape was no longer in public view. I took and uploaded photograph and the case was closed. True and accurate copies of the photographs from the inspection on August 24, 2021, are attached as "ATTACHMENT 4".

On <u>09-14-2021</u>, I was performing an inspection of another property on Macaulay Street pertaining to a separate case and I noted an unpermitted RV/travel trailer parked upon the landscape at 1119 Macaulay St. This RV/travel trailer was an entirely different vehicle than the one previously parked upon the property. As detailed in the events of the enforcement activity for this case, the property owner has been educated against storing RVs on the front of the property however, continues to do so. Due to the pending appeal of citation #28523, I did not conduct any enforcement action upon for this repeat violation of AMC 5-1.201.1. However, enforcement action will resume upon this property for the repeat violation, once the current appeal process has concluded. A true and accurate copy of the photograph taken September 14, 2021, showing the repeat violation of AMC 5-1.201.1, which has not been enforced at this time, are attached as "ATTACHMENT 5".

On <u>09-28-2021</u>, I performed an inspection upon the property and noted one vehicle parked in the driveway, a white Ford F250, CA plate #6V71688, registered current to Laura Cochnauer since February 28, 2021. There was also a Toyota Sequoia, CA plate #5LFK635, registered current to Laura Cochnauer since 10/31/2020. This is mentioned because during her conversation with Curt Michael, Code Enforcement Manager, the appellant stated that the RV is her only source of transportation. These two currently registered vehicles belonging to the appellant show that the RV is not the only source of transportation. Also, the same RV/travel trailer found on September 14, 2021, remains on the front of the property and the vehicles and RV/travel trailer are parked on an unpaved surface. True and accurate copies of the photographs from the inspection on September 28, 2021, are attached as "ATTACHMENT 6".

RECOMMENDATION:

Recommendation to uphold the Citation #28523 in the amount of \$340.00 issued to Laura Cochnauer on August 10, 2021, for violation of Antioch Municipal Code §5-1.201.1

ADMINISTRATIVE BOARD OF APPEALS

GENERAL INFORMATION FOR PERSONS APPEALING CITATIONS

The Administrative Board of Appeals is comprised of five Antioch residents, who are appointed by the Mayor and have volunteered their time to hear your appeal. The Board Members do not receive monetary compensation for their time and they are not employees of the City. They do not make or control the law. They are hearing officers who will review your appeal because you have requested the City do so. As the person making the appeal (the appellant) please keep in mind the following:

Schedule of Hearing:

- When an appeal is requested, it is typically scheduled for the first Thursday of every month.
- You will receive written notice of the date and time of the appeal hearing from the City Clerk's office.
- The Agenda and Staff Reports will be posted onto our City's Website 72 hours before
 the Board of Administrative Appeals Hearing date. To view the Board of
 Administrative Appeals Agenda information, click on the following link:
 https://www.antiochca.gov/government/agendas-and-minutes/board-of-administrative-appeals/.

When You Don't Show For Your Hearing:

If you do not appear at the hearing time and date you have been notified of, and unless you have provided the City Clerk seventy-two (72) hour notice <u>before</u> the hearing that you are requesting a postponement, your appeal will be heard without your participation.

How You Will Act At Your Appeal Hearing:

- You, and anyone else who is participating the appeal at your request, will maintain a respectful attitude at all time.
- If you or anyone else does not maintain a respectful attitude, you may be asked to "leave" the hearing by the Board Chairperson.
- Your appeal is not an opportunity to debate or argue with City staff or Board Members. Any questions should be directed to the Board Chairperson.
- When you speak, you should talk about the reasons why you feel the citation was wrongfully issued.

ADMINISTRATIVE BOARD OF APPEALS

GENERAL INFORMATION FOR PERSONS APPEALING CITATIONS

The Administrative Board of Appeals is comprised of five Antioch residents, who are appointed by the Mayor and have volunteered their time to hear your appeal. The Board Members do not receive monetary compensation for their time and they are not employees of the City. They do not make or control the law. They are hearing officers who will review your appeal because you have requested the City do so. As the person making the appeal (the appellant) please keep in mind the following:

Schedule of Hearing:

- When an appeal is requested, it is typically scheduled for the first Thursday of every month.
- You will receive written notice of the date and time of the appeal hearing from the City Clerk's office.
- The Agenda and Staff Reports will be posted onto our City's Website 72 hours before
 the Board of Administrative Appeals Hearing date. To view the Board of
 Administrative Appeals Agenda information, click on the following link:
 https://www.antiochca.gov/government/agendas-and-minutes/board-of-administrative-appeals/.

When You Don't Show For Your Hearing:

If you do not appear at the hearing time and date you have been notified of, and unless you have provided the City Clerk seventy-two (72) hour notice <u>before</u> the hearing that you are requesting a postponement, your appeal will be heard without your participation.

How You Will Act At Your Appeal Hearing:

- You, and anyone else who is participating the appeal at your request, will maintain a respectful attitude at all time.
- If you or anyone else does not maintain a respectful attitude, you may be asked to "leave" the hearing by the Board Chairperson.
- Your appeal is not an opportunity to debate or argue with City staff or Board Members. Any questions should be directed to the Board Chairperson.
- When you speak, you should talk about the reasons why you feel the citation was wrongfully issued.

How The Appeal Hearing Will Go:

- The Board will read your item of appeal from its Agenda.
- The Board will then ask City staff to present an oral report with regard to your citation. The Board may ask questions of City staff after the oral report. This oral report will be for five (5) minutes.
- After staff has provided its report, and the Board is finished with its questions of staff, you will then be called upon to speak.
- You will have **five (5) minutes** to present the reasons why you are appealing the citation.
- Any other additional persons who may oppose or support your appeal will have three (3) minutes to speak.
- The Board may then ask City staff for a rebuttal to the statements you or others made in support or opposition of your appeal. This rebuttal is only for **three (3) minutes**.
- Then the hearing is completed and the Board will then issue its ruling on your appeal.

Your Burden:

- It is your appeal and therefore you bear the burden to prove that the citation was wrongfully issued.
- To win your appeal, you must have a majority of the Board uphold your appeal (3 of 5, or 2 of 3).
- If the Board determines there was in fact good reason to issue the citation, your appeal will be denied and the citation amount that you deposited to have your appeal will not be refunded.

How The Board Will Rule:

The Board can only rule one of two ways:

- To uphold your appeal and dismiss the citation.
- To deny your appeal and uphold the citation.

Written Findings and Order:

- The Board will render their findings and recommendations after the hearing is concluded or as soon as possible.
- You will be mailed the written decision of hearing within ten (10) days of the hearing.

The intension of this letter is to contest the citation (#28523) I received from Amanda Lunsford.

On 6/22/21 I received a violation. The violation was for my motorhome being parked on an unimproved surface, and for not being out of public view. I have a garage north east of my house. The driveway leading to it runs east/west on the north side of my house. Once upon a time it had been paved with gravel. Over the years the gravel had been infiltrated with dirt and clay, as my property slopes. Despite that, I immediately corrected the violation within the time limit I was given by resurfacing the driveway. I removed 3 cubic yards of dirt and gravel and replaced it with brand new clean gravel.

As for my motorhome being in public view, I didn't move it because it's my only means of transportation. I have since then received a Citation for not removing my motorhome from public view. I work rotating 12.5 hour shifts that leave me very tired. I stay in my motorhome just outside the parking lot during a set of shifts and then drive home. It's safer for me and it allows me to be available in case I'm needed in between shifts. It's not uncommon for people in my line of work to do that. I'm saving up for some repairs so that I can start driving a regular vehicle again.

My motorhome is in great mechanical condition. It's in great cosmetic condition. It's not a public nuisance. It's not injurious to health, or indecent, or offensive to the senses, or an obstruction to the free use of property, so as to interfere with the comfortable enjoyment of life or property by an entire community or neighborhood, or by any considerable number of persons, or unlawfully obstructs the free passage or use, in the customary manner, of any navigable lake, or river, bay, stream, canal, or basin, or any public park, square, street, or highway. I've spoken to all of my neighbors about it. None of them are bothered by it. Having to move it from my driveway only ads to parking congestion on the streets and creates a hardship for me, having to constantly move it around. I understand that sometimes there is a need to enforce this code to prevent riffraff from disturbing the residents of this city, but there's simply no need for it in my case.

I've spoken to both Amanda Lunsford and Curt Michael, and neither of them demonstrate appropriate discretion or reasonableness. My neighbor and I were both in violation of the same code yet Amanda only sent me a violation for it. Last month I cleaned out my garage. I took some of my belongings to the dump but I had items that I thought people could use. So I posted a free ad and set the stuff out on the edge of the sidewalk. Amanda sent me a violation for that. While there are several cars on my street parked half way on the sidewalk as a common practice, not being cited. She even sent me a violation for the dirt pile that came from the surface she had me improve. I also had that posted for free and was working on getting rid of it.

The Citation I'm contesting says that my motorhome is a "Public Nuisance" but it's not. Not by definition or otherwise. There are so many real public nuisances that put the publics safety at risk that the <u>city is responsible for</u> that are being ignored. The hypocrisy is enough to drive anybody mad.
