Chairperson Simpson called the meeting to order at 3:07 P.M. on Thursday, January 5, 2017 in the Council Chambers.

PLEDGE OF ALLEGIANCE

Chairperson Simpson led the board, staff, and public in the Pledge of Allegiance.

1. CONSENT CALENDAR

A. APPROVAL OF ADMINISTRATIVE APPEALS MEETING MINUTES FOR DECEMBER 1, 2016

On motion by Board Member Rouse, seconded by Board Member Schleder, the Board of Administrative Appeals approved the Minutes of December 1, 2016. The motion carried the following vote:

B. APPROVAL OF THE LEVY OF SPECIAL ASSESSMENTS ON CERTAIN PROPERTIES FOR UNPAID ADMINISTRATIVE CITATIONS & ABATEMENTS FOR THE MONTH OF OCTOBER 2016

On motion by Board Member Gonsalves, seconded by Board Member Adeyemi, the Board unanimously confirmed each assessment and the amount thereof, as proposed or as corrected and modified, and order it assessed against the property. The Board also directed that the same be recorded with the Contra Costa County Recorder's Office and thereafter the assessment shall constitute a special assessment and lien against the property.

2. REGULAR AGENDA

City Clerk Simonsen administered the Oath for all persons present intending to testify on the appeal.

A. CITATION NO.'S 25447 AND 25460/CASE NO. CD1609-067 — APPEAL OF TWO ADMINISTRATIVE CITATIONS ISSUED REGARDING INOPERABLE VEHICLE [§5-1.202(D)] AND JUNK AND RUBBISH [§5-1.202(A)(1)(a)] FOR CALVIN LAVINDER, 1401 TULIP DRIVE, ANTIOCH, CA

Code Enforcement Officer Gallegos presented the staff report dated December 28, 2016 recommending the Board of Administrative Appeals uphold the citation issued to Calvin Lavinder for violation of the Antioch Municipal Codes §5-1.202(A)(1)(a) and §5-1.202(D).

In response to Board Member Rouse, Code Enforcement Officer Gallegos explained that when he had spoken to occupant, Ricky, he had specified that if there was progress in the abatement of the property, he would allow more time; however, there was no progress and no additional time was granted. He noted after the second citation, Mr. Lavinder indicated he needed 3-4 more days to clean up after the tenant was evicted and he was given 5 days. He stated Mr. Lavinder was informed that although things were progressing, the remaining items needed to be corrected. He explained the initial violation was observed on September 21, 2016 and the property was found to be in compliance on November 28, 2016. He stated time limits were explained on the notice of violation which he believed were understood and Mr. Lavinder was aware that in spite of cleaning up the property by November 28, 2016, he would remain responsible for the additional \$500.00 in fines.

In response to Board Member Gonsalves, Code Enforcement Officer Gallegos clarified the notice of violation was sent to the owner, at the address on County records. He stated he was able to obtain a phone number for Mr. Lavinder on October 19, 2016 and at that time, he was informed of the restraining order; therefore, he allowed Mr. Lavinder additional time. He reported the inspection on November 14, 2016 showed more items that appeared to be attributed to someone moving out of the home. He noted he had attempted to contact someone at the residence; however, no one answered the door and Mr. Lavinder's cell phone was not accepting calls. He clarified on October 19, 2016, Mr. Lavinder stated he was not living in the residence and had not received the Notice of Violation letter. He noted he informed Mr. Lavinder that he needed to update his address with the County Registrar's office.

Calvin Lavinder, Appellant, reported that due to threats he had received, he obtained a restraining order and had his tenant evicted. He reported he paid the original fine and thought the issue had been taken care of as he was unaware the last citation was issued because his mail had been destroyed by his tenant.

In response to Board Member Gonsalves, Mr. Lavinder stated as a result of the restraining order for the tenant to move out of his house, and when he did so, he left his possessions in the front yard.

In response to Board Member Simpson, Mr. Lavinder stated he had received and paid the first administrative citation and he was unable to pay \$700.00 for the additional citation.

Board Member Rouse thanked Mr. Lavinder for exercising his right to file an appeal.

In response to Board Member Rouse, Mr. Lavinder reported he was also hospitalized during this time period. He noted the evicted tenant owned all of the materials left in the yard.

In response to Board Member Gonsalves, City Clerk Simonsen explained the process for applying for the Hardship Waiver. He stated after discussion with the appellant, it appeared he was appealing \$750.00 in charges.

Cira Acosta commented that tenant Forest had threatened Mr. Lavinder so she assisted him in filing for a restraining order. She reported that when the tenant was evicted, he had left his garbage in the yard. She noted Mr. Lavinder then had to hire and pay for someone to remove the additional items. She explained that Mr. Lavinder had not received the second citation because Forest had hidden his mail.

Board Member Gonsalves stated he believed Mr. Lavinder acted prudently noting he had a troubled tenant, obtained a restraining order, paid the fine, and within 5 weeks, cleaned the property. Additionally, in light of his elder abuse and landlord/tenant issues, he felt his actions were prudent and timely.

Chairperson Simpson stated on November 7, 2016, Code Enforcement inspected the property and the junk and rubbish had been removed. She noted at that time, only the tarp removal remained. She further noted the additional items on November 14, 2016, appeared to have been left by the evicted tenant and not a continuation of the first violation; therefore, she was concerned the second citation was elevated to \$500.00.

Board Member Rouse stated considering all circumstances surrounding compliance, the request to clean up and the efforts by the appellant to comply; the facts supported a decision to uphold the appeal and waive all fees requested.

Board Member Adeyemi stated the appellant properly addressed the citation. He stated he would have preferred additional information regarding the dates he had been hospitalized and the tenant's eviction. He questioned what fees were being proposed to be waived.

City Clerk Simonsen explained that his understanding was when Mr. Lavinder filed the appeal; he was appealing the \$500.00 fee, \$50.00 late fee, and the \$200.00 re-inspection fee.

Board Member Rouse responded that he was in support of waiving \$750.00.

Chairperson Simpson stated she supported waiving the \$500.00 citation noting that the new items appeared to be attributed to the tenant being evicted and not the original citation.

Board Member Rouse proposed suspending deliberation to allow for additional witness testimony. Board Member Gonsalves seconded.

City Clerk Simonsen administered the Oath to Code Enforcement Manager Aguirre.

Code Enforcement Manager Aquirre clarified the amounts being discussed were \$500.00 for the administrative citation, \$200.00 re-inspection fee, and a \$50.00 late fee. He noted it was his understanding the Board could rescind the citation and not the re-inspection fee.

In response to Board Member Rouse, City Attorney Vigilia responded that the scope of administrative review included whether the amount of the proposed fine should be reduced or waived. He clarified the text of the code states the Board would "review the issuance of citations and the proposed imposition of administrative fines". He stated the Board could only adjudicate on the administrative citation fine and the late fee for that fine.

Board Member Rouse moved to reopen debate.

Board Member Rouse stated based on information provided by City Attorney Vigilia, it was his opinion that the Board should waive \$550.00.

Board Member Gonsalves agreed and recommended that staff look at the idea that if the Board was to waive a citation fee, there should also be some relief for the re-inspection fee.

Chairperson Simpson agreed with waiving the \$550.00 citation and late fee. She noted staff performed a re-inspection therefore she felt that fee should remain.

A motion made by Board Member Gonsalves to grant the appeal of the appellant with regards to the second citation waiving the \$500.00 citation fee and \$50.00 late fee for a total of \$550.00 debt relief. The motion was withdrawn for further discussion.

Board Member Rouse requested clarification that the motion was referencing Invoice #AR147641, items #212514046020 Admin Citation #25460 and #212514046020 Late Charge.

Board Member Gonsalves indicated that the above-mentioned items were what he was referring to in his motion. He noted it comes in terms of granting the appeal of the citation at the extent in which they had been advised, and in granting the appeal, find that the fine and the late fee were not due.

On motion by Board Member Gonsalves, seconded by Board Member Adeyemi, the Board of Administrative Appeals upheld citation #25447 for \$250.00 and dismissed citation #25460 in the amount of \$500.00 and the late charge in the amount of \$50.00. The motion carried the following vote:

REQUEST:

Appellent Avila requested a hearing to appeal a Vicious Animal Declaration issued on December 22nd, 2016, citing a violation of Antioch Municipal code § 6-1.80 (B) (b) which defines a Vicious Dog in part as: "A dog or animal which, when unprovoked, in an aggressive manner inflicts severe injury on or kills a person or a domestic animal."

On December 18th, 2016, the Antioch Police Department, Antioch Animal Services and EMT responded to a call for service regarding a dog that had attacked an adult male, Mario Oliva outside the residence of Mokelumne Drive, Antioch during a family reunion. By the time all service personnel arrived on scene, the attack was over and all dogs on the property were secured.

When Animal Control arrived on scene the victim was en route to the hospital and all parties were inside the residence of Mokelumne Drive. Antioch Police Officers were present and informed Animal Control of the situation. The dog owner was identified by family on scene as Jessica Anaya [Witness] and Ms. Anaya was asked by Animal Control to bring her dog out as it

was going to be impounded. Anaya initially refused to release the animal and the police officers had to detain her until the dog was secured inside the Animal Control vehicle. The dog, "White Boy" [A122670], was impounded by Animal Control and put on quarantine pending further investigation of the incident.

"White Boy" [A122670], is a male, 2 year old, neutered, white Pit Bull, microchip # 981020019549818. Anaya says that he is current on his rabies (no proof provided by Anaya). There are no animal related complaints on file at Antioch Animal Services or calls for service through the Antioch Police Department regarding "White Boy" or Jessica Anaya [Witness]. There is previous history with San Franciso Animal Care and Control for both "White Boy" and Jessica Anaya [Witness] with regards to prior dog attacks and a vicious animal case. [See Memos for Animal A386263]

Extent of Injuries;

Mario Oliva's [Victim DOB 12-20-57] injuries consist of a large laceration to the right ear, large laceration to the right forearm, a laceration to the right upper arm, chest abrasion and trauma. The victim had to be transferred from the Emergency of Sutter Delta Hospital in Antioch to John Muir Urgent Care in Walnut Creek due to the severity of his injuries. A plastic surgeon performed surgery on the arm and ear to repair. Mr. Oliva has still not been able to return to work as of January 25th, 2017 and may be out for two more weeks pending his doctor's recommendation.

INVESTIGATION:

On the afternoon of December 18th I was dispatched to a call for service deemed a "1091A" (Aggressive Animal) on Mokelumne Drive. The reporting party, Maybel, who was the daughter of Mario Oliva [Victim], said her Father had just been bitten by a dog and was en route to the hospital. She explained that no-one was outside except her Father, Mario Olivia [Victim] and that the dog owner, her cousin, Jessica got out there after the attack happened and pulled her dog off her Father/Jessica's Uncle. I asked her if the dog's records were on hand for the hospital's reference to ensure that the dog was up to date on his Rabies vaccination. The reporting party said that it was difficult to communicate with her cousin right at that moment. I told her I was en route.

I arrived on scene after the ambulance had left with the victim, Mario Oliva [Victim]. The responding police officers — Keo-Vann and Crites were at the location. Officer Keo-Vann described the extent of the injuries sustained by Oliva and pointed out the location of where the attack happened on the driveway in front of the garage at Mokelumne where there was blood on the concrete. I determined that the dog would have to be impounded due to the severity of the injuries described and how it appeared to be an unprovoked attack. We approached the home and knocked on the door. I asked for the dog owner to come out and Jessica Anaya [Witness] appeared. I informed her that her dog would have to go to Animal Services for Quarantine and further investigation following the incident. She insisted he had all his shots and that her records were in San Francisco and he didn't need to go. I told her that

due to the nature of the attack and no records we would be taking her dog. She refused to cooperate and Officer Keo-Vann detained her in his vehicle to allow access to the animal.

Ana Anaya, Jessica's Mother, came to the door and agreed to bring out the dog. She went inside and came out through the garage. I asked Ms. Anaya to confirm that this was the dog that attacked and she did. I walked the white, male, neutered Pit Bull with a black harness and camouflage leash to the truck and locked him inside. Ana Anaya followed and I explained to her that Animal Control would have to hold the dog for a quarantine and until further investigating was done. She nodded in acknowledgement. I told her that Jessica could bring the dog's records to the shelter on Tuesday, December 20th after 10am and we could discuss how things would proceed from there. Ana nodded in understanding. Officer Keo-Vann released Jessica Anaya [Witness] from being detained. Jessica continued talking emphatically about her "baby" and that we shouldn't be taking him as I tried to explain that the dog would be at Antioch Animal Services and that she could bring his records on December 20th, from 10am on. I asked her if I would be seeing her on Tuesday and she said "Yes".

Upon getting the dog to Animal Services I scanned "White Boy" for a microchip, which he had. Since it was a Sunday, the named organization on the microchip—"San Francisco Animal Care and Control" was closed and unavailable to provide the information linked to the microchip. "White Boy" was visibly agitated upon entering the shelter and due to there being no staff to assist I decided to not vaccinate "White Boy" on intake for my safety. [See Kennel Card attached]

Animal Services was closed on Monday, December 19th, 2016, but I left the microchip information for the dog with Officer Helgemo who was on duty that day. Officer Helgemo was able to make contact with San Francisco Animal Care and Control who provided extensive history on the dog named "White Boy" and said they have had incidents with "Jessica Anaya" in relation to numerous dogs including "White Boy". The listed owner of "White Boy" is Victor EK Avila who they said was incarcerated during the time of White Boy's impound. All history was related to previous dog attacks involving bites to humans. "White Boy" was impounded by San Francisco Animal Care and Control as recently as April 2016 where he was held pending a Vicious Animal hearing that Anaya appealed. SFACC were unable to get in touch with the male adult victim, who was a local transient, [See attached pictures provided by San Francisco Animal Care and Control] and Anaya claimed that they had impounded her wrong dog. "White Boy" was returned to her care in November 2016 with no declaration and a seizure notice was put in place for her other dog named, "Mister" who as of January 12th, 2017 remains a wanted animal that Anaya says is no longer in her care. [See attached Memos for #A386263 provided by San Francisco Animal Care and Control]

I attempted to contact the victim, Mario Oliva [Victim], on the morning of December 19th, 2016, but there was no response from his phone. I was able to contact his daughter, Maybel, and learned that his phone had been broken during the incident on December 18th, 2016. She said he had been discharged from the hospital on December 19th after two operations to correct extensive tendon and muscle damage to his arm and repair his ear.

rabies, that she has written permission to act as his guardian and that her Uncle's injuries were not serious as he had been discharged from the hospital, therefore she felt that we were holding her dog unfairly. Since she stated that she could not come to Animal Control the fax number was provided for Ms. Anaya to send proof of rabies and the letter of guardianship from Avila to Animal Control for our records. As of January 12th, 2017 such records have still not been provided by Ms. Anaya or Mr. Avila.

I was able to make contact with Mario Oliva [Victim] on December 23rd, 2016. He said his phone had been broken. I asked him to tell me from the beginning of his arrival at Mokelumne Drive, Antioch what happened prior to and during the attack;

Mario Oliva [Victim] said he got there early for the family reunion to set up the music equipment. His sister (Ana Anaya) told him that his niece's dogs were in the garage so he couldn't go through there with the equipment. He said that he was told the door was locked on the inside.

Mario Oliva [Victim] said he brought in the equipment and then went outside to smoke on the driveway. He had no idea that his niece was in the garage and suddenly the automatic door of the garage opened a little, then the door looked like it was trying to close, but before it closed two dogs came out and came after Mario. He said one jumped on him and he fell onto the driveway. Mario said only one dog jumped at him and only one dog attacked him. He said the attacking dog went for his face and he raised his arms to defend himself and the white dog continued to attack. He described the attacking dog as a white dog. He said the second dog was white and grey. He had never seen the dogs before, but he knew they belonged to his niece, Jessica Anaya [Guardian of White Boy].

On December 20th, 2016 Jessica Anaya [Witness] contacted Animal Control by telephone at 4.30pm to inform us that "White Boy" is up to date on vaccinations including his rabies, that she has written permission to act as his guardian and that her Uncle's injuries were not serious as he had been discharged from the hospital, therefore she felt that we were holding the dog unfairly. Since she stated that she could not come to Animal Control the fax number was provided for Ms. Anaya to send proof of rabies and the letter of guardianship from Avila to Animal Control for our records. As of January 25th, 2017 such records have still not been provided by Ms. Anaya or Mr. Avila.

[Copy of CA Driver's License attached], Jessica's mother and the brother of the victim, Mario Oliva [Victim] is the homeowner of Mokelumne Drive, where the incident occurred. came to Antioch Animal Services on December 21st, 2016 at 1.55pm. She asked that not be informed that she came to Animal Services, but that she wanted to make a statement. wanted to inform Animal Control that she would rather have "White **Boy"** put to sleep than to return to or leave the shelter as the dog scares her. She said Jessica has a second dog and that Jessica took it away from her home(Mokelumne) the day of the incident. She said the second dog is white and grey, but that she didn't know its name. I asked if it attacked her brother too, she said she didn't think so. I explained to that given the nature of the bite per the responding Officer's verbal statement and that of her niece that we would be pursuing a "Vicious Animal" declaration. I explained to her that if the dog resides at her home there would be stipulations that Victor EK Avila would have to meet in order to keep "White Boy" that would impact her residence. Said that Jessica doesn't live at her address and only comes to stay for a few weeks at a time. She asked again that Jessica not be informed that she came to Antioch Animal Services, but emphasized how she does not trust "White Boy" in public. I asked her if she would stand up in court to say the same if the case came to court and she declined.

I was able to make contact with **Mario Oliva** [Victim] on December 23rd, 2016. He said his phone had been broken. I asked him to tell me from the beginning of his arrival at Mokelumne Drive, Antioch what happened prior to and during the attack;

Mario Oliva [Victim] said he got there early for the family reunion to set up the music equipment. His sister (Ana Anaya) told him that his niece's dogs were in the garage so he couldn't go through there with the equipment. He said that he was told the door was locked on the inside.

Mario Oliva [Victim] said he brought in the equipment and then went outside to smoke on the driveway. He had no idea that his niece was in the garage and suddenly the automatic door of the garage opened a little, then the door looked like it was trying to close, but before it closed two dogs came out and came after Mario. He said one jumped on him and he fell onto the driveway. Mario said only one dog jumped at him and only one dog attacked him. He said the attacking dog went for his face and he raised his arms to defend himself and the white dog continued to attack. He described the attacking dog as a white dog. He said the second dog was white and grey. He had never seen the dogs before, but he knew they belonged to his niece, Jessica Anaya [Witness].

Mario described his injuries as a tear in his ear, where the dog bit first. He said it had to be stitched back together. He had a deep wound on his arm that required 3 hours of surgery and an urgent care nurse to come to his home and tend to dressing the wound daily following his discharge from the hospital. There was tendon damage and his doctor advised that he will be out of work for some time due to the damage. There may be a possible need for physical therapy and his doctor will be able to tell him if he will need that. Mario said he is scared of "that dog" (White Boy) and would not trust the dog in public. I asked what made the dog stop attacking and he said his niece, Jessica, had come outside and was pulling he and the dog apart and yelling at him. He mentioned how only seconds prior to the attack that there were kids in the driveway and his voice was shaking as he said how horrible it would have been if it had been one of them.

Mario agreed to testify if "White Boy's" case came to court. He said he feels strongly that this should never happen to anyone again and again stressed how he does not trust the dog at all. All evidence indicates that "White Boy" was not provoked.

VICIOUS ANIMAL DECLARATION:

I notified by registered mail on December 22nd, 2016, **Victor EK Avila** [Owner of "White Boy"], **Jessica Anaya** [Witness] and **Ana Anaya** [Homeowner at Mokelumne] at the address listed for Victor as Chanslor Ave B, Richmond and the address that the incident occurred. A letter was sent via registered mail to both addresses and one letter was delivered by hand to Mokelumne Drive. The letter informed the dog owner of the Declaration of "White Boy" [A122670] as a "Vicious Animal" as defined by Antioch Municipal Code Antioch Municipal Code § 6-1.80 (B) (b) which in part defines a Vicious Dog as; "A dog or animal which, when unprovoked, in an aggressive manner inflicts severe injury on or kills a person or a domestic animal." and the three options now available to the owner. Victor had until January 4th, 2017 at 4.30pm to appeal the determination.

Throughout the course of my investigation I did not find any evidence that the attack was provoked.

The term "Severe Injury" is defined in CA State Food and Agriculture Code § 31604 as "A physical injury to a human being that results in muscle tears or disfiguring lacerations or requires multiple sutures or corrective or cosmetic surgery."

The severity of the injuries is detailed by John Muir Urgent Care in the attached notes [John Muir Health; Notes] which describe extensive surgery performed by a cosmetic surgeon.

On January 4th, 2017 at 2.30pm **Victor EK Avila [Owner]**, **Jessica Anaya** [Witness] and a third person appeared at Antioch Animal Services, 300 L Street to discuss "White Boy". Jessica spoke on behalf of Victor regarding her feelings about declaring "White Boy" as a "Vicious Animal".

She felt that her dog was provoked by her Uncle and a wrongful decision made. She proceeded to City Hall to file an appeal.

RECOMMENDATION:

Based on the findings, due to the severity of the injuries inflicted, the viciousness of the attack by "White Boy" and the guardian's previous history of animals in her care, releasing this animal would create a significant threat to public health, safety and welfare if the animal is not humanely euthanized or designated as a "Vicious Animal" and the conditions of the permit followed to the fullest extent.

Therefore it is Staff recommendation to deny the appeal and uphold the Animal Declaration of December 22nd, 2016 for "White Boy" [A122670]

John Muir, with victim's verbal consent, sent details of Mario Oliva's injuries as follows;

Animal Bite

"This is a 58 year old male brought in by ambulance as a truama activation. The patient was reportedly attacked by 2 pit bulls with injury to his right arm as well as left forearm. The patient denies loss of consciousness. In the Emergency Room, the patient was continued on *ATLS protocols and close monitoring and paint management.

*ATLS - Advances Truamatic Life Support

This patient has been identified as having met ASST approved criteria for sustaining or being at high risk for a life/limb threatening trauma. Therefore ATLS protocol was initiated. This includes immediate evaluation and stabilization of the patient. It included placing two large bore IV's. Caridac Monitoring Pulse Oximetry Administration of supplemental oxygen. Administration of Parenteral Controlled substances as needed. This patient was treated with critical care for emergent/critical injuries. The surgeon personally coordinated the critical management of the patient including monitoring and managing their abnormalities in vital signs and/or cardiopulmonary monitors. The patient has new critical injuries from trauma that impairs one or more vital organ systems such that there is a high possibility of imminent or life threatening deterioriation in the patient's condition.

Mechanism of injury; Penetrating - dog bite to RUE and R ear Active Problems;
Dog bite
Laceration of right ear
Laceration of right arm
Laceration of right upper arm
Chest Abrasion
Trauma

The patient has a palpable right radial and ulnar pulse. However, he has significant soft tissue injury to the right upper arm and more son on the right forearm as well as a significant right ear laceration. The patient has been evaluated by Plastic Surgery (Dr Cremin) in the Emergency Room and will be taken to the operating room for irrigation, debridement and repair. The patient will also be admitted after this for ongong IV antibiotics and pain control.

Patient is to have close follow up. 12/18/16

12-18-16 Arrived to scene after ambulance left with victim. Owner named on scene was Jessica Anaya, she initially refused to hand over dog. She was detained by PD and her Mom handed over "Whtie Boy". Advised owner to come to AAS on 12/20/16 and bring proof of rabies.

12-20-16 No rabies proof provided. Listed owner on microchip is Victor Avila. Updated record.

Statement regarding Case 17-B17-000273, "White Boy"/Avila

On the afternoon of December 18th I was dispatched to a call for service deemed a "1091A" (Aggressive Animal) on Mokelumne Way. Dispatch gave me the phone number for the reporting party who was the daughter of Mario Oliva (Victim) who had just been bitten by a dog and was en route to the hospital. I called the reporting party to get an understanding of what went on. She explained that noone was outside except her father (victim) and that the dog owner, her cousin, Jessica got out there after the attack happened and pulled her dog off her Father/Jessica's Uncle. I asked her if the dog's records were on hand for the hospital's reference to ensure that the dog was up to date on his Rabies vaccination. The reporting party said that it was difficult to communicate with her cousin right at that moment. I told her I was en route.

I arrived on scene after the ambulance had left with the victim, Mario Oliva. The responding police officers — Keo-Vann and Cites were at the location. Officer Keo-Vann described the extent of the injuries sustained by Oliva and pointed out the location of where the attack happened on the driveway in front of the garage at Mokelumne where there was a small amount of blood on the concrete. I determined that the dog would have to be impounded due to the severity of the injuries and how it appeared to be an unprovoked attack. We approached the home and knocked on the door. I asked for the dog owner to come out and Jessica Anaya appeared. I informed her that her dog would have to go to Animal Services for Quarantine and further investigation following the incident. She insisted he had all his shots and that her records were in San Francisco. I told her that due to the nature of the attack and no records we would be taking her dog. She refused to cooperate and Officer Keo-Vann detained her in his vehicle to allow access to the animal. (Police Case: 16013495, Event: 16126837)

Ana Anaya, Jessica's Mother, came to the door and agreed to bring out the dog. She went inside and came out through the garage. I asked Ms. Anaya to confirm that this was the dog that attacked and she did. I walked the white, male, neutered Pit Bull with a black harness and camouflage leash to the truck and locked him inside. Ana Anaya followed and I explained to her that we would have to at the least hold the dog for a quarantine and/or until further investigating was done. She nodded in acknowledgement. I told her that Jessica could bring the dog's records to the shelter on Tuesday, December 20th after 10am and we could discuss how things would proceed from there. Ana nodded in understanding. Officer Keo-Vann released Jessica Anaya from being detained. Jessica continued talking emphatically about her "baby" as I tried to explain that the dog would be at Antioch Animal Services and that she could bring his records on December 20th, from 10am on. I asked her if I would be seeing her on Tuesday and she said "Yes".

Upon getting the dog to Animal Services I scanned him for a microchip, which he had. Since it was a Sunday San Francisco Animal Care and Control were unavailable to provide the information linked to the microchip.

Animal Services was closed on Monday, December 19th, 2016, but I left the microchip information for the dog with Supervisor Helgemo who was on duty that day. The named owner on the microchip was discovered to be Victor EK Avila who could not be contacted. San Francisco Animal Care and Control then provided an extensive history on Mr. Avila, Ms. Anaya and "White Boy".





NARRATIVE

On 09/29/2016 at approximately 0728 hours, Officer Gonzales #4272 and I were dispatched to the area of 19th Street and Treat Avenue for a report of a fight. Dispatch broadcasted that the reporting party advised that a male and female subject were yelling near a homeless encampment on 19th Street between Treat Avenue and Folsom Street.

Upon arrival, Officer Gonzales and I activated our (BWC1) Body Worn Cameras. 3D16A, Officer Gassen #59 and Officer Ramirez #893 also responded and activated their Body Worn Cameras.

In the area of 19th Street and Folsom Street, in front of San Francisco Fire Station 7, I observed a male subject, identified as (R/V1) Jacob Arrieta, laying down on the ground. Arrieta was being tended to by SFFD Medics who stated that he had suffered injuries from multiple dog bites.

Medic #71 responded to the scene to assess Arrieta's injuries. I accompanied Arrieta inside the ambulance and conducted an interview. I observed that Arrieta had multiple cuts and abrasions on his left arm, his back, and his left hip area.

Arrieta was in pain and difficult to communicate with. I obtained the following details from his statements, in summary.

Arrieta stated that he was walking westbound on 19th Street towards Folsom Street on the north sidewalk. Arrieta stated that as he passed a group of tents, he was attacked by two large Pitbull dogs. Arrieta stated that there was a black colored Pitbull and a White colored Pitbull. Arrieta stated that he did not know who the dogs belonged and was not familiar with any of the residents living in the homeless encampment.

I took photos of Arrieta's injuries. I issued Arrieta a follow-up form with assigned case number, a victim of crimes form, and a Marsy's card. Medic #71 transported Arrieta to Kaiser Hospital in South San Francisco where he was treated by Doctor Addour.

Officer Gonzales, Officer Gassen, Officer Ramirez, and I searched the area near the aforementioned homeless encampment for the dogs who were responsible for Arrieta's injuries. Sadler #20 and Pone #13 of Animal Care and Control also responded to the scene. A white Pitbull, (S1) "White Boy," was located inside a large brown tent. The white Pitbull belonged to (D1) Jessica Anaya. The Pitbull was seized by the ACC officers and secured in a crate. There was an additional stray dark colored Pitbull, (S2) Unknown, which was also seized by the ACC officers and secured in a crate.

It was inconclusive to whether these two Pitbulls were responsible for Arrieta's injuries, therefore no citations were issued on scene. There did not appear to be blood or other physical evidence on the mouth of either Pitbull.

I took photos of both Pitbulls. I issued Anaya a (E2) Certificate of Release (849b) Form.

No other dogs matching Arrieta's description were located in the area. ACC took custody of the Pitbulls.

I identified a potential surveillance camera mounted at 600 Treat Avenue that may have captured this incident.

Officer Gonzales transferred all above listed photos to a (E1) Compact Disc and attached copies to this report.

Officer Gonzales completed a (E3) Animal Bite Report Form.

Officer Gonzales booked the CD, a copy of the 849b form, and the Animal Bite Form into evidence at Mission Station.

I faxed a copy of this report to ACC and Sergeant Hicks #2227 of the Vicious and Dangerous Dog Unit.

Your dog, "White Boy" has been found to be in violation of Antioch Municipal Code § 6-1.801 (B)(2) *Vicious Animal* based on an incident that occurred on December 18th, 2016.

(B)(2) a dog or animal which, when unprovoked, in an aggressive manner inflicts severe injury on or kills a person or a domestic animal

Accordingly, Antioch Animal Services, a division of the Antioch Police Department, has determined that there exists probable cause that your dog is a "*Vicious Animal*" under Article 8 of Chapter 1 of Title 6 of the Antioch Municipal Code and Article 2 of Chapter 9 of the California Food and Agricultural Code.

You have three mutually-exclusive options now that your dog has been declared a "Vicious Animal," which are described in more detail on the following pages:

- 1. By **4:30 p.m. on January 4th, 2017**, surrender the dog to Antioch Animal Services; **or**
- 2. By **4:30 p.m. on January 4th, 2017** sign the "*Vicious Animal Declaration: Terms and Conditions Agreement,*" pay the outstanding fees, and comply with all of the terms and conditions in order for the dog to be returned to you. A copy of this agreement has been enclosed; <u>or</u>

3. By 4:30 p.m. on January 4th, 2017, file all papers and pay fees to appeal the determination that your dog is a vicious animal. The dog will remain at Animal Services until the Board of Administrative Appeals renders its decision.

Option 1 -- Surrender your dog

To surrender your dog to be humanely euthanized, please come to Antioch Animal Services and pay the applicable fees and sign the appropriate paperwork.

If you take no actions by **4:30 p.m. on January 4th**, **2017**, then your dog will be deemed to have been surrendered and will be euthanized. You will be billed for any applicable outstanding fees and costs.

Option 2 -- Sign the Vicious Animal Declaration; Comply with the Terms and Conditions; and Pay Fees

In order to obtain your dog, you may sign the Vicious Animal Declaration, comply with the Terms and Conditions, and pay the fees. The Terms and Conditions are enclosed. Once you come to Animal Control Services to sign the Declaration and Terms and Conditions, an appointment will be made to inspect your home to ensure that you have complied with the Terms and Conditions before your dog is released.

To date the fees for your dog are \$852.00 and board increases by \$25.00 per day starting on December 28th, 2016:



Dear: Victor Ek Avila

Your dog, "White Boy" has been found to be in violation of Antioch Municipal Code § 6-1.801 (B)(2) *Vicious Animal* based on an incident that occurred on December 18th, 2016.

(B) (2) a dog or animal which, when unprovoked, in an aggressive manner inflicts severe injury on or kills a person or a domestic animal

Accordingly, Antioch Animal Services, a division of the Antioch Police Department, has determined that there exists probable cause that your dog is a "Vicious Animal" under Article 8 of Chapter 1 of Title 6 of the Antioch Municipal Code and Article 2 of Chapter 9 of the California Food and Agricultural Code.

You have three mutually-exclusive options now that your dog has been declared a "Vicious Animal," which are described in more detail on the following pages:

- By 4:30 p.m. on January 4th, 2017, surrender the dog to Antioch Animal Services; or
- 2. By 4:30 p.m. on January 4th, 2017 sign the "Vicious Animal Declaration: Terms and Conditions Agreement," pay the outstanding fees, and comply with all of the terms and conditions in order for the dog to be returned to you. A copy of this agreement has been enclosed; or

3. By 4:30 p.m. on January 4th, 2017, file all papers and pay fees to appeal the determination that your dog is a vicious animal. The dog will remain at Animal Services until the Board of Administrative Appeals renders its decision.

Option 1 -- Surrender your dog

To surrender your dog to be humanely euthanized, please come to Antioch Animal Services and pay the applicable fees and sign the appropriate paperwork.

If you take no actions by 4:30 p.m. on January 4th, 2017, then your dog will be deemed to have been surrendered and will be euthanized. You will be billed for any applicable outstanding fees and costs.

Option 2 — Sign the Vicious Animal Declaration; Comply with the Terms and Conditions; and Pay Fees

In order to obtain your dog, you may sign the Vicious Animal Declaration, comply with the Terms and Conditions, and pay the fees. The Terms and Conditions are enclosed. Once you come to Animal Control Services to sign the Declaration and Terms and Conditions, an appointment will be made to inspect your home to ensure that you have complied with the Terms and Conditions before your dog is released.

To date the fees for your dog are \$852.00 and board increases by \$25.00 per day starting on December 28th, 2016:





SEIZURE ORDER

Dear Sgt. Sadler,

On Thursday, October 29, 2015, a dog bite incident occurred involving at least 4 dogs described as pit bulls in an unprovoked attack against a Human and his small dog. All dogs were 'packing' up in a manner consistent with the definition of the SF Health as vicious and dangerous. (As defined by Article 1, Section 42(a) of the San Francisco Health Code) The attack resulted in injuries to both the Victim's dog and the Victim's hand. The bite to the Victim did puncture the skin resulting in a bleeding wound.

Due to the Registered Owner, Ms. Jessica Anaya, being unable to properly and safely contain her dogs by allowing the dogs to 'escape' from the van she utilizes as a dog living quarters, they were off leash and able to attack the Victim and his dog.

SF ACO's were able to secure and seize 3 dogs at the scene; however, a fourth dog known as "Mister" A#374312 a N male (White) was not at the scene and Ms. Anaya told the responding Police Officer that she didn't know where he was. This dog was a part of the "attacking pack" and to protect public safety I order that dog "Mister" be **SEIZED** immediately by the Department of Animal Care and Control and held pending a Vicious and Dangerous Dog Hearing along with the other dog's seized today.

I believe that this order, once executed, will protect the health, safety and welfare of the community.
