Chairperson Busenbarrick called the meeting to order at 3:12 P.M. on Thursday, November 1, 2012, in the Council Chambers.

PLEDGE OF ALLEGIANCE

Chairperson Busenbarrick led the board, staff and public in the Pledge of Allegiance.

1. CONSENT CALENDAR

A. APPROVAL OF ADMINISTRATIVE APPEALS MINUTES FOR AUGUST 2, 2012

On motion by Board Member Schleder, seconded by Board Member Simpson, the Board of Administrative Appeal members unanimously approved the Minutes of August 2, 2012.

City Attorney Nerland explained the manner in which the proceedings would be conducted and reviewed the options available for the Appeals Board.

In response to Board Member Jennings, City Attorney Nerland clarified the appellant was given notice of this meeting and the City had not received any messages indicating she would not be able to attend. She noted the appeal can go forward in the absence of the appellant.

2. APPEALS

A. Appeal to reverse "Potentially Dangerous Animals" decision for three (3) dogs "Bubba" (A507033), "Roxy" (A102104), and "Chevelle" (A102105) for Jacqueline Wight, 2317 Redwood Drive, Antioch [§6-1.22 (A)(b)]

Animal Control Officer Johnson presented the staff report dated October 23, 2012 recommending the Board of Administrative Appeals uphold the Potentially Dangerous Animal declaration for all three dogs.

In response to Chairperson Busenbarrick, Animal Control Officer Johnson stated she was informed that the appellant had problems obtaining insurance for the dogs, building a kennel, and getting an appointment to have them neutered and spayed. Therefore the appeal would provide extra time to comply with the conditions.

APPELLANT

Chairperson Busenbarrick confirmed that Ms. Wight was not in attendance and staff had not been notified in advance of any issue with the date or her attendance at this meeting.

OPPONENTS

Ms. Reyes elected to have assistance from City Approved Interpreter Christina Garcia.

Estella Reyes reported she was in her home when she heard her husband yell from the garage and when she went outside, she saw her neighbor's dogs attacking her husband. She stated a man and woman removed the dogs and the man put the dogs in a vehicle and left the scene. She noted her husband was unable to get up due to the dog bites so she called 911 for an ambulance. She further noted it was a traumatic experience and following this incident, they were afraid to live in the neighborhood, so they had moved.

In response to Board Member Schleder, Ms. Reyes stated all three dogs had attacked her husband. She confirmed that they had never been a dog owner.

Crystal Reyes stated she was in her room when her mom asked her to come outside. She noted when she went outside, she witnessed a male neighbor putting the dogs inside his vehicle and she photographed the license plate with her phone. She further noted one of the female neighbors stated she was sorry and they left, and did not return for (2) two days. She stated when they did return, they would give them angry looks.

City Attorney Nerland indicated, for the record, that it is 3:35 P.M. and the dog owners had not shown up for the appeal.

Chairperson Busenbarrick closed the public comment portion of the meeting.

Board Member Simpson stated the information provided indicated the dogs attacked another human or animal, unprovoked, on more than one occasion.

In response to Board Member Schleder, Animal Service Supervisor Helgemo explained the hospital report indicated the victim received three stitches to his ankle and the other wounds were punctures, which did not require stitches.

Board Member Jennings stated that based upon the testimony and his experience, he would deem the dogs potentially dangerous and if conditions were not met, the dogs needed to be euthanized.

City Attorney Nerland reported the appellant would be notified of the decision, given a short time to comply with the conditions, and if she failed to do so, the dogs would be euthanized, assuming she did not appeal the decision to the Superior Court.

On motion by Board Member Simpson, seconded by Board Member Jennings, the Board of Administrative Appeals unanimously denied the appeal and upheld the decision of "Bubba, Roxy, and Chevelle" as Potentially Dangerous Animals and upheld the stipulations required to redeem the dogs. Included in the specific findings were the following:

- Finding that there had been a prior incident with the dog attacking another dog in the neighborhood on January 14, 2012.
- The dogs were unprovoked and caused severe injury as defined.
- If the appellant failed to comply with the conditions, then the dogs would be euthanized.

He calls animal control services and then goes to he's yard to assure my dogs continue to bark, so the officer responding can confirm the barking. I went around the entire street I live on as well as Almondridge Drive because that's where the complaints have come from. I collected 23 plus signatures stating my dogs are not a nuisance to our neighborhood. I find myself in a difficult position to pay these fines, while having other expenses in life to pay. This has been going on for a year an a half. We were told the individual complaining felt animal services was not doing there job and spoke to there lieutenant in charge. About a week later of being told that that's when the citations started. I all so want to state I purchased 2 anti bark collars last year, I have all so purchased a outside anti bark device for my back yard this year and my dogs and birds are put in at night and are not let out until 10am or so sense the neighbors complaint started in the January 2012.

Violation of Antioch Municipal Code § 6-1.18 - *Excessive Barking Dog*

REQUEST:

Appellate Alejandro Lopez requests a hearing to appeal the decision of Administrative Citation Number 30251 issued on February 16, 2013 citing Violation of the Antioch Municipal Code:

§6-1.18 BARKING OR HOWLING DOGS: *No person shall allow any dog which he owns, keeps, harbors, or controls within the City to bark or howl with such frequency, or in such manner, as to disturb the peace of the immediate neighborhood.*

BACKGROUND INFORMATION:

Responsible Dog Owner:

Alejandro Lopez – 2905 Cashew Street, Antioch CA, 94509

- January 11, 2012: Antioch Animal Services responds to a call for service regarding excessive barking dogs (**See attached Event #12-003304**). Reporting party complains that there are two dogs on the property that bark all day and night. Contact was unable to be made with Dog Owner at that time. A Notice to Correct was left for No Dog Licenses (x 2 dogs) and No Proof of Rabies (x 2 dogs). Dog Owners were advised about barking complaints on Notice to Correct.
- May 1, 2012: Antioch Animal Services responds to a call for service regarding two barking dogs as well as loud birds (**See attached Event #12-039262**). A Notice to Correct is left by ACO Johnson (**See attached citation #26-C131109**). ACO Johnson was able to make contact with Animal Owner Alejandro Lopez and advised him of the noise complaints.

Citation # 30251 – LOPEZ

- October 2, 2012: Antioch Animal Services responds to a call for service regarding barking dogs and loud birds (**See attached Event #12-092995**). No barking dogs were heard.
- November 11, 2012: Antioch Police Department responds to a call for service regarding loud birds (**See attached Event #12-106371**). APD Officer Kidd closes the call and notes that he was unable to make contact with residents at 2905 Cashew Street but did hear a loud bird in backyard.
- December 3, 2012: Antioch Police Department responds to a call for service regarding loud bird (**See attached Event #12-113281**). APD Officer Kidd closes the call and notes he heard a bird in the backyard of residence. Officer Kidd also notes he was able to make contact with residents at 2905 Cashew Street.
- December 9, 2012: Antioch Police Department responds to a call for service regarding a loud bird and barking dogs from 2905 Cashew Street (**See attached Event #12-115217**). APD Officer Chang closes the call and is unable to hear barking dogs or bird noise from the residence.
- February 16, 2013; 4:56PM: Antioch Animal Services responds to a call for service regarding an ongoing animal noise complaint (**See attached Event # 13-014487**). ACO Johnson closes the call and is unable to hear excessive animal noises.
- February 16, 2013; 10:07PM: *Antioch Animal Services responds to a call for service regarding barking dogs (**See attached Event #13-014563**). The Neighborhood was quiet for the first 15 minutes while I was on scene, but then both dogs started barking from the backyard of 2905 Cashew Street and continued for the next 20 minutes (mostly large dog barking). I was unable to make contact with the Dog Owners at the time of the call due to the residents not being home. I left Administrative Citation No. 30251 in the amount of \$100.00 for Violation of Antioch Municipal Code §6-1.18: Excessive Barking and advised the owner on the citation that I was able to confirm excessive barking at the time of the call for service (**See attached Administrative Citation # 30251**).*

RECOMMENDATION:

At the time of this writing, additional calls for service were requested. Due to the excessive and unabated barking, it is Staff's recommendation to uphold the Administrative Citation No. 30251 for the Violations of Antioch Municipal Code § 6-1.18 Excessive Barking on February 16, 2013.

2. May 01, 2012- February 16, 2013: Antioch Police Department and Antioch Animal Services receives and responds to multiple calls for service regarding barking dogs and excessive animal noise. Some calls for service are closed with validation of noise and some are closed without validation of noise. Dog Owners are advised on several occasions about excessive barking.
 3. On February 16, 2013: Antioch Animal Services responds to a call for service regarding barking dogs. Animal Control Officer Gomez is able to confirm excessive barking from residence for at least twenty minutes. An Administrative Citation was issued for Violation of Antioch Municipal Code § 6-1.18. Dog Owners were not home at time of call and were unavailable for contact.
 4. The City has the ability to issue an Administrative Citation pursuant to Antioch Municipal Code §6-1.18 No person shall allow any dog he owns, keeps, harbors, or controls within the City to bark or howl with such frequency, or in such a manner, as to disturb the peace of the immediate neighborhood.

11 Based on a preponderance of evidence, the Board finds that there was probable cause for the City to issue an
12 Administrative Citation and the appeal is denied.

Appellate Alejandro Lopez requests a hearing to appeal the decision of the second Administrative Citation (No. 30254) issued on March 7, 2013 citing Violation of the Antioch Municipal Code:

§6-1.18 BARKING OR HOWLING DOGS: *No person shall allow any dog which he owns, keeps, harbors, or controls within the City to bark or howl with such frequency, or in such manner, as to disturb the peace of the immediate neighborhood.*

- February 21, 2013; 2:29PM: Antioch Animal Services responds to a call for service regarding barking dogs (**See attached Event #13-015879**). ACO Johnson closes the call and is unable to hear excessive barking from the residence.
- February 21, 2013; 7:18PM: Antioch Animal Services response to a call for service regarding barking dogs (**See attached Event #13-016044**). ACO Johnson closes the call and notes that she was able to hear dogs barking on and off but nothing

excessive. She also notes Dog Owners were not home at time of call so she was unable to make contact but left her business card for contact.

- February 21, 2013; 10:32 PM: Antioch Police Department responds to a call for service regarding barking dogs (**See attached Event #13-016091**). APD Officer Gonzalez closes the call and notes he was unable to hear excessive barking from the residence.

I was able to confirm that both dogs on the property barked excessively from 6:40PM until my departing time of 7:00PM. The Dog Owners were not home at the time of the call and I was unable to make contact. I left a second Administrative Citation No. 30254 in the amount of \$200.00 for Violation of Antioch Municipal Code §6-1.18 Excessive Barking and advised on the citation that I was able to confirm excessive barking at the time of call for service (**See attached Administrative Citation No. 30254**).

RECOMMENDATION:

At the time of this writing, additional calls for service were requested and Officer Johnson responded and issued a third Administrative Citation for Excessive Barking (Event #13-023112). Due to the excessive and unabated barking, it is Staff's recommendation to uphold the Administrative Citation No. 30254 (*second citation issued*) for the Violations of Antioch Municipal Code § 6-1.18 Excessive Barking on March 07, 2013.

- 15 1. Administrative Citation for violation of Antioch Municipal Code: § 6-1.18. At all relevant times
16 Appellant was the sole owner of both dogs and/or the responsible party.
17 2. Appellant appealed the Administrative Citation for Antioch Municipal Code § 6-1.18, which is
18 the only item at issue for today's hearing.
19 3. An Administrative Appeals Board Hearing regarding the Appellant's appeal of the

26 Licensing, No Proof of Rabies Vaccination and Excessive Barking.
27 2. May 01, 2012- February 16, 2013: Antioch Police Department and Antioch Animal Services
receives and responds to multiple calls for service regarding barking dogs and excessive animal
28 noise. Some calls for service are closed with validation of noise and some are closed without
validation of noise. Dog Owners are advised on several occasions about excessive barking.

- 1 3. On February 16, 2013, Antioch Animal Services responds to a call for service regarding barking
2 dogs. Animal Control Officer Gomez is able to confirm excessive barking from residence for at
3 least twenty minutes. An Administrative Citation was issued for Violation of Antioch Municipal
4 Code § 6-1.18. Dog Owners were not home at time of call and were unavailable for contact.
- 5 4. February 21, 2013 and February 22, 2013: Additional calls for service regarding barking dogs are

12 Owners were not home at time of call and were unavailable for contact.
- 13 6. The City has the ability to issue an Administrative Citation pursuant to Antioch Municipal Code
14 §6-1.18 No person shall allow any dog he owns, keeps, harbors, or controls within the City to
15 bark or howl with such frequency, or in such a manner, as to disturb the peace of the immediate
16 neighborhood.

17 Based on a preponderance of evidence, the Board finds that there was probable cause for the City to issue an
18 Administrative Citation and the appeal is denied.
