PLEDGE OF ALLEGIANCE

Vice Chairperson Simpson led the board, staff, and public in the Pledge of Allegiance.

City Attorney Nerland gave introductory comments.

1. CONSENT CALENDAR

On motion by Board Member Rouse, seconded by Board Member Schleder, the Board of Administrative Appeals unanimously confirmed each assessment and the amount thereof, as proposed or as corrected and modified, and order it assessed against the property. The Board also directed that the same be recorded with the Contra Costa County Recorder's Office and thereafter the assessment shall constitute a special assessment and lien against the property.

2. APPEAL

City Attorney Nerland explained the manner in which the proceedings would be conducted and reviewed the options available for the Appeals Board. She noted two items had been entered into the record; an item from the City Clerk's office with clearer copies of staff report photos and a statement with photos from Sheryl Cox.

City Clerk Simonsen administered the Oath for all persons present intending to testify on the appeal.

A. ANIMAL ID# A114619 "Lucky" (dog) – Appeal filed by Eleuterio Olveda, 2401 Silveria Way, Antioch, CA 94531 to overturn the "Potentially Dangerous Animal" [§6-1.801(B)(3)] determination made by Antioch Animal Services

Animal Control Officer Gomez presented the staff report dated March 5, 2015 recommending the Board of Administrative Appeals deny the appeal and uphold the Potentially Dangerous Animal Declaration of January 13, 2015.

Eleuterio Olveda explained his dog was chasing a ball when it encountered the victim dog at the edge of his driveway. He noted at that time, the victim dog snapped at his dog and the victim dog owner, kicked him and hit his girlfriend. He stated his dog had never shown signs of aggression; however, that action caused his dog to react in a defensive manner. He commented that the victim dog owner had not informed them that her dog had been bitten until two hours after the encounter.

In response to Board Member Rouse, Mr. Olveda clarified that he was not home when the incident occurred.

Breann Lewis stated it was not in the responsible dog's character to be dangerous and she believed he reacted as a result of being provoked.

In response to the Board, Ms. Lewis explained the incident occurred where the driveway meets sidewalk and she was at the end of the driveway when it took place. She commented that her dog was protective; however, he was not aggressive. She

noted they did not want him deemed as a potentially dangerous dog and further noted he had been licensed since the event took place.

Ms. Olveda (Eleuterio Olveda's mother), stated she had raised the responsible dog until he was approximately eight (8) months old and he had never shown signs of aggression. She requested the Board uphold the appeal.

Sheryl Cox reported her family and her dog, on leash, were walking to the park. As they approached the address of the incident, the responsible dog, unleashed, came out of the opened garage door and got on top of her dog. Ms. Cox stated there was no ball that the responsible dog was chasing. She further clarified her dog never snapped at the responsible dog and she never made contact with the dog or the dog's owner while she was attempting to separate them. She noted it wasn't until they were at the park that she discovered her dog was bleeding from his neck and back as her dog has long hair. She further noted when she returned to the residence an hour later to inform the responsible dog owner of the wounds, dog owner Breann Lewis used profanities and never acknowledged or apologized for the incident.

In response to the Board, Ms. Cox stated the dog's owner was in the garage area when the incident began. She noted her dog never snapped, growled, or barked at the responsible dog.

REBUTTAL

Eleuterio Olveda stated due to a recent death in his family, his dog's license and vaccinations had lapsed. He reported a delay in the appeal process by staff caused him to incur additional fees for boarding his dog at the shelter.

In response to the Board, he stated the reason given for the delay in the appeal process was that staff did not have sufficient time to submit a report to the Board. He expressed concern that he was unable to review the staff report until March 4, 2015 and he was denied access to his dog at the shelter. He confirmed his dog was off leash and stated he assumed the information in the report was correct; however, he believed the incident was a defensive action by his dog to protect his property and family.

REBUTTAL

Animal Control Officer Gomez stated she had never been informed the victim dog had acted in an aggressive manner and clarified the responsible dog was not currently licensed in the City of Antioch. She noted the dog could have been returned to the owner if the stipulations of the PDA declaration had been met.

For the record, City Attorney Nerland stated there was a letter, attached to the staff report, dated January 13, 2015, from the City to the appellant, outlining costs.

Animal Services Supervisor Helgemo stated all fees incurred would have to be paid for when the animal was picked up. She noted the appellant stated he did not have an issue with the PDA declaration; however, he wanted to appeal the stipulation requiring his dog be neutered. She noted that she informed the appellant he could not appeal the stipulations.

Vice Chairperson Simpson closed the floor to public comment.

Following discussion, City Attorney Nerland reviewed the options available for the Appeals Board.

A motion by Board Member Rouse to impose all fines and stipulations with the exception of neutering was withdrawn for further discussion.

Following discussion, Vice Chairperson Simpson reopened the floor to public comment.

Animal Services Supervisor Helgemo explained the stipulation to neuter was to avoid passing on aggressive genes to potential offspring and noted an intact male had a higher tendency to be involved in biting/attacking another animal or person. She further noted stipulations were in the municipal code and applied to any potentially dangerous or vicious animal.

Vice Chairperson Simpson closed the floor to public comment.

On motion by Board Member Rouse, seconded by Board Member Adeyemi, the Board of Administrative Appeals denied the appeal and upheld the Potentially Dangerous Animal Declaration of January 13, 2015. The motion carried the following vote:

FISCAL IMPACT

BACKGROUND INFORMATION

I am writing to appeal accumulated violation re-inspection fees in reference to the above property. I am renting the property to David Zanca and his family. They have agreed to keep the property clean, to include exterior, in accordance to rental agreement since 2013. I have not received any complaints from the city regarding substandard property until now.

On 3/20/2015, tenant David Zanca delivered my mail that included these notices, dating back to January 1, 2015, regarding the violation and imposed fees as a result of non-compliance. To my surprise, I realized that the city has conducted several re-inspections of this issue without my knowledge and therefore unnecessarily penalized.

I have been in contact with the tenants and they have agreed to pay the citation for the violation, if possible without the unnecessary penalties incurred since we did not have knowledge of the notices were mailed in unmarked in discreet City of Antioch envelopes. I have received City of Antioch notices regarding the water bill mailed in an envelope labeled in identical fashion. I am a responsible person, and so are these tenants who have never delayed their monthly rent since 2013. If we have known (City of Antioch envelope marked "code enforcement"), a swift action would've resolved this matter when it first occurred, there would not be a request to appeal today. The violation would've been acknowledged and resolved promptly.

We are looking to appeal this matter.

I am requesting a reconsideration of the assessment amounts, "Re-Inspection Fee", the "Admin Citations Fees" and the "Late Charges". Also, the total amounts shown for the 3 citations (#23877, #23884, & #23326) will and is causing me a financial hardship. There was unclean\misinformation, and misunderstanding regarding the citation and billing amounts. I am also requesting to be able to make partial payments. I previously paid \$345.00 on 3/2/15, and inclosing \$400.00 today 3/26/15.

My attention was not to violate the first citation's request. I had a difficult time moving the 4 cars in the time allowed. I made several attempts to call the contact number on the citation to explain and request more time in-between the inspections but was unable to make contact. However, I was able to make contact after the 3rd citation and R. Souza did allowed two additional days to the citation on the 3rd citation.

I called for ^{Towed} ~~to~~; however the cars could not be ^{Towed} ~~told~~ because of any registrations. A couple of the cars belonged to my husband (separated since 2007). Had to locate him to either move the cars or obtain paper work to have the cars move. After obtaining the paper work, checked with Motor vehicle and the fees was more than I could afford. I called the Wrecking Yards to give them the cars. One yard kept changing the time and date of pick-up, and still never came.

The **Re-Inspections Fees** are shown on the bill for all three citations instead of just the last two citation inspections. I previously paid \$345 which included the re-inspection charged on the first citation. I am questioning and asking for reconsideration of that \$125 re-inspection fee, and the amounts of the additional late charges, \$40.00, \$100.00 and \$345.00. I was told when I came in to pay the \$345.00 in February that there will be no more late charges.

I had a misunderstanding about the debris mentioned in the citation. On the first citation's photo, that I received right after the wind and rain storm I saw a lot of leaves on the yard and driveway. I thought that was what the citation was referring to. I cleaned the leaves up before the second citation. The second citation came with the wrong house photos, which my driveway with the box was not shown. I tried and was unable to contact R. Souza to let her know that the picture was not our house until after the 3rd citation. She just stated it was. I tried to explain that we had got the leaves up and that they were there because of the rain storm, I pay for weekly yard service if it is raining they do not come out. It was not until after I contacted and talked with someone else in, and he explained that the box was also considered as debris. After I spoke to someone else again in about mid Feb 2015, who also stated I was sent the correct picture. I received the correct picture of my driveway stamped dated 01/07/15 that showed the box with a statement of the three citations. Note: The citation was written on 01/06/15.

I was diligently trying to get rid of the cars. I was previously staying in Richmond because of health and work for over a year. The citation came in an envelope like the water bill. I pay the water bill over the internet, so my daughter did not open the envelope. During that time my (separated) Husband put the cars on the driveway. When I came back at Christmas, I open the first violation. I cannot reach out to my husband for help to pay because his monthly income is less than \$600, and he is living on his own.

I am not making excuses for the incident. I am asking for reconsideration and a lesser amount charged based on the above and your graces. Please see the attached photo and citation information. Thank you for considering this request. Verna L. Pickett

I am requesting a reconsideration of the assessment amounts, "Re-Inspection Fee", the "Admin Citations Fees" and the "Late Charges". Also, the total amounts shown for the 3 citations (#23877, #23884, & #23326) will and is causing me a financial hardship. There was unclean\misinformation, and misunderstanding regarding the citation and billing amounts. I am also requesting to be able to make partial payments. I previously paid \$345.00 on 3/2/15, and inclosing \$400.00 today 3/26/15.

My attention was not to violate the first citation's request. I had a difficult time moving the 4 cars in the time allowed. I made several attempts to call the contact number on the citation to explain and request more time in-between the inspections but was unable to make contact. However, I was able to make contact after the 3rd citation and R. Souza did allowed two additional days to the citation on the 3rd citation.

I called for ^{Tow} ~~tell~~; however the cars could not be ^{Towed} ~~telled~~ because of any registrations. A couple of the cars belonged to my husband (separated since 2007). Had to locate him to either move the cars or obtain paper work to have the cars move. After obtaining the paper work, checked with Motor vehicle and the fees was more than I could afford. I called the Wrecking Yards to give them the cars. One yard kept changing the time and date of pick-up, and still never came.

The **Re-Inspections Fees** are shown on the bill for all three citations instead of just the last two citation inspections. I previously paid \$345 which included the re-inspection charged on the first citation. I am questioning and asking for reconsideration of that \$125 re-inspection fee, and the amounts of the additional late charges, \$40.00, \$100.00 and \$345.00. I was told when I came in to pay the \$345.00 in February that there will be no more late charges.

I had a misunderstanding about the debris mentioned in the citation. On the first citation's photo, that I received right after the wind and rain storm I saw a lot of leaves on the yard and driveway. I thought that was what the citation was referring to. I cleaned the leaves up before the second citation. The second citation came with the wrong house photos, which my driveway with the box was not shown. I tried and was unable to contact R. Souza to let her know that the picture was not our house until after the 3rd citation. She just stated it was. I tried to explain that we had got the leaves up and that they were there because of the rain storm, I pay for weekly yard service if it is raining they do not come out. It was not until after I contacted and talked with someone else in, and he explained that the box was also considered as debris. After I spoke to someone else again in about mid Feb 2015, who also stated I was sent the correct picture. I received the correct picture of my driveway stamped dated 01/07/15 that showed the box with a statement of the three citations. Note: The citation was written on 01/06/15.

I was diligently trying to get rid of the cars. I was previously staying in Richmond because of health and work for over a year. The citation came in an envelope like the water bill. I pay the water bill over the internet, so my daughter did not open the envelope. During that time my (separated) Husband put the cars on the driveway. When I came back at Christmas, I open the first violation. I cannot reach out to my husband for help to pay because his monthly income is less than \$600, and he is living on his own.

I am not making excuses for the incident. I am asking for reconsideration and a lesser amount charged based on the above and your graces. Please see the attached photo and citation information. Thank you for considering this request. Verna L. Pickett

Mr. Thomas Trost requests a hearing to appeal Notice of Violation Case No. CD1502-052 issued on February 24, 2015, citing violation of the **Antioch Municipal Code Sections:**

§5-1.202(A)(1) - Property inadequately maintained - The keeping, storage, depositing or accumulation on the premises of any personal property, including, but not limited to, abandoned, wrecked, dismantled, discarded or inoperable equipment, appliances, furniture, containers, packing materials, scrap metal, wood, building materials, junk, solid waste, rubbish, trash and debris, dirt, sand, gravel, concrete or similar materials that is visible from the public right-of-way and:

1. poses a risk of harm to the public; or
2. constitutes visual blight or reduces the aesthetic appearance of the neighborhood; or
3. is offensive to the senses; or
4. is detrimental to the use and enjoyment of nearby properties; or
5. reduces nearby property values due to the visibility from the public right-of-way.

§5-1.202(D)- It is declared a public nuisance to have outdoor parking or storage of any inoperable, wrecked, dismantled, salvaged, abandoned vehicle, or parts thereof, including watercraft so that is within the view from the public right-of-way. Any vehicle that is not currently registered with the California Department of Motor Vehicles to operate legally on a public street is deemed inoperable for purposes of this section.

§ 9-5.3830 RECREATIONAL VEHICLES.

It shall be unlawful for any person to keep or maintain or to permit to be placed, kept, or main-tained any recreational vehicle as a temporary or permanent residence upon any lot, piece, or parcel of land within the city other than within an established recreational vehicle park.

BACKGROUND INFORMATION:

On 2-18-2015, I received a complaint regarding junk and rubbish, unregistered vehicles, people living in recreational vehicles, people going in and out of the property at all hours and loud noises regarding this location.

On 2-20-2015, A site inspection at the property was conducted with APD Officer Summers, Deputy Director of Community Development Ryan Graham, and Code Enforcement Officer Aguirre. When we arrived, the property owner Mr. Thomas Trost met us on the public street in front of the property. We explained the reasons why we were there. We asked permission to inspect the property and take photos of possible violations. Mr. Trost gave us permission. We walked around the property with him and pointed out the violations. He was then advised that a Notice of Violation would be posted and mailed to him. Photos were taken. (See Attachment "A")

On 2-24-2015, A case was opened under Code Enforcement case #CD1502-052. A Notice of Violation letter was mailed by first class mail to Fruitful Farms LLC PO BOX 584 Bethel Island Ca 94511-0584 who shows with the County Assessor's records to be the property owner. A copy of the Notice of Violation was also posted on the gate located on the property. (See Attachment "B")

On 03-04-2015, The City of Antioch received a letter from Mr. Trost advising his desire to appeal Case CD1502-052. (See Attachment "C")

On 03-13-2014, Mr. Trost submitted a City of Antioch Decision Appeal Application. (See Attachment "D")

- 24 3. On February 24, 2015 a Notice of Violation letter was mailed to Fruitful Farms LLC PO BOX
25 584 Bethel Island Ca 94511-0584 who shows with the County Assessor's records to be the
26 property owner. A copy of the Notice of Violation was also posted on the gate located on the
27 property.
- 28 4. On March 4, 2015, The City of Antioch received a letter from Mr. Trost advising his desire to
appeal Case CD1502-052
5. On March 13, 2015, Mr. Trost submitted a City of Antioch Decision Appeal Application.

6. The Board finds that the reasons given by Appellant for these ongoing violations are not credible and are not mitigations for his unlawful conduct.

Based on a preponderance of evidence, the Board finds that there was probable cause to issue the Notice of Violation and the appeal is denied. The Appeal deposit amount will not be refunded.

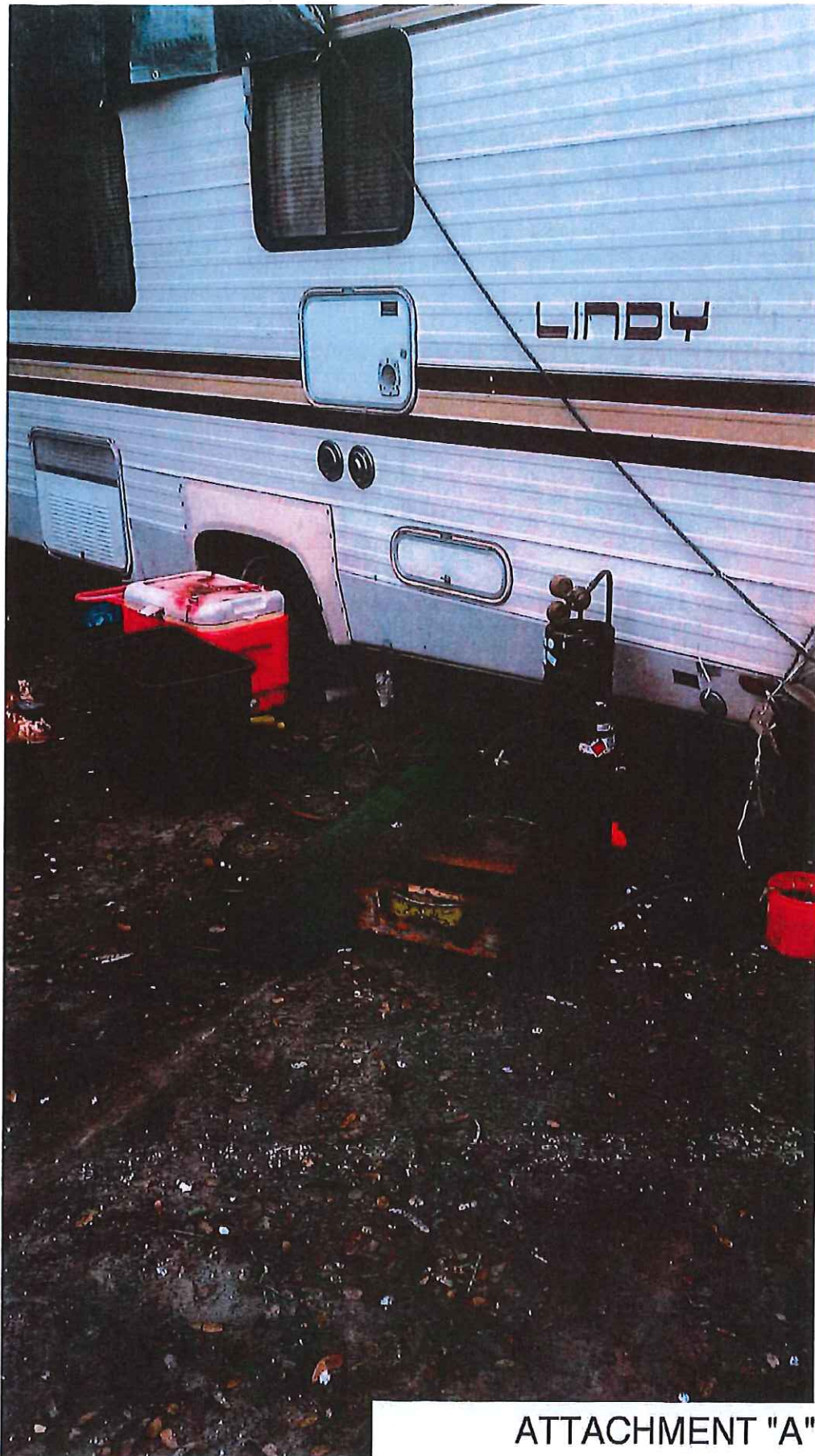

I'm writing to appeal the public nuisance claim from the city of Antioch, Ca filed 2/20/2015 case #C21502-052 for parcel 066032-024 owned by Fruitful Farms LLC at present time.

I have owned this property since February of 1999. The property was sold at auction as a tax recovery sale for redevelopment project that failed because of contamination in soil. I have spent a lot of time and thousands of dollars trying to meet state and city requirements of environmental issues connected to this property.

The physical description of property is 9 1/2 acres on waterfront in Antioch, CA located at 5th & B St. and 6th & A St.

I have cooperated with the city throughout the last 15 years by cleaning up garbage disposed of by the homeless and attempting to keep the homeless off the property required by the state of California. I have allowed the city of Antioch to enter my property to repair the main trunk line of the city's sewer system that had collapsed, which lead to the installation of a new trunk line along with a new easement. I have not been paid for the new easement or the use of my property while this was being done. It took a year and a half to complete. Other property owners that have allowed the city to install sewer lines on their properties were paid \$15,000.00 per month. This would have allowed me a \$270,000.00 compensation for the easement and rent.

A contractor hired by the city to put in the new sewer line, drilled through my property and an existing 18" water well that supplied water to the old cannery and old downtown Antioch. This created a problem with the State of California because the well was not properly sealed. As of now the properties water supply has been destroyed which decreases the value of my property having no water without the dependency of the cities water.

Months back I talked to Code Enforcer Ryan Graham about why the Contra Costa Sheriff Marine Patrol was patrolling my property and Ryan's response was "He didn't know why, but stated they could go anywhere they want". A couple of weeks went by and I contacted Denise Skaggs (former code enforcer) as to why the CoCo County Sheriffs Marine Patrol was patrolling around my property and arresting homeless people. This procedure went on for 3 months consisting of 2 Contra Costa County Patrol Cars in the am and 2 more for the pm shift and homeless people were arrested.

After talking to a city employee whom I will not divulge the name told me to clean my property at 6th and A St. I informed him that the property located at 6th and A St belonged to the City of Antioch. The next day the city code enforcer Brian Graham and a crew with heavy equipment cut the lock on my gate and crossed my property without permission to gain access to their property for clean up. In doing so a state surveyor corner marker was destroyed by equipment, the cost of the survey paid for by the State of California was \$3,500.00 in

which needs to be resurveyed and marked. The crew left garbage from the job on my property for me to clean up.

I have been trying to remedy state and city violations against the property for the past 15 years and will continue doing so. I am a one man crew working diligently to meet all that is expected of me and I feel that the city is working against me and trying to take my property.

I am asking the city for a permit to have a small yard to store equipment used to maintain the property and a self contained motor home used by myself to watch and maintain the property.
