
#### BACKGROUND INFORMATION

#### **REQUEST:**

Beverly Robrielle, owner of subject property, requests an Abatement Cost Hearing to appeal the Summary Abatement Costs incurred by the City of Antioch on February 14, 2015 in the amount of \$752.84

§5-1.314 (A)If, ...there exists any condition on any premises within the city which is of such a nature as to be immediately dangerous to the public health, safety or welfare, or that constitutes an immediate threat of injury to any person or damage to property which, if not abated, would, during the pendency of the abatement procedures set forth in this chapter, subject the public or property to potential injury or harm of a serious nature, the condition may be abated by the city immediately without compliance with the provision of this code.

§5-1.314(C) The owner of the property that was the subject of the summary abatement shall be served with written notice, within two business days following the summary abatement action, of the right to request a postdeprivation hearing before the Board of Administrative Appeals

§5-1.314(D) The cost of the summary abatement, including all administrative costs of any action taken hereunder and reasonable attorney's fees, may be assessed against the subject premises as a special assessment lien or made a personal obligation of the owner as provided in this code

#### **BACKGROUND INFORMATION:**

On <u>02-16-15</u>, I received a faxed Invoice in the amount of \$502.84 from K2GC a Licensed Contractor. The Invoice provided information that the contractor had performed an emergency board up at subject property on February 14, 2015. I researched Parcel Quest for property ownership information. A copy of the K2GC Invoice is included as **Attachment "A"**.

On <u>02-17-15</u>, I prepared and mailed a Demand for Abatement Costs & Summary Abatement Costs Invoice in the amount of \$752.84 representing Contractor Invoice of \$502.84 plus administrative fees and costs to subject property owner A copy of the Demand letter and Invoice are hereto attached as **Attachment "B"**.

On <u>03-02-15</u>, I received a faxed request from Beverly Robrielle requesting an Abatement Cost Hearing.

A copy of the faxed request is hereto attached as Attachment "C".

On <u>03-10-15</u>, I recorded a Notice of Special Assessment under the authority of California Government Code Section 38773.5 and Antioch Municipal Code, Title 5, Chapter 5 to protect the City's interest in this matter.

A copy of the recorded lien is attached hereto as Attachment "D".

Violation of Antioch Municipal Code §5-1.202 (D)

#### **REQUEST:**

Ms. Jaskolski requests a hearing to appeal Administrative Citation 23791 issued on February 27, 2015, citing violation of the **Antioch Municipal Code Sections**:

**§5-1.202(D)-** Parking and storage of vehicles and equipment. (1) Any outdoor parking or storage of any inoperable, wrecked, dismantled, salvaged, abandoned vehicle, or parts thereof, including watercraft so that it is within the view from the public right-of-way

**§4-16.03-** Except as otherwise provided in this chapter, no person shall be authorized to perform major repairs in public view in a residential district unless: (A) Such person is the lawful resident of the property where the major repair is being performed; (B) In a fully-enclosed garage, or building, or behind a six foot high fence and gate capable of screening the boat or vehicle and parts thereof from public view; and (C) The door of such garage or building or the fence gate is closed when repairs are not in progress.

#### **BACKGROUND INFORMATION:**

On <u>01-21-2015</u>, Administrative staff received a complaint for **Example** Redrock Dr. regarding major automotive repair and inoperable vehicles.

On <u>01-22-2015</u>, I conducted a site inspection at Redrock Dr. and confirmed that there was an inoperable vehicle, CA license number 7FET681, parked on the driveway. I observed the vehicle on wood blocks and jack stands with a dismantled front and rear end. Photos were taken of the conditions (**See Attachment "A"**). A Notice of Violation was issued and given to Ms. Jaskolski at the time of the inspection for the inoperable vehicle and the major automotive repair. It was explained to Ms. Jaskolski how to remedy the violations.

On <u>01-23-2015</u>, A Notice of Violation was mailed by first class mail to Ms. Jaskolski who is shown on County Assessor's records to be the property owner. The Notice of Violation was issued for AMC §5-1.202(D) and AMC §4-16.03. It included the direction to cease all major automotive repairs in a residential area as well as to remove the inoperable vehicle from public view. (See Attachment "B")

<u>On 02-06-2015</u>, I conducted a follow up inspection. At the time of my inspection I saw that the vehicle, CA license number 7FET681, had been removed from the wood blocks and jack stands. I also noted that the front end was complete and all of the automotive tools had been removed from public view. Photos were taken (**See Attachment "C"**). The case was closed.

On <u>02-24-2015</u>, Administrative staff received a complaint for **EXER** Redrock Dr. regarding major automotive repair and inoperable vehicles.

On <u>02-27-2015</u>, I conducted an inspection at **Conduct** Redrock Dr. and saw an inoperable vehicle, CA license number 6WKW170, parked on the driveway in public view. The vehicle was on a jack and jack stand with the rear tires blocked. The front passenger side tire was missing as well as the rotor (**See Attachment** "**D**"). I prepared Administrative Citation 23791 in the amount of \$100.00 for violating AMC §5-1.202(D) Parking and storage of vehicles and equipment. (1) Any outdoor parking or storage of any inoperable, wrecked, dismantled, salvaged, abandoned vehicle, or parts thereof, including watercraft so that it is within the view from the public right-of-way. A re-inspection fee of \$125.00 was also issued.

On <u>03-02-2015</u>, Citation 23791 and notice of the re-inspection fee (**See Attachment "E"**) was mailed to Property Owner Jaskolski Thomas L & Janice L at Redrock Dr. Antioch, CA 94509.

On <u>03-06-2015</u>, I received a phone call from Ms. Jaskolski. Ms. Jaskolski wanted to inform me that her son was changing a flat tire on the vehicle that I cited as an inoperable vehicle. I advised Ms. Jaskolski that I observed more than a tire being replaced on the vehicle. Ms. Jaskolski stated that she had just remembered that her son was also changing a wheel bearing on the vehicle. I asked Ms. Jaskolski if the vehicle was operable at the time of my inspection and when the citation was issued. Ms. Jaskolski stated that the vehicle was not operable at that time.

On <u>03-06-2015</u>, Lieutenant LaDue, emailed Ryan Graham forwarding complaints received regarding major automotive repair taking place at **Example** Redrock Dr.

On <u>03-19-2015</u>, I conducted a follow up inspection at Redrock Dr. At the time of my inspection I saw that the inoperable vehicle, CA license number 6WKW170, had been removed. A new vehicle was observed on the driveway

with a dismantled front end and interior, however, appeared to be operable. Photos were taken (See Attachment "F") and the case was closed.

On <u>03-19-2015</u>, Administrative staff received a voicemail stating complaints of major automotive repair at Redrock Dr.

On <u>03-20-2015</u>, Deputy Director of Community Development, Ryan Graham, conducted a site inspection at Redrock Dr. and observed major automotive repair taking place.

#### RECOMMENDATION

Recommendation to uphold the Administrative Citation 23791 issued to Janice Jaskolski for violation of the Antioch Municipal Code §5-1.202(D).




