Chairperson Simpson led the board, staff and public in the Pledge of Allegiance.

#### 1. CONSENT CALENDAR

#### A. APPROVAL OF ADMINISTRATIVE APPEALS MINUTES FOR APRIL 5, 2018

On motion by Board Member Adeyemi, seconded by Board Member Faraji, the Board of Administrative Appeals unanimously approved the Minutes for April 5, 2018.

#### B. APPROVAL OF THE LEVY OF SPECIAL ASSESSMENTS ON CERTAIN PROPERTIES FOR UNPAID ADMINISTRATIVE CITATIONS & ABATEMENTS FOR THE MONTH OF MARCH 2018

On motion by Board Member Adeyemi, seconded by Board Member Faraji, the Board of Administrative Appeals unanimously confirmed each assessment and the amount thereof, as proposed or as corrected and modified, and order it assessed against the property. The Board also directed that the same be recorded with the Contra Costa County Recorder's Office.

Interim City Attorney Bamshad explained the manner in which the proceedings would be conducted.

### OATH

Minutes Clerk Eiden administered the Oath for all persons present intending to testify.

#### A. CITATION NO. 26401 – APPEAL OF ADMINISTRATIVE CITATION ISSUED REGARDING <u>"PROPERTY INADEQUATELY MAINTAINED - INOPERABLE EQUIPMENT" [§5-1.202(A)(1)(a)]</u> TO SYLVIA MCDOWELL, 3216 ASHLEY WAY, ANTIOCH, CA.

Code Enforcement Manager Michael presented the staff report dated May 3, 2018 recommending the Board of Administrative Appeals uphold Citation No. 26401 in the amount of \$300.00, including a \$200.00 re-inspection fee.

Sylvia McDowell, Appellant, reported that no one had come to her door to inform her of the violations on her property and noted the citation was mailed to her. She clarified that all the vehicles in her driveway were operational and engine parts in her driveway were blocked from public view by vehicles. She reported her son had a serious accident and was laid up in bed for the week prior to March 26, 2018, so there would be no reason for anyone to call Code Enforcement regarding auto repairs occurring in her driveway. She stated it was her belief that a neighbor was using Code Enforcement to cause herself and her family hardship. She noted the property was well maintained and she could not afford \$300.00 as she was on Social Security. She submitted her receipt for her son's pain relief medication and a copy of her comments to the Board.

Sandy Williams stated that every time she had visited the property it was cleaned up, not a nuisance and not used to conduct major auto repairs. She noted that she believed this was a neighbor issue.

Maurice McDowell supported his mother Sylvia McDowell and asked for the City's definition of major auto repair. He stated he was told by Code Enforcement that if the car in the driveway was not registered to the house, it was major auto repair. He noted he tried hard to follow the City's code.

In response to Board Member Faraji, Code Enforcement Manager Michael clarified that a photo in the staff report depicting a transmission on the ground between two vehicles, was as it would be seen from the public right of way. He noted there was also a close up of the same photo which was provided. He explained that the citation was issued for § 5-1-202(A)(1)(a) of the municipal code which was for inoperable equipment stored in public view. He reported that during the initial inspection an engine lift and vehicle parts were on the property and three people were working on a vehicle in the driveway. He noted the officer made contact with a resident named "Chris" and advised him that he could not do any automotive repairs or store equipment in public view. He further noted a notice of violation was issued on February 6, 2018 for major automotive repairs and equipment stored, in public view. He stated several inspections occurred in about a four week period and due to the nature of the complaint, the case remained active even though reinspections found that there was no evidence of automotive repair or debris. He noted when the final inspection occurred at the end of March, a

citation was issued for the transmission being in public view. He commented that citations were issued in-house and sent out to the property owners with photographs of the violation. He noted the corrective action on the citation said to remove engine parts from public view and all other signs of auto repair. He further noted a citation was issued for \$100.00 and there was a \$200.00 reinspection fee. He clarified if the property was in compliance with all municipal codes, no citations would be issued.

In response to Board Member Adeyemi, Code Enforcement Manager Michael reiterated that citations were sent via U.S. Mail and notices of violations were hand delivered. He noted they provided a 10-day courtesy notice prior to any citations being issued.

Board Member Livingston stated it was clear that there were auto parts in public view.

On motion by Board Member Livingston, seconded by Board Member Adeyemi, the Board of Administrative Appeals unanimously upheld the citation and denied the appeal.

#### B. CITATION NO. 5176 – APPEAL OF ADMINISTRATIVE CITATION ISSUED REGARDING <u>"THIRD CITATION – BUSINESS LICENSE REQUIRED" AMC §3-1.103</u> TO BARJINDRE TOOR, 1709 SPRINGWOOD WAY, ANTIOCH, CA.

Director of Finance Merchant presented the staff report dated April 24, 2018 recommending the Board of Administrative Appeals uphold the \$500.00 Administrative Citation No. 5176 issued on April 17, 2018 for violation of the Antioch Municipal Code Business License Required and Residential Landlord Business License Tax (Measure O).

Barjindre Toor, Appellant and property owner, reported he had been making consistent payments for his Business License as approved by the Finance Department. He noted he made his initial payment on December 20, 2017 and received a citation on December 22, 2017. He further noted that even though he had made monthly payments, he received citations adding to the total balance due. Subsequently, he reached out to the Finance Department and was told the citations were issued because the payments were not received. He noted his January payment was not received by the department and the check had not cleared the bank. He reported he had made several calls and sent emails to the Finance Department; however, he had not received a response. He noted he kept receiving bills and citations even though he made payments. He commented that he came into the City Clerk's office and explained the matter and was advised to appeal the citation. He noted the \$100.00 citation was issued two days after his first payment and the \$200.00 was received in March. He clarified that he sent payments to the City which were not received and he had carbon copies of those checks. He stated after that, he issued two checks to a third party and those checks were received. He noted payments were sent every month and requested that due to an economic hardship, the Board waive the \$500.00 citation.

In response to Board Member Faraji, Mr. Toor reiterated that after his first payment on December 20, 2017, he received a citation on December 22, 2017 and the balance remaining was \$683.00. He noted the three subsequent payments were not received by the Finance Department. He further noted he followed up with the Finance Department to inquire as to why

the payments had not cleared; however, he did not receive a response to his phone calls or emails. He noted he received a second citation in the amount of \$200.00 and a third citation in the amount of \$500.00. He noted after speaking with the City Clerk, he paid the total balance due and filed the appeal. He further noted he had a carbon copy of the checks he sent to the City.

In response to Chairperson Simpson, Mr. Toor confirmed that he received the first citation after he had made his first payment to the City. He explained that the missing checks were not returned back to him and they had not cleared his account. He noted he went to his bank to request a stop payment and he provided the Board with the stop payment paperwork. Additionally, he reported that his tenant had moved out in December and the property was vacant for two months and during that time the property was vandalized.

Chairperson Simpson stated the stop payment request was for a check in the amount of \$500.00 written on April 23, 2018 and it had not indicated that he had stopped payment on all of the previous checks the appellant indicted were sent to the City.

Mr. Toor responded that the bank had not provided documentation for the previous checks because he had cancelled them by phone. He again reiterated that he had made payments and they were not received by the City, which had resulted in the citations being issued.

In response to Board Member Livingston, Mr. Toor stated he had a third party managing the property and when he received the first email from the City, he became aware of the Business License requirement.

Anupama Sharma stated she managed the property as of September 17, 2017 and the first time she received any documentation was in December because the letters had been sent to Mr. Toor's address and he had been out of town for three years. She commented that she had notified Mr. Toor in December who emailed the City to inquire as to why he needed a business license. She further noted a check was issued in December after an agreement was reached with the City's business license representative that they would accept payments for the amount due. She reported the initial payment cleared on Dec 20, 2017; however, they received a citation on December 22, 2017. She reported a second check was issued for which she had a copy; however, the City had never received it. She further noted on April 5, 2018, they received a \$200.00 citation and she notified Mr. Toor who indicated he had sent the check. She stated they then called the Business License Department and informed them that they had made the payment to which they responded if the City did not receive payment, a \$500.00 and \$1000.00 citations would be issued. She noted Mr. Toor followed up with an email stated he would make the payments. She commented that she had a copy of the check issued for \$500.00 on April 9, 2018, which was not cashed from the City. She stated she made several calls to the Business License Department, which was finally returned on April 23. 2018 and she was told she had to pay the \$200.00 citation because the time to appeal it, had passed. She noted on April 23, 2018, she found out her check had not been cashed and she went to the bank to stop payment. She clarified after they made first payment, the City issued a citation, they received the second citation on the date it was due and she was attempting to contact the Business License Department who was not responding. She noted she was told

they could not make a payment on a credit card so they stated they would send a check and they sent a \$900.00 check on April 9, 2018.

Ms. Sharma presented the Board with her emails to the City.

In response to Board Member Adeyemi, Mr. Toor stated he did not recall receiving any letters from MuniServices. He verified his primary address was and noted the first time he became aware of the business license requirement was when he received the balance due.

In response to Board Member Faraji, Mr. Toor reported he had been on medication for three years and had not checked his mail or emails regularly. He noted Ms. Sharma was handling the matter for him.

Board Member Faraji stated it was the property owner's responsibility to manage their properties and pay their fees.

Mr. Toor stated this matter had not been handled professionally and when attempting to contact the Finance Department, his calls and emails were not responded to. He noted he understood his responsibilities and this issue should never occur again.

Chairperson Simpson stated mail should be read and responded to and it seemed as though the City agreed to accept payments. She noted the first payment was received; however, citations were issued when those payments lapsed. She noted it was incumbent upon the property owner to find out where his checks went. She expressed concern that no stop payment documentation had been provided for the checks written to the City except for one check written for \$500.00.

Mr. Toor stated the bank had not provided him with any documentation.

Chairperson Simpson responded that if the appellant had stopped payment on the checks, the banks would provide documentation.

Mr. Toor explained that he had provided proof that he had stopped payment on the \$500.00 check and questioned why he received citations when he made consistent payments.

Chairperson Simpson reiterated that the City had not received any payments after December. She stated if checks had been sent in the same way as the first payment, they would have been received, cashed and noted on the account. She noted there was a lack of evidence showing that the other checks were written and explained that the appellant had received the \$500.00 citation because he had not made the payments as promised.

Board Member Faraji stated that the appellant agreed to pay the fees that accumulated. She noted business owners needed to be responsible and further noted if the tenant had not paid rent, they would have been evicted. She suggested reducing the citation amount because she sympathized with the appellant.

A motion by Board member Faraji, seconded by Board Member Adeyemi, to waive \$250.00 in citations reducing the citation from \$500.00 to \$250.00 failed by the following vote:

Board Member Adeyemi stated that a payment was not made until it was received.

On motion by Board Member Adeyemi, seconded by Board Member Livingston, the Board of Administrative Appeals denied the appeal and upheld the citation. The motion carried the following vote:

#### **REQUEST:**

Eric Depper requests to appeal the citation fee issued by the City of Antioch on 4/24/2018 in the amount of \$500. Eric Depper failed to comply with the Measure O ordinance after several attempts by MuniServices DBA Avenu and the City of Antioch were made.

#### **BACKGROUND INFORMATION:**

Measure O background information can be found in its entirety on the City of Antioch website at <a href="http://www.ci.antioch.ca.us/CityGov/Finance/BusLic.htm">http://www.ci.antioch.ca.us/CityGov/Finance/BusLic.htm</a> as Attachments A-F. The Council Meeting held on June 24, 2014, adopted Resolution No. 2014/61 to present to Voters a Measure to update the existing Business License Tax Ordinance to include a Residential Landlord Business License Tax (<u>Attachment A</u>). In September 2014, the "Frequently Asked Questions" document (<u>Attachment B</u>), was included and mailed out with water bills. The Contra Costa County Elections Division mailed the November 4, 2014 General Election Sample Ballot and Voter Informational Pamphlet (<u>Attachment C</u>) to all Registered Voters in the City of Antioch. The pamphlet contained the Local Measure Submitted to the Voters for the City of Antioch "Measure O – Business License Tax". This included the Full Text, Impartial Analysis, Argument For, and Argument Against the Measure. Also included in the November 4, 2014 General Election Sample Ballot and Voter Informational Pamphlet Election Sample Ballot and Voter Information for, and Argument Against the Measure. Also included in the November 4, 2014 General Election Sample Ballot and Voter Informational Pamphlet Election Sample Ballot and Voter Information For, and Argument Against the Measure. Also included in the November 4, 2014 General Election Sample Ballot and Voter Informational Pamphlet were the Candidates running for Antioch City Council.

#### November 4, 2014 General Election

The City Council adopted Resolution No. 2014/97 at the December 9, 2014, Council Meeting confirming canvass by the County Clerk of Contra Costa of ballots cast at the November 4, 2014 General Municipal Election. Measure O – Residential Landlord

2A.WEB 6/7/2018 Business License Tax was approved by the Voters and Ordinance No. 2094-C-S was adopted by Council (<u>Attachment D</u>).

#### MuniServices Contract approved by City Council

At the February 24, 2015 Council Meeting, City Council approved the contract with MuniServices after issuing a Request for Proposal (Attachment E-F) to help identify business owners in the City of Antioch.

Their primary functions are to identify owners of both commercial and residential businesses, collect the revenue, and submit the applications with payment to the City of Antioch at which time the Business License Representative enters them in to the City of Antioch's Business License System and collects any money through renewals going forward.

#### <u>Regarding Antioch Municipal Code:</u>

#### **↓**§ 3-1.103 LICENSE REQUIRED.

(A) Except as provided in § <u>3-1.120</u>, it shall be unlawful for any person to commence, conduct or purport to commence or conduct, either directly or indirectly, any business activity in the city without having an unrevoked license under this chapter so to do, valid and in effect at the time, and without paying the required taxes and fees therefore and complying with any and all regulations of such business provided in this chapter, unless such person is exempt under this chapter. Licensees shall promptly inform the city of any change in operation, ownership, location and/or name of licensed businesses. No person who is an employee, or who is the direct representative of a licensee, shall be required to pay a license tax for doing any part of the work of such licensee.

(B) No person may advertise or announce a business activity in the city until he or she has obtained a business license, and where required by this Code, a permit. Advertising or announcement includes, but is not limited to, disseminating pamphlets or handbills, publishing newspaper announcements, electronic advertisement on the internet or otherwise, and purchasing radio and television spots.

(Ord. 2082-C-S, passed 3-25-14)

#### § 3-1.217 RESIDENTIAL LANDLORD.

(A) In lieu of any other business license tax and subject to division (B) below, all those in the business of renting living quarters, including but not limited to a rental dwelling unit as defined in § 5-20.201 of the Antioch Municipal Code, shall pay the annual license amount indicated in the table immediately below based on the total number of units they are renting or have available for rent within the city and the type of unit as defined in the Municipal Code:

Type of Unit	Annual Tax
Single family dwelling unit	\$250 per unit
Multi-family dwelling unit including duplexes, condominiums and apartments	\$150 per unit

(B) The following living quarters are excepted from this requirement to pay a business license tax based on dwelling units but still must pay the tax based on gross receipts:

(1) Those that fit within the definition of hospital, hotel, motel, and convalescent and extended care facility and residential care facility as defined in § <u>9-5.203</u> of the Antioch Municipal Code;

(2) Those that are exempt as a matter of law; and

(3) Those that the Director of Financial Services reasonably determines to be substantially similar in nature to one of the excepted living quarters listed above.

(C) The Director of Financial Services may promulgate policies and procedures to administer this tax. (Ord. 2094-C-S, passed 12-9-14)

RENTAL DWELLING UNIT AS DEFINED IN OUR MUNICIPAL CODE:

"Any building or portion of a building in the city that contains living facilities, including provisions for sleeping, eating, cooking, and sanitation, which is hired, rented or leased by a person within the meaning of Cal. Civ. Code § 1940. A "rental dwelling unit" includes a single family dwelling, either attached or detached, or a unit in a multifamily or multipurpose dwelling, or a unit in a condominium or cooperative housing project, or any room or group of rooms located within a dwelling and forming a single unit with facilities that are used or intended to be used for living, sleeping, cooking or eating. The definition of "rental dwelling unit" applies to any dwelling space that is actually used or available for residential purposes whether or not the residential use is legally permitted."

#### DISCUSSION

Eric Depper received the following notifications for the rental property located at SYCAMORE DR, APT requesting compliance with Measure O:

 12/29/2015 MuniServices sent 1<sup>st</sup> letter along with a declaration of information and business license application to the county records address on file at this time. (<u>Attachment G</u>).

- 2/3/2016 MuniServices sent 2<sup>nd</sup> letter along with a declaration of information and business license application to the county records address on file at this time. (<u>Attachment H</u>).
- 3/15/2016 MuniServices sent 3<sup>rd</sup> letter along with a declaration of information and business license application to the county records address on file at this time. (<u>Attachment I</u>).
- 8/25/2017 MuniServices sent a follow up notice of violation to the county records address on file at this time. (Attachment J).

All letters mailed by MuniServices included an application with instructions to complete and return.

Per Antioch Municipal Code:

**₽§ 3-1.203 PENALTIES.** 

(A) Unless otherwise specified by the terms of a particular license, taxes are due and payable within 30 days following expiration date of the license.

(B) Any business license tax not paid when it becomes due and payable shall be delinquent and the following penalties added to it as follows:

(1) Ten percent of the business license tax for a delinquency after 30 days from the expiration date;

(2) Thirty percent of the business license tax for a delinquency of 60 days from the expiration date plus a new application fee as provided in § 3-1.120; and

(3) Fifty percent of license tax for a delinquency of 90 days from the expiration date plus a new application fee as provided in § 3-1.120.

(C) Failure to pay the business license tax is a violation of the Antioch Municipal Code and a public nuisance. The city may seek any remedies available to it for such violation and public nuisance.

(D) Any business operating in violation of the Antioch Municipal Code or as a nuisance is subject to water service disconnection, subject to noticing requirements under the law.

(Ord. 2082-C-S, passed 3-25-14)

Per State statute of limitation:

Section 6501(a) of the Internal Revenue Code (Tax Code) and section 301.6501(a)-1(a) of the Income Tax Regulations (Tax Regulations), the IRS is required to assess tax within 3 years after the tax return was filed with the IRS. Similarly, under 301.6501(a)-1(b) of the Tax Regulations no proceeding in court by the IRS without assessment for the collection of any tax can begin after the expiration of 3 years. The final letter sent from MUNI Services on 8/25/2017 contained the following statement (fifth and sixth paragraphs) notifying that if compliance was not made, Eric Depper could be subject to citation from the City:

Required correction: Within 15 calendar days from the date of this notice, you must contact MuniServices, LLC by phone at 1-800-987-0999 or in person at 200 H Street, Antioch, CA and obtain a business license for the above property or file an appeal with the office of the City Clerk.

I hope you take this one-time opportunity to voluntarily abate the above violation(s) and public nuisance without the need for the City to issue Administrative Citations, which carry fines that range from \$100 to \$1,000 for every day the violation(s) are permitted to remain and/or take other action to compel your compliance.

The following actions were taken by the City when Eric Depper continued to fail to comply with the Measure O ordinance for **SYCAMORE DR**, APT ;

- <u>11/21/2017</u> No application or payment was received from Eric Depper through MuniServices or the City of Antioch. Invoice No. 2786 for \$483 was issued from the Business License system for business license taxes and fees due per Ordinance. The invoice was due 12/1/2017. (<u>Attachment K</u>).
- <u>2/5/2018</u> No application or payment was received from Eric Depper through MuniServices or the City of Antioch. A \$100 Administrative Citation No. 4233 was issued for non compliance with Measure O with a due date of 2/15/2018 (<u>Attachment L</u>).
- <u>3/20/2018</u> Invoice AR152744 for \$483 and invoice AR152745 for \$110 was created in the City's Accounts Receivable system and sent. (Attachment M).
- <u>3/20/2018</u> No application or payment as agreed was received from Eric Depper through MuniServices or the City of Antioch. A \$200 Administrative Citation No. 4783 was issued for non compliance with Measure O with a due date of 3/30/2018. (<u>Attachment N).</u>
- <u>4/19/2018</u> Invoice AR152804 for \$220 was created in the City's Accounts Receivable system and sent. (<u>Attachment O</u>).
- <u>4/24/2018</u> No application or payment was received from Eric Depper through MuniServices or the City of Antioch. A \$500 Administrative Citation No. 5366 was issued for non compliance with Measure O with a due date of 5/4/2018. (<u>Attachment P</u>).
- <u>5/4/2018</u> Property owner Eric Depper came in to office and complied with Measure O ordinance and filed appeal for the \$500 Administrative Citation No. 5366 (<u>Attachments Q & R</u>).

#### **RECOMMENDATION:**

It is staff's recommendation to uphold the \$500 Administrative Citation No. 5366 issued on April 24, 2018 for violation of the Antioch Municipal Code Business License Required and Residential Landlord Business License Tax (Measure O).

#### CITY OF ANTIOCH ADMINISTRATIVE BOARD OF APPEALS

#### **General Information for Persons Appealing Citations**

The Administrative Board of Appeals is comprised of five Antioch residents, who are appointed by the Mayor and have volunteered their time to hear your appeal. The Board Members do not receive monetary compensation for their time and they are not employees of the City. They do not make or control the law. They are hearing officers who will review your appeal because you have requested the City do so. As the person making the appeal (the appellant) please keep in mind the below:

#### Schedule of Hearing:

- When an appeal is requested, it is typically scheduled for the first Thursday of every month.
- You will receive written notice of the date and time of the appeal hearing from the City Clerk's office 10 days after you file your appeal.
- The Agenda and Staff Reports will be posted onto our City's Website 72 hours before the Board of Administrative Appeals Hearing date. To view the Agenda information, click on the following link and then double click 'Board of Administrative Appeals': <u>http://www.ci.antioch.ca.us/CityGov/agendas/</u>. Other locations to view the Agenda are the City Council Chambers front window, City Clerk's Office, Antioch Branch Library, Senior Center on 2<sup>nd</sup> Street, and the Antioch Community Center on Lone Tree Way.

#### When You Don't Show For Your Hearing:

If you do not appear at the hearing time and date you have been notified of, and unless you have provided the City Clerk forty-eight (48) hour notice before the hearing that you are requesting a postponement, your appeal will be heard without you being there.

#### How You Will Act At Your Appeal Hearing:

- You and anyone else who is attending the appeal at your request will maintain a respectful attitude at all times,
- If you or anyone else does not maintain a respectful attitude, you may be asked to leave the hearing by the Board Chairperson.
- Your appeal is not an opportunity to debate or argue with City staff or Board members. Any questions should be directed to the Board Chairperson.
- When you speak, you should talk about the reasons why you feel the citation was wrongfully issued.

#### How The Appeal Hearing Will Go:

- The Board will read your item of appeal from its Agenda.
- The Board will then ask City staff to present an oral report with regard to your citation. The Board may ask questions of City staff after the oral report. This oral report will be for five (5) minutes.
- After staff has provided its report, and the Board is finished with its questions of staff, you will then be called to the podium to speak. Please come up and speak at the podium, not from the audience.
- You will have **five (5) minutes** to present the reasons why you are appealing the citation.
- Any other additional persons who may oppose or support your appeal can fill out speaker cards and speak for three (3) minutes.
- The Board may then ask City staff for a rebuttal to the statements you or others made in support or opposition of your appeal. This rebuttal is only for **three (3) minutes**.
- Then the hearing is completed and the Board will then issue its ruling on your appeal.

#### Your Burden:

- It is your appeal and therefore you bear the burden to prove that the citation was wrongfully issued.
- To win your appeal, you must have a majority of the Board uphold your appeal (3 of 5, or 2 of 3).
- If the Board determines there was in fact good reason to issue the citation, your appeal will be denied and the citation amount that you deposited to have your appeal will not be refunded.

#### How The Board Will Rule:

#### The Board can only rule one of two ways:

- To uphold your appeal and dismiss the citation.
- To deny your appeal and uphold the citation.

#### Written Findings and Order:

- The Board will render their findings and recommendations after the hearing is concluded or as soon as possible.
- You will be mailed the written decision of hearing within ten (10) days of the hearing.
- The decision of the Board is the final ruling on your appeal from the City.
