Chairperson Busenbarrick called the meeting to order at 3:02 P.M. on Thursday, June 7, 2012 in the Council Chambers.

**PLEDGE OF ALLEGIANCE**

Chairperson Busenbarrick led the Board, staff, and public in the Pledge of Allegiance.

**1.     CONSENT CALENDAR**

**A.     APPROVAL OF ADMINISTRATIVE APPEALS MINUTES FOR APRIL 26, 2012**

On motion by Board Member Schneider, seconded by Board Member Simpson, the Board of Administrative Appeals approved the Minutes of April 26, 2012, as presented. The motion carried the following vote:

**2.     APPEALS**

**A.     CITATION NO. 30040 – Appeal of Administrative Citation issued regarding *No Dog Licensing, No Proof of Rabies Vaccination, and Excessive Barking* of two dogs for Jennifer Campbell, 5116 Equestrian Way, Antioch, CA [§6-1.20(b), §6-12.2, §6-1.18]**

City Attorney Nerland clarified the process for hearing the appeals.

Animal Control Officer Gomez presented the staff report dated June 7, 2012, recommending the Administrative Appeals Board uphold the Administrative Citation for the violation of Antioch Municipal Codes § 6-1.20(b), 6-12.2 and 6-1.18.

In response to Chairperson Busenbarrick, Officer Gomez clarified with regards to foster dogs, any person owning, harboring, or possessing an animal for 30 days or longer was required to license the animal and provide rabies vaccinations.

## **APPELLANT**

Jennifer Campbell speaking to the violation for not licensing foster dog, "Bogart", stated he was only in her care for approximately 10 days; therefore she was not responsible for licensing. She noted both dogs were current on their rabies vaccinations. With regards to "Trinity", she was not current on her license; however, she intended to license her immediately after she was spayed. She reported the majority of time, she had taken her pets to work with her and she had purchased and attached a kennel to her garage side door to secure the dogs when they were left at home. She noted leaving the dogs in the kennel was done on a trial basis to determine if they could be left while she went to work and that was when the barking complaints began. She further noted her surrounding neighbors indicated they had not heard her dogs barking. She stated "Bogart" had since been adopted. She reported after purchasing bark collars for "Trinity" which had not worked, she had her surgically debarked to resolve this issue. She stated she accepted responsibility however, due to the cost incurred to remedy the situation, she asked for a re-evaluation of the citation.

In response to Chairperson Busenbarrick, Ms. Campbell stated many attempts to contact Antioch Animal Control were unsuccessful, as she had not received any response to messages she had left. She noted working 8-6, Monday – Friday did not allow her the opportunity to take proof of the vaccinations to Animal Services.

In response to Board Member Schneider, Ms. Campbell clarified "Bogart" was in her care for approximately two weeks.

In response to Board Member Simpson, Ms. Campbell stated she had attempted to call Animal Services to ask about the citation and get a fax number to send in the vaccination certificates. She noted after she had received the citation, she immediately had "Trinity" licensed and she had her father drop the paperwork off at Animal Services.

Ms. Campbell provided the Board with receipts for the bark collars and kennel as well as the veterinary bill for spaying and debarking "Trinity". She reported she had only left "Trinity" since she had been debarked and she would no longer be fostering dogs.

In response to Board Member Schneider, Mr. Campbell stated Trinity cannot bark and she was completely enclosed when left alone during the day; therefore the situation was completely rectified.

In response to Board Member Simpson, Ms. Campbell stated that since she had received the notice to correct, she had tried to leave work to deliver the paperwork and she had been unable to do so. She noted she had then asked her father to purchase the license for "Trinity"

as soon as he was able to do so. She further noted she took responsibility for the delay in getting the paperwork completed.

In response to Chairperson Busenbarrick, Ms. Campbell stated she understood the importance of becoming informed of City Codes related to pets.

## **REBUTTAL**

Officer Gomez reported the license for "Trinity" was purchased on April 4, 2012 and the Administrative Citation was given on March 17, 2012. She clarified the Animal Shelter was opened on Saturdays from 10:00 A.M. – 5:00 P.M. She commented that she had never received any messages from Ms. Campbell and her only contact with her was when the appeal was filed and she provided the City with proof of rabies. She noted she received an email from the reporting party on May 18, 2012 stating the barking had improved, however, he continued to deal with some barking.

In response to the Board, Officer Gomez noted from her experience vocal cords could grow back. She reported she had made sure the complaining party had verified the address and she had verified the barking herself, the second time she responded to the residence. She reiterated the City's request was for the Board to uphold the citation. She reported the City requires a dog to be licensed 30 days after coming into the City; however her citation was for 10 days.

## **REBUTTAL**

Ms. Campbell clarified due to debarking; "Trinity" was unable to make any noise.

Board Member Schneider stated Ms. Campbell had made considerable financial effort to remedy the situation; therefore he supported the citation be mitigated.

Board Member Simpson stated she felt the appellant had the opportunity to rectify this situation through Animal Services on a Saturday. She noted she was given a warning and 10 days to comply, which she had failed to do. She noted she had managed to file the appeal in a timely manner.

Board Member Schleder agreed that the Appellant had spent a considerable amount of money to remedy the situation, which should be considered.

Chairperson Busenbarrick commented most costs incurred were the price of dog ownership and the citation was for a correctable situation.

A motion was made by Board Member Simpson and seconded by Chairperson Busenbarrick to deny the Appeal of Citation Number 30041. The motion failed by the following vote:

*Ayes: Busenbarrick, Simpson*

*Noes: Schneider, Schleder*

City Attorney Nerland clarified the appeal failed due to the fact it is the appellants responsibility to get three votes to uphold the appeal. Therefore at this point, she would be responsible for paying the \$500.00 citation. She noted she had the burden of proof to overturn the appeal, which had not occurred.

On motion by Board Member Schneider, seconded by Board Member Schleder, the Board of Administrative Appeals upheld the appeal waiving the Citation for §6-1-12-2 No Rabies Proof x 2 dogs. The motion carried the following vote:

*Ayes: Busenbarrick, Schneider and Schleder*

*Noes: Simpson*

City Attorney Nerland stated staff would prepare a modified Decision indicating the Board's action, which would be signed and sent to the Appellant.

Chairperson Busenbarrick declared a recess at 3:42 P.M. The meeting reconvened at 3:47 P.M. with all Board Members present.

City Attorney Nerland announced the Board of Administrative Appeals was a volunteer board made up of residents of the City of Antioch who receive no compensation. She reported the dog owner, Mr. Flores, arrived today and requested an interpreter. Acting Deputy City Clerk Christina Garcia had volunteered to serve in that position and Mr. Flores had agreed.

**B. APPEAL to reverse "Potentially Dangerous Animal" decision for dog "Mono" (A506433), for Adan Flores, 1150 Rockspring Way, Antioch [§6-1.22 (A)(b)]**

Animal Control Officer Gomez presented staff report dated June 7, 2012, recommending the Board uphold the Declaration of "Potentiality Dangerous Animal" under Municipal Code § 6-1-22 (A) (b).

City Attorney Nerland reported on the dais was a revised proposed Decision for the Board in this matter.

**APPELLANT**

Mr. Flores stated he believed his dog was not aggressive and reported his dog had no incidence of biting since he was a puppy. He provided the Board with a description of the Samoyed breed indicating they were good with children and showed a video of "Mono" playing with children. He noted the report indicated there was no medical needed for the bite received. He stated that when he initially signed the paperwork, he did not understand the definition of surrendering the dog.

Chairperson Busenbarrick clarified with the concurrence of Shelter staff that if the dog was surrendered, it would be euthanized.

Mr. Flores stated he had reconsidered surrendering his dog and planned on complying with the Terms and Conditions within the Declaration of "Potentially Dangerous Animal", however, he had been unemployed and doing so was a financial hardship. He reiterated he did not believe his dog was potentially dangerous.

### **REPORTING PARTY - VICTIM**

Sarah Brambrey, Antioch resident, reported the dog "Mono" had gained access to her backyard at 3:30 P.M. by breaking out fence boards on April 30 2012, and noted when she entered the yard at that time, the dog exited back through the fence. She further noted when she went into the backyard later that morning; the dog charged her and had bitten her hand. She then contacted the Antioch Police Department who arrived and took a report. She stated as a result of the bite, she had been hospitalized with cellulitis. She commented that she believed the dog was dangerous and if given the opportunity to roam the neighborhood, it would harm others. She clarified the report indicated "no medical needed" referred to her declining an ambulance.

### **REBUTTAL**

Officer Gomez clarified the issue before the Board was that the dog being off its property and whether it had the potential to be dangerous.

In response to Board Member Simpson, Officer Gomez stated Officer Ward had observed that the dog had come through three fences to enter Ms. Brambrey's yard.

In response to Board Member Schneider, Mr. Flores stated his financial situation had not changed. If the citation was upheld, he would be unable financially to comply with the terms and conditions therefore he would have to surrender the dog. He reiterated the dog was playful and he had never been aggressive in the past.

In response to Board Member Simpson, Mr. Flores stated the cost of the kennel would cause a financial difficulty. He noted he would be able to buy insurance however he had not called to get prices.

City Attorney Nerland clarified for this hearing, the Board would determine if the dog was "Potentially Dangerous" or "Vicious". She noted the owner's course of action following that determination could occur at a future time.

Chairperson Busenbarrick closed the floor to public comment.

Board Member Schneider stated the owner had failed to take any action to secure the dog therefore he supports the City's recommendation to deem the dog "Potentially Dangerous".

Chairperson Busenbarrick stated with the medical expenses and photos presented by the victim, she felt the dog was "Potentially Dangerous".

Board Member Schneider stated a dog that size could have done significantly more damage; if he meant harm.

Board Member Simpson stated part of the medical treatment could have been precautionary. She noted for a dog that size she did not feel the bites were vicious in nature.

Supervisor of Animal Services Helgemo discussed steps taken to reach the conclusion "Mono" was a "Potentially Dangerous" dog which then placed a stipulation to provide a kennel for the dog to prevent him from getting loose when left unattended. She noted other stipulations were the general costs associated with pet ownership. She stated it was the dogs' action that put him in violation and noted she had witnessed this dog being very reactive and fence fighting with other dogs. She stated if the dog were declared a "Potentially Dangerous" animal and after three years there were no complaints and he does not violate any of the stipulations, the "Potentially Dangerous" title would come off of the dog "Mono".

Chairperson Busenbarrick stated she felt the terms are common sense pet ownership responsibilities.

*On motion by Board Member Simpson, seconded by Board Member Schneider, the Board of Administrative Appeals unanimously upheld the determination that the dog was "Potentially Dangerous" and denied the appeal.*

## STAFF REPORT TO THE ADMINISTRATIVE BOARD OF APPEALS FOR CONSIDERATION AT THE HEARING OF AUGUST 2, 2012

Violation of Antioch Municipal Code §6-1.12.2; §6-1.15; §6-1.20(c)

### REQUEST:

Appellate Pamela Wilson requests a hearing to appeal Administrative Citation AC-30277 issued June 20, 2012 citing the following violations of the Antioch Municipal Code:

#### §6-1.12.2: RABIES VACCINATION REQUIRED:

(A) Every dog owner shall procure a rabies vaccination by a licensed veterinarian upon the dog attaining the age of four months and at intervals not later than the expiration date on the vaccination certificate. A certificate shall be issued to the owner by the veterinarian showing the following:

- (1) The veterinarian's name and business address;
- (2) The name and description of the dog;
- (3) The date of the vaccination; and
- (4) The expiration date of the rabies vaccination.

(B) Exemptions may be issued by a licensed veterinarian if a rabies vaccination would be detrimental to the health of the dog. Every dog owner shall show a copy of the vaccination certificate upon the request of an Animal Control officer or other enforcement officer.

#### §6-1.15: LICENSE TAGS; DISPLAY:

The license tag shall be attached securely to collar or harness upon the dog for which issued at all times the dog is within the city and not confined indoors. The license tag shall be shown by the owner at any time upon request by the Animal Control Officer, or other enforcement officers.

#### § 6-1.20: UNLAWFUL ACTS:

It shall be unlawful for any person owning, harboring, possessing, or collecting any animal knowingly to:

- (C) Permit any animal, except a cat, to run at large

### BACKGROUND INFORMATION:

On January 22, 2010, the Antioch Police Department received a call from resident Alberto Porras regarding an unfamiliar dog in his backyard at [REDACTED] Chaps Court. *[See APD Incident Report: E10-007056.]* Antioch Police Officer Robert Solari responded to the call, impounded the dog and transported it to Antioch Animal Services. *[See Animal Kennel Card: A093987.]* On January 23, 2010, Pamela Wilson of 4928 Chaps Court identified the dog as "Precious," a female gold/fawn Pit Bull mix. *[See Lost Dog Report.]* Upon impound, "Precious" was unlicensed, unvaccinated against rabies and unaltered. Ms. Wilson was required to pay fines for these violations and boarding fees to redeem her dog. *[See R10-000297.]*

On June 20, 2012, Antioch Animal Services received a call from resident Michelle Edgmond regarding two dogs in her backyard at [REDACTED] Chaps Ct. *[See APD Incident Report: E12-057125 and Edgmond Witness Statement.]* Upon arrival, Animal Control Officer Gabrielle Johnson found two dogs (a black/white male Pit Bull and a red/white female Pit Bull, later identified as "Precious") running around the court. She saw the two dogs charge a woman (later identified as Kinsley McLaughlin) as she was getting out of her car. *[See Kinsley Witness Statement.]* While Officer Johnson caught the black and white dog, the red and white dog ran back into its backyard through an open gate at 4928 Chaps Ct. *[See attached photo of open gate at 4928 Chaps Ct.]* Officer Johnson shut the gate behind the dog and made contact at the front door of the residence. Officer Johnson spoke with a young adult, who confirmed that the dog, "Precious," as well as 8 puppies, lived at the 4928 Chaps Ct. residence and belonged to Pamela Wilson. However, he stated that the black and white dog did not live at the residence.

As the dog, "Precious," did not have a current dog license tag on display in accordance with the Antioch Municipal Code §6-1.15, Officer Johnson contacted Animal Control and confirmed that "Precious" had not been licensed or vaccinated against rabies since November 7, 2010. *[See attached license and rabies vaccinations records from Antioch Animal Services and Pet Data Licensing Services.]* Officer Johnson left an Administrative Citation for §6-1.12.2: No Current Rabies Vaccination, §6-1.15: No Current Antioch License Tag on Display and §6-1.20(c) Permitting a Dog to Run at Large. She also advised that while at large, "Precious" had charged at a citizen and had almost drown in a neighbor's pool. As well, she advised that they would need to purchase a Kennel Permit if they were going to keep the puppies on the property. *[See attached Administrative Citation AC-30277 and Animal Control Activity: A12-000048.]*

The black and white Pit Bull was transferred to Animal Control. After being held the legal waiting period for a possible owner to redeem it, the dog was unclaimed and later euthanized as it could not be adopted out due to its aggressive behavior.

On July 7, 2012, the Edgmond Family of [REDACTED] Chaps Ct. took three photos of the dog, "Precious," again running at large in the neighborhood and also trespassing in the front yard of some other residences in the court. The photos were later emailed to Animal Control. *[See attached photos.]*

On July 11, 2012, Antioch Animal Services received a call from resident Michelle Edgmond regarding the dog, "Precious," being on her porch at [REDACTED] Chaps Ct. [See APD Incident Report: E12-064567] Mrs. Edgmond could not exit her house because she was afraid of the dog's previous behavior while at large. Upon her arrival, Officer Johnson was unable to find the dog, "Precious," at large in the court. However, Ms. Edgmond stated that she had gone out to her porch to smoke when she saw the dog, "Precious," was out in the court, and it ran up to her house and onto her porch. Ms. Edgmond further stated that she was unable to get pictures of the dog on her porch this time because the dog was too close to her front door and she did not feel safe going outside. However, she did show Officer Johnson photos of the dog at large in the court from the previous incident on July 7, 2012.

Officer Johnson then made contact with Pamela Wilson, the owner of the dog, "Precious," at 4928 Chaps Ct. Ms. Wilson stated that although her dog, "Precious," had gone outside with her to the trash without a leash on, the dog did not at any time leave the property. Ms. Wilson had also stated that her husband had passed away in November 2011 and that she was repeatedly a victim of racism in the court. She felt that these false reports of her dog being at large were a continuation of that harassment.

Giving Ms. Wilson the benefit of the doubt, Officer Johnson issued her a 10 day correction citation for the same violations of §6-1.12.2: No Current Rabies Vaccination, §6-1.15: No Current Antioch License Tag on Display and also advised her to be sure to keep her dog on her own property. Officer Johnson further advised her that if she did not correct the violations and continued to let her dog roam at large, that she would have to issue her a second Administrative Citation that would have higher fines attached to it. [See attached Notice to Correct: 26-C128228]

On July 19, 2012, Ms. Wilson showed proof of a current rabies vaccination and licensed her dog, "Precious," at Antioch Animal Services. Since Ms. Wilson complied with the licensing and vaccination requirements within the given 10 day period of her most recent correction notice and her dog was not at large again within that time frame, she was not issued a 2<sup>nd</sup> Administrative Citation. [See R12-001980]

#### **RECCOMENDATION:**

Due to the number of times that the dog, "Precious," has been allowed to roam at large on Chaps Court and the 1 year and 8 month lapse in rabies vaccination and dog licensing, it is Staff recommendation to uphold the Administrative Citation for violation of Antioch Municipal Code §6-1.12.2: No Proof of Current Rabies Vaccination; §6-1.15: No Current Antioch Dog License Tag on Display and §6-1.20(c): Permitting a Dog to Run at Large.

The week of June 18<sup>th</sup> in regards to a tan pit-bull by the name of "Precious", a female dog that was in my pool under the cover and couldn't swim well do to being under the pool cover. I pulled the dog out. And knew where the dog lived, which is at the address 4928 Chaps ct. I went out my front door and a male pitbull that was black with white on it's chest came charging me with great aggression and was trying to bite me. I had seconds to getting back inside my house. Mean while I look out my window in the pool area and the tan female pitbull was still in the yard, then the male goes through my fence to the pool area also. An officer came to our resident and then noticed the female first, coming from my yard. My neighbor at [REDACTED] Chaps ct. was also in the court area and saw the tan dog and told the lady where she lived. Then minutes later the male black dog came charging with great aggression to my neighbor she rushes to get back in her car in fear. My husband had been on the phone with me to calm me down , and to also tell me that the neighbor at 4928 has had the male black dog at their house several times. And has seen teenagers walking it in our court. My husband has also seen the tan dog that belongs to the neighbor at 4928 out several times off leash with no owner.

The day this all happened we did notice that our fence that these dogs went through was the right side to our pool area. And the two dogs had to be chasing a cat, cause our fence was busted through on the bottom.

I would like to say on our behalf and my courts behalf that we all have deep concerns on the well being of all of our children which is 8 boys under 12 and 1 girl under 9 years old. I hope that the owner at 4928 realizes that it could have been a child that day that could have been attacked! That is every parents fear!

To Whom It May Concern:

I am a resident at [REDACTED] Chaps Ct in Antioch. I am writing to you in regard to an aggressive dog that resides in my neighborhood.

The residents at 4928 Chaps Ct. own two dogs that I am aware of. One appears to be a pit-bull, tan in color, which goes by the name of "Precious." To my knowledge, they have owned "Precious" quite a while, and she is generally a very sweet dog. The other dog also appears to be a pit-bull, and is black with a bit of white. I had been warned that the black dog could be vicious at times, and to keep my distance. "Precious" and the black dog escape the yard regularly and are usually ushered in without conflict. We also see the youths of the residence walk the black dog fairly regularly, so we know it belongs to them.

However, an incident happened last week involving the black dog. I was arriving home, parked in court parking, and noticed an Animal Services officer attempting to capture "Precious." Because I am familiar with "Precious," and understand her to be a friendly dog, I got out of my car and tried to help catch her. A few minutes later, I saw the black dog come running from the porch at [REDACTED] Chaps Ct. He ran at me snarling and appearing aggressive and I jumped in my car and shut the door before he reached me. The Animal Services officer luckily caught both dogs and loaded them into the van.

We have never had a problem with their dog "Precious." Even if she does get out, we generally usher her back through the gate and all is well. My hope is that this aggressive dog issue can be resolved, as we have many neighborhood kids who play out front quite regularly.

I was dispatched to an aggressive call about a dog that just attacked the reporting party (rp) in this case the rp was Mrs. Michelle Edgmond. The call also indicated that Mrs. Edgmond was attacked after she pulled her neighbors pit-bull a different dog out of her pool. The dog fell into the pool earlier and that she saved the dog. Once I arrived at Chaps Ct in Antioch and parked my vehicle in the courts parking area in the middle of the court. A purple VW bug followed me into the court and parked across from me. The driver was Kinsey McLaughlin. At first I only saw a raw a red and white pit-bull female with moderately saggy nipples in the driveway of a house on Chaps court walking around near the rp's house. Once I had taken a look around I saw the second dog the rp said attacked her. A black and white male pit-bull walked up the female coming from the direction of the rp's address. I told Ms. McLaughlin to be careful as she was getting out of her car. I advised her that the black and white dog had attacked one of her neighbors.

She indicated that the red and white pit-bull was "precious" and she pointed where she believed the dog lived. She pointed out 4928 Chaps Ct. she tried to call "precious" over to her by name. Both the dogs started walking in Ms. McLaughlin direction and I grabbed my catch pole and leashes. Both dogs Precious and the male pit-bull started running toward Ms. McLaughlin. She realized the dogs were running towards her and she started to guard herself behind her car door. She eventually ended up in her car just before the black and white pit-bull nearly missed her ankle.

I was able to get between the dogs and Ms. McLaughlin and caught the male dog. The female "precious" ran into the yard of 4928 Chaps Ct. the fence was wide open. After I put the black and white dog in my vehicle I walked over the 4928 Chaps where the dog "precious ran into, the fence was wide open and I took a picture. With the fence open I could see the side garage door was open inward toward the garage and I could hear whimpering and whining coming from inside the garage. It sounded like a litter of puppies; it seemed to me that the two dogs got out of the yard from an unsecure latch.

2..continue... I shut the gate and walked over to the front door. I knocked on the door and rang the door bell. Mean while I called into the Antioch Animal Services to Officer Gomez and had her look up the address for a current license and rabies to a dog at that address..continueShe confirmed that a dog named "Precious" and red and white pit-bull was impounded and returned to owner from that address and that license and rabies were not current. She also indicated that the owners name was Pamela Wilson.

With another knock a young man in her preteens maybe answered the door. I asked if any adults were home anyone over the age of 18. He said yes over the music that was playing and went to go get his brother. After turning down the music his brother came to the door. I asked him if they had any dogs living there. He indicated he did. I told him that I was called out because two dogs were out loose and one dog attacked one his neighbors a black and white pit-bull. I asked him if that was his dog. He said no that he didn't know who that dog was. I asked him if "Precious" still lived at this address a red and white pit-bull. He said she does and "I asked how many puppies are in the garage? The young man answered 8 puppies. I advised him that the dog precious was out running around and that she is back in her yard and I shut the gate so that she could not run out again. I also told the boys to find something to lock the gate because it is not secure. I let him know that I was taking the male pit-bull since he is not claiming at the dog lives there and that I was going to leave a ticket for his mom. I wrote up an administrative citation with the owner information Animal Control Officer A. Gomez was able to give me over the phone. I left an administrative citation for "Precious" be at large, not having rabies, and not having a license. I advised on the ticket that she needs a kennel permit if the puppies are to remain on the property. Also to be aware that Precious almost drowned in a neighbor's pool. I left the ticket with Ms. Wilson's adult son on the property and instructed him to give it to his mother when she got home....continue

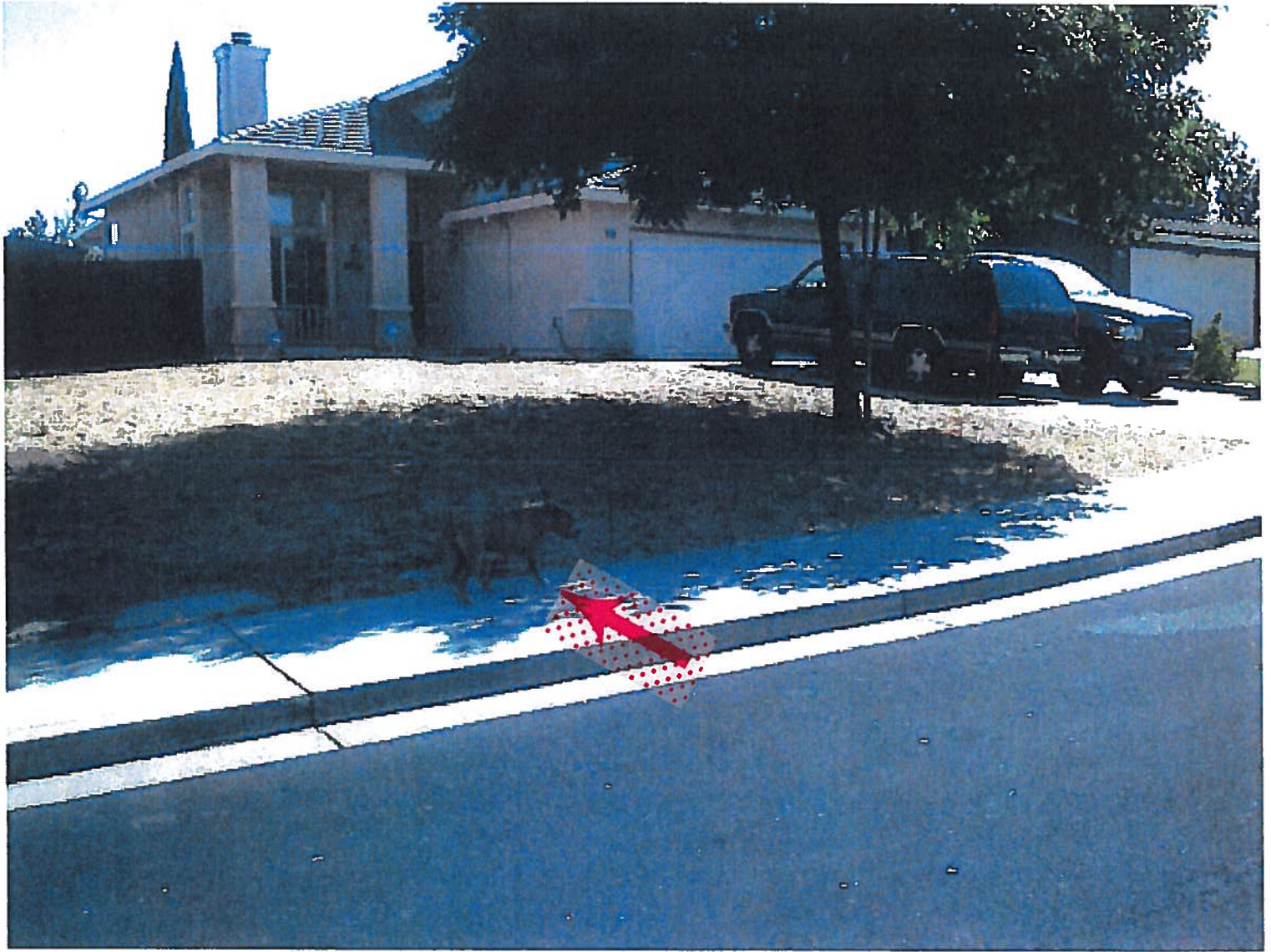
3...continue...I walked back over to Mrs. Edgmond's residence and asked her again how the first dog "precious" got into her backyard. She showed me a hole in the fence where the dog got through from her front yard. She told me that she was in her house and heard her dogs starting to bark at the back door. She went to see what they were barking for and saw the pit-bull fall into her pool and was having problems swimming because of the pool cover they have over their pool. She pulled the dog out and went to walk her back to where she knows the dog lives due to prior events with the dog getting out. I advised Mrs. Edgmond that precious is back in her own yard and that I was able to take the black and white pit-bull because the dog owner's son claims the dog is not their dog. She affirmed me that she has seen the black and white dog there several times before at the address of [REDACTED] Chaps Ct.

The black and white pit-bull was impounded and the Wilsons residence was given an administrative citation.

14 I. GENERAL FINDINGS:

- 15 1. The underlying citation concerns code violations at 4928 Chaps Ct. for violation of Antioch  
16 Municipal Codes: §6-1.12.2 (no proof of current rabies vaccination), §6-1.15 (no current license  
17 tag on display) and §6-1.20(c) (permitting a dog to run at large). At all relevant times the  
18 Appellant was the sole owner of dog and/or the responsible party.
- 19 2. Appellant appealed the Administrative Citation for Municipal Codes §6-1.12.2 (no proof of  
20 current rabies vaccination), §6-1.15 (no current license tag on display) and §6-1.20(c) (permitting  
21 a dog to run at large), which are the only items at issue for today's hearing.
- 22 3. An Administrative Appeals Board Hearing regarding the Appellant's appeal of the  
23 Administrative Citation was set for August 2, 2012, and the Appellant was duly notified by the  
24 City Clerk.

25 II. SPECIFIC FINDINGS:

26 An Administrative Appeals Board Hearing regarding Appellant's appeal of the Administrative  
27 Citation was duly held on August 2, 2012, at 3PM. Evidence, both oral and documentary, was taken  
28 and based on the preponderance of said evidence; the following specific findings are made:

1. On January 22, 2010, Antioch Police Department responds to a call for service and finds the dog,  
"Precious," in a neighbor's backyard. The dog is unlicensed at the time of impound.
2. On November 7, 2010, Pamela Wilson's dog license and rabies vaccination for the dog, "Precious,"  
expires. A license renewal from Pet Data services is sent to Pamela Wilson at 4928 Chaps Ct.

3. On June 20, 2012, Antioch Animal Services responds to a call for service regarding "Precious" being at large on Chaps Court. Upon arrival, Officer Johnson finds "Precious" running loose in the court and corrals her back into her own backyard at 4928 Chaps Ct. Officer Johnson leaves an Administrative Citation for Pamela Wilson for violation of Antioch Municipal Codes: §6-1.12.2 (no proof of current rabies vaccination), §6-1.15 (no current license tag on display) and §6-1.20(c) (permitting a dog to run at large).
  4. On July 11, 2012, Antioch Animal Services responds to a call for service regarding the dog, "Precious," trespassing onto the property of 4920 Chaps Court. Upon arrival, Officer Johnson finds the dog, Precious," back on its own property, without a current license tag and unvaccinated against rabies. Officer Johnson issues a 10 day correction notice, advising Ms. Wilson that she will issue a 2<sup>nd</sup> Administrative Citation with higher fees if she does not correct the violations.
  5. On July 19, 2012, Ms. Wilson provides proof of a current rabies vaccination and purchases a license for her dog, "Precious." A 2<sup>nd</sup> Administrative Citation is not issued.
  6. The City has the ability to issue Administrative Citations to Dog Owners that are in violation of the Antioch Municipal Code pursuant to AMC §1-5.03 which states, in part, that Animal Control Officers are authorized to issue Administrative Citations regarding "Title 6, Chapter 1: Animals" of the Antioch Municipal Code.

15 Based on a preponderance of evidence, the Board finds that there was probable cause for the City to issue an Administrative Citation and the appeal is denied.
