**RECOMMENDATION**

As previously indicated in the staff report presented to you dated July 7, 2025, a Notice of Intent to Record Lien was sent to each property owner listed on the attached spreadsheet due to outstanding receivables to the City of Antioch. As of today, July 23, 2025, fifty-four of those accounts have reconciled their balances.
