PRESENTATION

Community Support Contribution to Hapgood Theatre Company

Councilmember Kalinowski stated he attended and viewed the play and the performance was unique and a wonderful community event.

Jackie Seeno agreed with Councilmember Kalinowski and spoke to the theater being an asset to the community.

Jackie Seeno, representing Discovery Builders presented Josie Miller representing the Hapgood Theater Company and Ralph Garrow Jr. President of the Hapgood Theater Company Board of Directors, with a community support contribution. Ms. Miller thanked Ms. Seeno and the City Council for the contribution. Mr. Garrow thanked Discovery Builders, the City of Antioch and everyone who has supported the Theater.

Councilmember Kalinowski reported the Lesher Foundation provided a grant that required similar contributions which were provided by the City of Antioch and Discovery Builders.

PUBLIC COMMENTS

Sandra Golightly, Antioch resident, expressed concern regarding an article in the Contra Costa Times pertaining to starter homes in the east bay and discussed the adverse affect smaller, inexpensive homes would have on the community. On motion by Councilmember Davis, seconded by Councilmember Moore, the Council unanimously approved the Council Consent Calendar with the exception of items A, E, H which were removed for further discussion.

Item E – In response to Antioch resident, Marty Fernandez, Mr. Harrington clarified the section of roadway where DiMaggio intersects with James Donlon was incomplete as the City must wait for PG&E to complete the vault drop on the corner. He further reported the City would be completing the work within 45 days.

On motion by Councilmember Moore, seconded by Councilmember Simonsen, the City Council unanimously approved item E.

Item H – Mayor Freitas requested the City Council delay this item to a future date.

On motion by Councilmember Kalinowski, seconded by Councilmember Simonsen the City Council unanimously delayed Item H to a future date.

COUNCIL REGULAR AGENDA

2. ORDINANCE AMENDING SECTION 2-5.10 AND ADDING SECTION 2-5.108 OF THE ANTIOCH MUNICIPAL CODE TO CREATE THE BUILDING BOARD OF APPEALS TO HEAR BUILDING RELATED APPEALS #302-12

City Attorney Nerland presented the staff report dated December 28, 2007 recommending the City Council: 1) Motion to approve the reading of the ordinance by title only; 2) Motion to introduce the Ordinance regarding creation of the Building Board of Appeals; and, 3) Motion to direct staff to announce opening for the Building Board of Appeals.

Councilmember Simonsen requested the staff report reflect "The Building Official" as "The Chief Building Official".

Mayor Freitas stated the Board should be independent and suggested establishing a list of up to three additional alternate members.

Will LeRoy expressed concern the City's rental inspection program was an invasion of the residents and homeowners privacy.

City Attorney Nerland clarified this agenda item was not related to the rental inspection program; furthermore, creation of the Building Board of Appeals was consistent with the State of California code.

On a motion by Councilmember Kalinowski, seconded by Councilmember Simonsen, the City Council unanimously approved: 1) the reading of the ordinance by title only; 2) to introduce the Ordinance regarding creation of the Building Board of Appeals; and 3) to direct staff to announce the opening for the Building Board of Appeals, with these changes: A) Change "The Building Official" to "Chief Building Official"; B) Section 2-5.108 (A) "The Building Board of Appeals shall consist of three regular members and up to three alternate members."

PUBLIC COMMENTS

Victoria Overing, Richardo Lopez and Scott Gardner representing the LaRouche Political Action Committee discussed the state budget deficit and financial crisis occurring due to subprime mortgages. They suggested the City Council consider supporting, through a resolution, the Homeowners and Bank Protection Act.

In response to Mayor Freitas, Mr. Gardner stated the Homeowners and Bank Protection Act had not been endorsed by any cities in Contra Costa County.

William LeRoy, Antioch resident, stated he felt for full disclosure to occur, assessments should be included in the price of the house.
