Mayor Davis called the meeting to order at 7:02 P.M., and City Clerk Martin called the Council/Agency roll.

Mayor Davis announced Council Member Kalinowski has an excused absence.

PLEDGE OF ALLEGIANCE

Mayor Pro Tem Rocha led the Council and audience in the Pledge of Allegiance.

PROCLAMATIONS

On motion by Councilmember Rocha, seconded by Councilmember Moore the Council members present unanimously approved the proclamations.

Councilmember Rocha accepted the proclamation proclaiming March 31, 2010, as Cesar Chavez Day and announced she attended the Contra Costa Chamber Supervisors event for Cesar Chavez. She invited the community to attend tributes to Cesar Chavez on March 26, 2010, at Los Medanos College from 2:00 . 5:00 P.M. and March 28, 2010, at Antioch High School, Beede Auditorium.

Councilmember Moore presented the proclamation proclaiming April 3, 2010, as April Pools Month, to Pools Safety Council committee members, Ryan Graham, Lt. Robin Kelly, Bill Gegg, Lori Chalifoux and Russ Burror who discussed their efforts to create an awareness for drowning prevention and invited the community to attend the April Pools Day event on April 3, 2010, from 12:00 . 4:00 P.M. at Prewett Water Park.

In response to Councilmember Parsons, Mr. Graham reported they are sending informational brochures to all property owners who have a pool or spa. Mr. Gegg added the Contra Costa County Pool Safety Committee sent out 4000 brochures to pool and spa owners in Antioch.

James Shen, representing the Antioch Rotary Club, announced Council General event from the Peoples Republic of China in San Francisco will be visiting the Antioch Rotary Club on

March 25, 2010, to give a speech on the cultural and modern economy of China. He invited the City Council to attend the luncheon on March 25, 2010, and requested Mayor Davis present him with a proclamation to recognize his presentation.

Mayor Davis requested staff prepare the proclamation.

PUBLIC COMMENTS

Douglas Tokes, Antioch resident, questioned if the City Council and staff exercised due diligence when considering the increase in trash collection rates and extension of the Allied Waste Services contract.

Nancy Fernandez, Antioch resident, announced a Celebration of Earth Day Keep Antioch Beautiful will be held on from 8:30 . 11:00 A.M. on April 17, 2010, and will be followed by a BBQ lunch for the volunteers, sponsored by Honeywell, at Contra Loma Regional Park. She recognized Councilmember Parsons for spearheading the event and acknowledged the committee of volunteers and sponsors. Contact information was given for anyone wishing to participate.

Fred Hoskins, Antioch resident, reiterated his disappointment in the City Council for not addressing a previous request for consideration of a police oversight commission. He discussed an incident at the Antioch Historical Society Museum, in which, he feels, Antioch Police overstepped their authority and urged the Council to open dialog so that these types of issues can be addressed.

Walter Ruelig, on behalf of the Antioch Unified School District, thanked the Gate Keepers for hosting a wonderful event. He announced the Delta Academy of Performing Arts is moving to Deer Valley High School. He reported the Antioch Climate Change Committee attended a workshop on March 20, 2010, and he invited the community to attend a workshop at 6:30 P.M. on March 30, 2010, at Antioch High School Beede Auditorium. He thanked Councilmember Rocha for providing a Census Supervisor with his contact information to get the School District involved in the process.

Iris Ebel, Antioch Business Owner, expressed concern her tenant has been informed he can no longer store impound cars for the Antioch Police Department. She stated the business is clean and she has not received any complaints. She questioned if the city could look into this matter and consider allowing the business to remain operational.

Mayor Davis requested City Manager Jakel follow up with Ms. Ebel regarding her concerns and report back to the City Council.

Mayor Davis announced the fourth appointment will be held over to April 13, 2010.

4. RESOLUTION CONTAINING RECOMMENDATIONS TO THE BART BOARD CONCERNING THE PROPOSED HILLCREST EBART STATION (#1107-03)

Consultant Carniglia presented the staff report dated March 17, 2010, recommending the City Council adopt the resolution. He noted staff has provided the City Council with an updated resolution this evening to address the issue of funding priorities for any bid savings.

Armando Cardona, Antioch resident, representing CCISCO, thanked the City Council for implementing the local hire policy in the resolution.

Chris Schildt, representing TransForm thanked the City Council for including support for a local hire program as part of the resolution as well as many other elements of the resolution. Additionally, she thanked City and BART staff for being cooperative in having a series of meetings to work through access improvements.

Pastor Mario Howell, Antioch Church Family, thanked the City Council for their leadership and supporting a local hire policy.

Fred Hoskins, Antioch resident, spoke in opposition to the current EBART plan and provided the City Council with written recommendations for BART phases #1-3, which he requested, be included as an attachment sent to the BART Board of Directors. He reviewed his recommendations.

Tony Tiscareno, Antioch resident, spoke in support of the resolution and suggested provisions for some local hires for operations and maintenance of the facility.

Joel Keller, BART Director thanked staff for their hard work on the resolution and stated he was prepared to commit to a local hire policy for future contracts. He cautioned the first contract was fast-tracked and therefore they may not be able to include the local hire component.

In response to Councilmember Rocha, Mr. Keller cautioned BART did not have authority to reprogram any funding from the Contra Costa Transportation Authority or the Metropolitan Transportation Commission.

In response to Councilmember Parsons, Mr. Keller stated BART is committed to working in a cooperative way to seek funding for the study to initiate the planning for an eBART station beyond Hillcrest Avenue. He stated they will do everything possible to insure the multimodal access to the Hillcrest station is planned properly.

Councilmember Parsons expressed concern regarding circulation around the Hillcrest Avenue station and requested the future station planning become a top priority.

Consultant Carniglia stated he can work with Mr. Keller, BART staff and surrounding cities to start the dialog for the future station design and layout.

Councilmember Moore stated he had heard the community desires for traditional BART service in Antioch; however, this project was funded and would bring much needed relief to East County.

In response to Councilmember Parsons, Consultant Carniglia reported meetings on the design of the station had been held and they were looking at solutions to simplify transition from the north to the station.

Councilmember Moore thanked Mr. Carniglia for working with all stakeholders on a well designed project and a resolution which encompassed the City Council of direction.

Councilmember Parsons requested the resolution with a letter from the Mayor be sent the Congressman.
