ANTICIPATED LITIGATION was due to facts and circumstances regarding the Councilos action on the Walmart Expansion which could lead to significant exposure to litigation. Regarding item #3, CONFERENCE WITH LEGAL COUNSEL. EXISTING LITIGATION, no action was taken.

City Clerk Martin called the roll.

Mayor Pro Tem Rocha led the Council and audience in the Pledge of Allegiance.

ANNOUNCEMENTS OF CIVIC AND COMMUNITY EVENTS

Barbara Sobalvarro, Antioch resident, President and Founder of Friends of Animal Services, invited the City Council, staff and community to attend the Black Cat Ball fundraiser at 6:00

P.M. on October 23, 2010 at the Lone Tree Golf and Event Center. All proceeds benefit animals at the Antioch Animal Shelter. Contact information was given.

Police Captain Cantando announced the Police Activities League Charity Golf Tournament would be held on September 17, 2010 at the Lone Tree Golf Course. Contact information was given.

Paul Adler, representing Supervisor Federal Glover announced the 2010 Gang Summit would be held from 8:00 A.M. to 4:00 P.M. on October 9, 2010 at Deer Valley High School. He thanked everyone for their support and requested event information be added to the Citys website.

PUBLIC COMMENTS

Nancy Fernandez, Antioch resident, reported her dog was killed by another dog in her yard and the owners of the dog responsible for the death of her pet were still allowing their animals to run unrestrained in the neighborhood. She thanked the Antioch Police Department, Antioch Animal Control and Antioch Veterinary Hospital for their help in the matter and announced they had begun circulation of a petition to revise the Citycs ordinance applying to vicious dogs and their owners. Contact information was given for anyone wishing to help circulate the petition.

Garry Holman, Antioch resident and Licensed Professional Engineer, spoke to safety issues related to the erosion of the aging infrastructure throughout the City. He recommended the City Council obtain maps of natural gas transmission lines and make the information available to the public. Additionally, he suggested the City instruct residents to notify PG&E and the City immediately if they smell the presences of natural gas, keep detailed records of these calls and inform neighbors of their concerns. He further recommended the City also maintain records of the information. He offered his personal services to the City.

Mayor Davis requested staff agendize the issue of the Cityos infrastructure, as well as emergency services operations within the City for an October meeting.

Rick Allen and members of the Society of American Magicians invited the community to attend the Rock and Roll Magic Show being held at 7:00 P.M. on October 2, 2010 at the El Campanil Theatre. Contact information was provided.

Councilmember Moore referenced an email he received this afternoon which requested the item be tabled to September 28, 2010 due to the fact the ballot arguments had not been considered by the City Council.

2. PRESENTATION ON ANTIOCH FERRY TERMINAL BY WATER EMERGENCY TRANSPORTATION AUTHORITY

Consultant Carniglia presented the staff report dated September 8, 2010 recommending the City Council receive the presentation by the Water Emergency Transportation Authority

(WETA) on the proposed Antioch Ferry Terminal and the City Council provide comments and direction to WETA staff as appropriate

John Sindzinski, representing the Water Emergency Transportation Authority (WETA), and Gary Oates and Reema Mahamood, representing ESA, gave a brief overhead presentation of the Antioch Ferry Terminal Project Reinitiation.

Councilmember Parsons thanked Senator DeSaulnier for freeing up the money to get the WETA project and Ferry Service EIR back on track. She voiced her support for the %+Street terminal location.

Mayor Davis thanked John Sindzinski, Gary Oates and Reema Mahamood for the presentation as well as Consultant Carniglia for his participation.

Councilmember Parsons also thanked Consultant Carniglia.

3. EAST BAY REGIONAL COMMUNICATIONS SYSTEM AUTHORITY (EBRCSA)

Councilmember Kalinowski reported on the advice of City Attorney Nerland, he would recuse himself from the item, due to the potential conflict of interest based on his employment as a County Sheriff. He left the dais.

Chief of Police Hyde presented the staff report dated September 8, 2010 recommending the City Council direct staff as to Council desired course of action regarding the City participation in the East Bay Regional Communications System Authority.

Mayor Davis discussed the importance of intercommunication among the various agencies and noted he supported participation in the East Bay Regional Communications System Authority.

STAFF COMMUNICATIONS

COUNCIL COMMUNICATIONS

Councilmember Rocha asked for reconsideration of the Walmart issue regarding the Aug 17, 2010 vote Resolution #B, which she understood was not possible due to the fact she was not part of the prevailing party on the motion. She clarified she wanted the item to come back to the City Council for discussion due to Roberts Rules.

City Attorney Nerland clarified Roberts Rules do not trump the Brown Act and the Walmart item was coming back to the City Council on the September 28, 2010 agenda. She reiterated what she had stated in closed session, she anticipated the staff report would provide a recommendation and spectrum of options from which Council could take final action on the item.

Councilmember Moore reported he had received communication from Antioch Chambers of Commerce requesting certain information under the Public Records Act and Freedom of Information Act. He noted the request indicated they were asking for the information due to the fact he had received a communication allowance from the City of Antioch. He clarified he does not, nor had he received said communication allowance for over two years. He stated he paid for all his email and cell phone communications out of his personal funds.
