- d) A finding that SPPI-Somersville, Inc. and Somersville-Gentry Inc. have breached the Settlement Agreement dated September 15, 2009
- 2) If the defaults of the Development Agreement, Improvement Agreement and Deferred Improvement Agreement are not remedied and work does not begin immediately on the Markley Creek Culvert Crossing project followed by the Somersville Road Widening project, direct staff to negotiate the appropriate agreements with the surety bond companies or report back to the City Council on March 22, 2011 with all options for consideration
- 3) Approval of the deed restriction on Black Diamond Ranch open space located immediately west of Somersville Road that Discovery Builders failed to provide the California Department of Fish and Game before deeding the property to the City
