Term of the Agreement	15 year agreement organized as follows: -Review after 3 years, 5 years, 8 years, 12 years -submit annually an operating budget before FY begins (March 15 th) -demonstrate break even operations -Review proposed CIP with City annually	
Payment to City for right to operate	\$20,000 annual payment made each July at the beginning of the FY	
Amendments	All previous amendments null and void; include ALL previous amendment content in new agreement with new direction and parameters	
Fees and Charges	Golf Corporation sets fees; submits proposed fees annually for City approval and review as part of operating budget presentation. Presentation before Council and/or Commissions as requested	
Minimum Number of Rounds	40,000 rounds deemed minimum; less than 40,000 during review requires additional City operational direction

Street Maintenance from Golf Course Road to Clubhouse	Golf Corporation responsible for daily maintenance of roadway.
