SUBJECT: Governor Newsom's Homeless Trailer Program

RECOMMENDED ACTION

It is recommended that the City Council provide authorize the City Manager to apply for Governor Newsom's Homeless Trailer Program.

FISCAL IMPACT

The fiscal impact is unknown at this time, but may require costs for permits and improvements to accommodate the homeless trailers.

DISCUSSION.

Governor Newsom recently unveiled a program to deploy 100 state owned trailers to qualifying Cities and Counties throughout the state for the purpose of housing the homeless. Initial discussions with the Governor's office have resulted in Antioch being a potential candidate for 3 to 5 trailers that can house up to 10 individuals each.

The details about utility hook ups and other improvements that will be required to accommodate the trailers are still unknown. The City Manager is looking for direction if the City Council is interested in pursuing this opportunity. The Governor's Office is requesting that applications are due by end of day Wednesday January 29, 2020
