**Ordinance Update** 

#### RECOMMENDATION

It is recommended that the Planning and Economic Development Commissions conduct a study session on the opportunities and constraints for developing a Downtown Specific Plan and updating the General Plan Land Use Element and Zoning Ordinance.

#### **BACKGROUND**

On July 11, 2014, the City was awarded a grant from the Strategic Growth Council under the Sustainable Communities Planning Grant and Incentives Program. The grant was in the amount of \$426,857 for the development of a Specific Plan for the downtown (Rivertown) area.

Following the award of the grant, the City Council approved an additional \$241,406 for an update to the General Plan Land Use Element and the Zoning Ordinance. The General Plan Land Use Element and Zoning Ordinance updates are in response to the changes in the market due to the recession, as well as the increase in the pace of development. The updates would also take into consideration the reduction in staffing levels while also becoming more business friendly. With the understanding that the residents of the City are ultimately the primary concern, this process is aiming to achieve the following three goals:

- Support of clean and safe housing and neighborhoods.
- Encourage and expedite permits for businesses that provide residents with goods and services, entertainment, and employment opportunities.
- Preservation of the ability for residents to provide input on proposals that have the potential to impact residents and the community.

The City has hired Loewke Planning Associates as the firm to undertake the Specific Plan and the General Plan Land Use Element and Zoning Ordinance updates.

#### **ENVIRONMENTAL**

The study session is considered to be information collection and is a non-entitlement action; therefore, does not require environmental review. The Specific Plan and the General Plan Land Use and Zoning Ordinance updates would require compliance with the California Environmental Quality Act.

#### **ANALYSIS**

Loewke Planning Associates thus far has reviewed the existing conditions which revealed a number of important opportunities and constraints affecting the City's ability to advance the community's goals. The review of existing conditions has consisted of examining current City documents, conducting interviews with community stakeholders to solicit for feedback, examining the infrastructure capacity, and conducting an analysis of the real estate market to name a few.

Loewke Planning Associates will be presenting their findings as they pertain to the opportunities and constraints within the City of Antioch. Staff is looking for feedback from the Planning Commission and the Economic Development Commission, as well as the public, on the initial planning work that the City has undertaken thus far. The feedback will help to develop the City's goals and to shape the future policies that will guide land and economic development.
