## **NEW PUBLIC HEARINGS**

2. UP-08-25 – Anthony Nathaniel on behalf of Shadows of the Knight Motorcycle Club requests a six month review of the Use Permit for the purpose of holding club meetings and other non-profit functions. The site is located at 2101 W. 10<sup>th</sup> Street (APN 074-051-005).

Through discussions, there was a consensus that the sign be powder coated in a low sheen and that the applicant choose one color for the letter backing.

Per the request of the City Attorney, the applicant has agreed with all proposed conditions, per the Staff Report.

On motion by Commissioner Johnson, and seconded by Commissioner Brandt, the Planning Commission approved the addition of one (1) monument sign at the East County East Shopping Center on Somersville Road, with the addition of:

- Condition No. 13: <u>"That the applicant select only one color for the background of the routed out letters of the company's names."</u>
- Condition No. 14: <u>"That the finish of the sign be powder coated and that it match the color of the building."</u>
