## Agenda Item #1- Call to Order

## a. Discussion on webpage with an action item for March meeting

CSO Alcantara requested commissioners ideas for what the webpage should have on it and it beat emails would be something they would want. Commissioner Zuniga stated he would like the beat emails. Commissioner Archuleta requested more resource links and see if it could be easier to find with a link back to the main police department site. Commissioner Zuniga also requested PAL applications to be put on line as well as information about how to donate to PAL. Commissioner De Los Reyes requested a beat map on the website. Commissioner Archuleta stated she wanted to contact the block captains and get feedback from them for items to add to the website.

### b. Antioch Crime Prevention Commission Vacancies Update

Lt. Marchoke stated that the Mayor was still deciding what to do as of two days prior to the Crime Prevention Commission meeting.

### c. Task Group Reports

**1. Publicity-** Commissioner Archuleta stated that her task force (Ho, Archuleta and De Los Reyes) had attended strategic planning meetings and had collected forty names interested in Neighborhood Watch. Also, 350 copies of the Neighborhood Watch brochure had been given to Alex Fuentes, a realtor, to give out with his newsletter. Commissioner De Los Reyes added that he had left brochures with the Church where they held the strategic planning meeting. Commissioner Archuleta also stated that she had registered on "hot coco" with a blog and has put up Neighborhood Watch information on it. Also, both De Los Reyes and Archuleta attended a UCBN meeting and got some interest.

**2. Recruitment**- Commissioner De Los Reyes made a motion to continue his action plan to the next meeting for a full commission. Commissioner Archuleta seconded the motion. Vote:

Commissioner De Los Reyes spoke with REACH director Mickie Marchetti. Mr. Marchetti gave a brief presentation on REACH. Mr. Marchetti also expressed an interest in becoming a block captain.

## **Commissioner De Los Reyes**

## **Commissioner Archuleta**

She reviewed the meeting with the block captains of both beat five and six and reported on their concerns.

- recommitting to their block captains
- review the legal procedure for the meetings
- review the limits of the commission's authority
- devote the first hour of the joint meeting to the block captains
- focus on the furtherance of neighborhood watch
- introduce the block captains at the quarterly joint meetings
- finish commissioner training
- find out about CPR training for the block captains as well as training them to do presentations
- make presentations to the community to get people to come to meetings : drugs, gangs, fraud, etc...

## b. Staff

## Lieutenant Marchoke

- Stated that the build out is coming along well and has a tentative completion date in April. The facility will be significantly larger and state of the art.
- CERT classes are from April 17<sup>th</sup> to May 22<sup>nd</sup> Tuesdays and there are about 20 people signed up for them that had found out about it via the Safety Faire. Antioch will be partnering with Oakley.
- Also the Church of Later Day Saints is holding a Safety Fair on April 14<sup>th</sup> 10 am to 2 pm and would like Neighborhood Watch to have a booth there.
- Coffee with the Cops on Saturday had 40-50 people at the Starbucks on Lone tree Way it has also been advertised more
- Lt. Marchoke will be running a Coffee with the Cops at the end of March or April and will be doing it with the Crime Prevention Commission
- At the strategic planning meetings there were 55 people and juvenile crime seems to be the biggest issue
- Lt. Marchoke spoke to the fact that press releases are sent to the media same day, but does not have control over whether or not they will publish it.
- PACT handles problem areas it is a 4 person team w/ a corporal. They handle high risk warrants, etc...
- The safety faire was down 18% and he plans to revitalize it, change it up and perhaps streamline it.
