# <u>Agenda Item #4</u> Public Comments – Forum for Public Comment of Items not on the Regular Agenda

Dallas Ranch area problems were discussed along with the concerns about incidents of an individual or individuals throwing items and breaking the windows of vehicles at the car dealerships along Auto Center Drive.

Mr. Lee brought up the idea of an anonymous tip line. He was urged to continue to suggest it although it had be earlier suggested and not yet implemented.

#### **Agenda Item #5** - Commission Staff Report

a. TV/DVD for Neighborhood Watch Activities

This item will be continued until Lt. Marchoke can report on it.

#### b. Commission Vacancies Update

Those applying for both of the vacancies should be interview in the near future by the Mayor and then his recommendations will be taken to the entire City Council for approval

#### c. Neighborhood Watch Beat Report

Chair Ho has asked each of the Commission members to report on the Block Captains within their assigned Beats. He reported on Beats 1 and 2 and stated how Neighborhood Watch does make a difference.

Commission Member Koch (Beat 3) reported 9 active block captains and their groups; 3 block captains have moved; and 3 couldn't be reached.

Commission Member Talavera (Beat 5) reported having 32 Block Captains with 3 inactive; 2 very active. There are plans to have a get together of all the block captains prior to the last quarterly meeting.

#### d. National Night Out

Secretary Friedrikson had available "Block Party" applications for those planning on blocking off a cul-de-sac or portion of a street.

#### e. Bear Ridge Issue

Mr. and Mrs. Dailey from the Bear Ridge area spoke to the Commission regarding the vandalism; car burglaries (including the placing vehicles on blocks and stripping them of wheels/rims) within their neighborhood. They also spoke about going to the City Council to ask for help and requesting more officers' presence in the area. The group have formed their own citizens' patrol in their neighborhood; they were reminded to be very careful and to only observe and report any activity to the police to handle.

Chair Ho admonished the importance of keeping in touch with the Block Captains to see what issues they are having in the areas. He would like to try this idea of contacting the Block Captains each month for the next few months and then re-evaluate the program.

#### f. Safety Summit

Chair Ho strongly urged the Commission get involved in the Safety Summit group which includes the City Council, and local citizens groups. They will discuss various problems within the city including code enforcement complaints.

Chair Ho made a motion, seconded by Commission Member Koch, to draft a letter to the City Council asking for the Antioch Police Crime Prevention Commission to be included in the Safety Summit.
