# <u>Agenda Item #4</u> Public Comments – Forum for Public Comment of Items not on the Regular Agenda

Members of the audience discussed various issues with the Commission/Staff. Some of the topics of discussion included: the need for more police presence at the crosswalk in front of the Social Services building on Leland; possession and/or shooting off illegal fireworks is a misdemeanor; kids from outside Antioch coming into Antioch schools; the times of the officers shifts and how many officers on each shift; how many officers on the street and how many officers vacancies at present; the need for more communication with the Neighborhood Watch groups and what is in the works to remedy this problem; how crime prevention tactics are hard to evaluate their effectiveness but do help; the use of a task force and special CHP computerized vehicles used to catch car thieves; the effective use of engravers to mark car rims etc. and Chair Ho will check into whether or not there are engravers available from the APD to loan out;

home with overgrown shrubbery/weeds etc can be reported to the fire department as well as code enforcement; the problem with multiple families living in single family homes;

Also discussed a problem rental home in the White Rock/Rock Spring area where the residents have friends over in the middle of the night and plays loud music. A new "problem home" unit has been assembled (includes a sergeant, corporal and two officers) to handle problem homes started last Monday. Also, at least one more Code Enforcement Officer is expected to be hired soon to help. Landlords need to be more responsible.
