Emil Stein wished all a Merry Christmas. He also conveyed to the Commission about reported breaking and entering as well as stolen vehicle problems in the W.7th/G Street area of town. Lt. Marchoke will look into the situation.

Vincent Ciccarello reported seeing some kids trying the door handles of cars in the Folsom/Wildhorse area.

Bob Miller relayed information regarding his Neighborhood Watch meeting on Puma Court and his encounter with a carload of kids.

Commission Vice-Chair/Neighborhood Watch Coordinator Beck provided a summary report of activities for the period of November 22, 2005 to December 19, 2005.

a. Commission

Commission Member Ho

- requested the Activities Committee report be placed on the January 23rd's meeting agenda.

Commission Member Beck

- stated what a blessing it is to have Lt. Marchoke as the police liaison. He also wished all a Merry Christmas.

Presenter Miller

- relayed to the Commission how he was instrumental in getting a coach fined (\$275) for always parking in the handicapped parking space.

b. Staff

Lt. Marchoke

- thanked Commission Member Beck for his work this past year; he also thanked Secretary Friedrikson for the decorations etc. for the potluck held prior to the meeting.
- updated the Commission about the recruitment of a new Commission member not happening until after the first of 2006.
- reminded the Commission that the all future meetings (until further notice) will be held at the City Council Chambers. The next meeting will be held on Monday, January 23rd.
- attended earthquake training in San Luis Obispo and our city is doing well.
- will be holding some Block Captains only meetings with Corporal Delavan for Beats 1 & 2 together; Beats 3 & 4 together; and Beat 6 by itself. These meetings will help train the Block Captains about some of the realities of police work.
- reminded the Commission about the new laws regarding driving with headlights whenever using windshield wipers.
- informed the Commission that Pocket Bikes can now be confiscated and that scooter riders need helmets but not a license.

- addressed issues regarding speeding problems on James Donlon and Lone Tree Way and other problem areas. He also stated that driving 21 miles over the speed limit disqualifies a person for traffic school and 26 miles over invokes a suspension of the license. A discussion regarding the use of red light cameras ensued.
