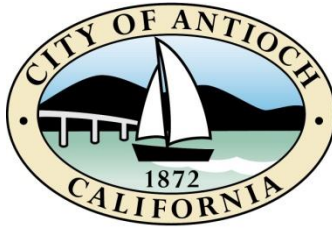

1. Playground Renovation at Chichibu, Jacobsen and Marchetti Parks:

The Commission reviewed multiple playground design options for Chichibu and Jacobsen Parks, and reviewed the single design for Marchetti Park. Staff, along with a representative from Miracle Play Systems, answered questions and highlighted the design elements of all the options. Members of the Commission requested color schemes that fit a more natural landscape instead of “neon or bright” colors.

1. Staff Communication

Public Works staff reported that picnic tables are being repaired and new tables installed at various parks throughout the City. Restroom repairs are underway at Williamson Ranch and Gentrytown Parks (subject to vandalism last year). There are new soccer goals at City Park and Jensen Grove Family Picnic Area is receiving new group BBQs. Recreation staff highlighted numerous programs for children; the Youth Employment Fair is this upcoming weekend. Scholarships are still available for youth of all ages; staff asks that Commissioners share this information. Season Passes for the 2019 Water Park season are available. The Spring/Summer Recreation Guide is in production and will be mailed mid-March. For the first time, the Summer Concert schedule has been established.

2. Commission Communication

Commissioners complimented the MLK Day of Service event and mentioned that Waldie Plaza looked very nice. Several Commissioners expressed interest in advancing activities that would increase visitors to the waterfront – it is a hidden gem. There was also a good amount of support voiced for the Antioch Historical Society and the Riverview Museum; Commissioners encouraged residents to visit. Members of the Commission are interested in following City news and projects such as the Amtrak Station Demolition and the evolution of Cannabis businesses, especially along Wilbur Avenue where the AY SC complex is located.

The Chair welcomed the new Commissioners and all members shared enthusiasm about working together for Antioch.
