Maintain the same parking; good to see no loss of parking spaces Water feature should be a small, spray park like feature to engage small children; if the cost is feasible. No pool-like water features (safety and risk) Maintenance costs must be incorporated into the planning and design Keep the existing building grades Adjust the views away from the Riverview Lodge and towards the natural river landscape Include security cameras Design the plaza and waterfront for safety of all users Review the railroad crossing area; make it safer Discuss the feasibility of restrooms; use, maintenance, vandalism, repair

### RECOMMENDED ACTION

It is recommended that the Parks and Recreation Commission review and approve a resolution supporting the designation of Antioch trail section as an addition to the great California Delta trail network.

# **STRATEGIC PURPOSE**

**Long Term Goal J: Parks and Recreation.** Provide outstanding facilities and programs for the community.

- Strategy J-1: Increase the use of the City's recreation facilities

Long Term Goal K: Public Works & Engineering.

- Strategy K-1: Ensure well maintained public facilities, rights-of-ways and parks

### DISCUSSION

The California Legislature approved legislation in 2006 mandating the Delta Protection Commission establish "The Great California Delta Trail," which is intended to be a continuous bicycling, hiking and water trail in the Sacramento-San Joaquin Delta region. The trail will link the San Francisco Bay Trail with the Sacramento River Trail.

The Commission is considering approximately three miles of trails within the City of Antioch as a Delta Trail segment. This segment is also recognized as the Delta Trail by East Bay Regional Park District. The Antioch segment is part of the 23 miles of trails proposed from Point Edith to Big Break Regional Shoreline.

A Delta Trail designation could make future expansions of trail segments more competitive for state and federal grant funding

# SUPPORTING DESIGNATION OF ANTIOCH TRAIL AS AN ADDITION TO THE GREAT CALIFORNIA DELTA TRAIL NETWORK

WHEREAS, In 2006, Senate Bill 1556 (Torlakson) mandated that the Delta Protection Commission (Commission) adopt a plan and implementation program for a continuous recreational corridor trail network linking the San Francisco Bay Trail system to the planned Sacramento River trails in Yolo and Sacramento Counties; and

WHEREAS, the East Bay Regional Park District's (District) 2013 Master Plan identifies a proposed 23-mile alignment of the Great California Delta Trail from the Benicia Bridge to the Antioch Bridge; and

WHEREAS, an approximate 3-mile segment of the District's proposed Great Delta Trail alignment traverses through the City of Antioch (Antioch), along the shoreline of the San Joaquin River; and

WHEREAS, the Commission staff propose to officially designate the District's Great California Delta Trail alignment as an addition to the Commission's Great California Delta Trail system; and

WHEREAS, Antioch currently benefits from several regional west/east trails within its boundaries and recognizes the benefit of collaborative partnerships in trail development; and

WHEREAS, this designation is not to be construed as granting legal authority to the Commission over property or action by the City nor the assumption of any liability by the Commission;

NOW THEREFORE, BE IT RESOLVED, that the Antioch Parks and Recreation Commission supports the designation of the East Bay Regional Park District's future Great California Delta Trail alignment, as a segment of the Great California Delta Trail system.
