RECOMMENDED ACTION

It is recommended that the Parks and Recreation Commission appoint 2-3 members of the Commission to serve on the Civic Enhancement Grant Ad-Hoc Committee.

FISCAL IMPACT

This action has no direct fiscal impact. The budget allocation for the Civic Enhancement Grant Program is \$50,000 for Fiscal Year 2022-2023.

DISCUSSION

The Fiscal Year 21-23 Budget approved by City Council includes the continuation of the Civic Enhance Grants Program to support community events and improvement projects that originate with nonprofit organizations in Antioch. It is the City's goal to assist nonprofit organizations by creating and implementing a grant program to fund civic events and enhancement projects in an objective and efficient manner. The City Council directed the Parks and Recreation Commission to make final recommendations for grant approval to the City Council.

Applications for the grant program are anticipated to be available in December and due in January. The Ad-Hoc Committee review of grant applications will take place in early February with review and recommendation by the Commission at the February meeting. Final approval by City Council is anticipated in March.
