### 6. BUSINESS

## A. INTERIM RE-ORGANIZATION OF THE PARKS DEPARTMENT

Deputy Director Recreation Department (DDRD) Sanderson introduced newly appointed Director of Public Works Ron Bernal and Interim Superintendent Parks Mike Bechtholdt.

Director of Public Works (DPW) Bernal introduced himself and explained his duties. He added that there is now a Public Works link on the City's website for the public to address any concerns or comments.
