#### VI. BUSINESS

## A. SOCCER FIELD MAINTENANCE ACTIVITIES - VERBAL UPDATE - F. PALMERI

Park Superintendent Palmeri stated that this issue was placed on the agenda stemming from concerns from students regarding the present condition of the City's playfields. Presently all playfields are reviewed monthly by City Staff and a report was recently submitted to the City Council. Recently there has been damage from adult leagues and Staff has inspected and is working on repairing the fields. The infields should be repaired by March 21 and he requested that the Commission report any damaged fields to Staff.

# B. IMPACTS OF MINIMUM WAGE INCREASES – STAFF REPORT – D. SANDERSON

Deputy Director of Leisure Services (DDLS) Sanderson distributed and reviewed a handout entitled "Minimum Wage Increate Total Visits Impacts" and further elaborated on the Staff Report dated March 2, 2007. He noted that he would return to the Commission in October with a fee impact proposal, as well as what the impacts would be to operate the Water Park at its current level.

- > Staff is currently attending the Parks & Recreation Society Conference being held this week in Sacramento
- > A Community Center update will be coming to the Commission in the near future
- > The swimming pool dome will come down in mid-April

#### **PUBLIC COMMENTS:**

Wayne Steffen, Project Manager for the City Park Community Built Playground, introduced the volunteers that were in the audience and provided a brief introduction of the construction process of the playground.

Michael Cohen, Leather and Associates, Inc., provided a power point presentation that depicted the conceptual design of the Community Playground at City Park.

Through discussions, it was the consensus of the Commission to add two additional benches in the older section of the park. Mr. Steffen requested that the Commission support a Children's Committee to name the playground, and it was the consensus of the Commission to proceed with a contest and support a committee of the same.
