**A. Prewett Park Community Eastern Parking Lot Landscape Re-Design Presentation**

He presented a Power Point Presentation that depicted the two (2) conceptual eastern parking lot landscape re-design schematics. Mr. Karste further spoke to funding issues and Deputy Director Recreation Department (DDRD) Sanderson added information pertaining to parking, ADA requirements, traffic and circulation patterns.

Aditya Advani, Project Architect, further presented information pertaining to the conceptual design of the eastern parking lot re-design, per the Power Point presentation.
