**A. PREWETT FAMILY PARK COMMUNITY CENTER & LIBRARY UPDATE -  
VERBAL REPORT, L. KARSTE**

Lonnie Karste, Project Manager Prewett Family Park and Civic Center Project, provided a Power Point presentation on the Prewett Family Park Community Center & Library Update. He also referred to a conceptual drawing and wall map.

Mr. Karste stated that the Commission will be advocates for this recreational facility and in the future would be bringing forward to the Commission design concepts, final schematics and revenue projections for this project. He would also like the Commission to participate in the start of the approval process and noted that one or two Commissioners' would be serving on a subcommittee through 2010 to move this project forward.
