PUBLIC COMMENTS

NEW PUBLIC HEARING

1. **HFD Day Program & Fence Variance (UP-21-07, V-21-02)** – Ivan Nevarez requests approval of a use permit to occupy an existing 5,270 square foot commercial space to operate an adult day program to serve up to 60 individuals and approval of a variance to construct a six foot high fence in the required front yard setback. This project has been determined to be exempt from the California Environmental Quality Act (CEQA). The project is located at 1130 A Street (APN 067-092-027).

RECOMMENDATION(S):

It is recommended that the Zoning Administrator APPROVE a use permit allowing an adult day program at 1130 A Street and variance allowing a six-foot-tall fence to be placed in the front yard setback, subject to the conditions contained in the attached resolution.

NEW ITEM(S)

2. **Horizon at Cielo (AR-21-15)** – Century Communities requests design review approval for a new home plan for use in tracts 9561 and 9483 for the Cielo at Sand Creek project.

RECOMMENDATION(S):

Staff recommends that the Zoning Administrator approve the Design Review application subject to the conditions contained in the attached resolution.
