In February of 2021, the Antioch City Council convened a special meeting to consider several dimensions of Police Reform. On April 13, 2021, the City Council then established the Police Reform Standing Committee of the Whole City Council, subsequently renamed the Police Oversight Standing Committee.

The City of Antioch Police Oversight Standing Committee is an entity intended to operate on an interim basis prior to the formation of an independent review body. Responsibilities of the Police Oversight Standing Committee are defined by Antioch City Council Resolution No. 2021/67 and are described as follows:

- 1) To review and recommend modifications to Antioch Police Department policy that integrate community input and expertise.
- 2) To review and audit on duty police officer complaints and the resolution of said complaints.
- 3) To review Antioch Police Department use of force policies and provide community updates.
- 4) To guide the future formation of an Antioch Police Department Civilian Oversight Commission for On Duty Officer Complaints.

Notice of Opportunity to Address the Standing Committee

Members of the public wishing to provide public comment may do so in the following ways:

- 1) <u>In Person</u>. Fill out a Speaker Request Form, available near the entrance doors, and place in the Speaker Card Tray near the City Clerk before the City Council Meeting begins.

Policy of the Antioch Police Department

 The Antioch Police Department takes seriously all complaints regarding the service provided by the Department and the conduct of its members.

• It is also the policy of this department to ensure that the community can report misconduct without concern for reprisal or retaliation.

Personnel Complaint Categories

Internal Investigation

 Alleged misconduct or improper job performance of any employee of the Police Department that is reported by a member of the Police Department.

Citizen Complaint

 Alleged misconduct or improper job performance of any employee of the Police Department that is reported by a member of the public.

Findings

- <u>Unfounded</u>: The investigation clearly established the allegation was not true.
- **Exonerated**: The acts which were the basis of the complaint occurred, but were justified, lawful, and proper.
- <u>Sustained</u>: The investigation disclosed sufficient evidence to clearly prove the allegation made in the complaint.
- **Not Sustained**: The investigation disclosed insufficient evidence to clearly prove or disprove the allegation.
- **No Finding**: The complainant failed to disclose promised information to further the complaint.
- Withdrawn: The complainant affirmatively indicates the desire to withdraw their complaint.

Internal Investigation

- Any member (sworn or non-sworn) of the Police
 Department can initiate an allegation of misconduct or improper job performance of another employee.
- The allegation is documented in a memorandum and forwarded through the chain of command.
- The Chief of Police determines who will have responsibility over the investigation. (immediate supervisor, internal affairs, contracted outside investigator)
- The completed investigation is reviewed through the chain of command. The Chief of Police determines the final disposition, finding(s), and any disciplinary action.

Internal Investigation Laws

Government Code 3303

- Public Safety Officers Procedural Bill Of Rights (POBR).
- AB 301 Rights and Obligations

Government Code 3304

 Agency has 1-year to complete the investigation and initiate discipline from the date the department became aware of the allegation.

Lybarger Admonition.

• An order to answer questions and cooperate during an administrative investigation. Refusal results in discipline. Statements are not admissible in a criminal proceeding if the allegations are criminal in nature.

Citizen Complaint

 Initiated by any member of the public alleging misconduct or improper job performance that, if true, would constitute a violation of Department Policy, Federal Law, or State Law.

 All complaints are courteously accepted by any department member and promptly given to the appropriate supervisor.

Availability of Complaint Forms

- Personnel complaint forms are accessible to the public and clearly visible in the front lobby of the Antioch Police Department.
- Personnel complaint forms are available on the Antioch Police Department website and can be submitted electronically.
- The website also contains a direct phone number and email address to the Internal Affairs Unit.

Citizen Complaint Investigation

• Formal complaint is routed through the office of the Chief of Police.

 The complaint is entered in a computer database and assigned a case number.

- Depending on the nature of the allegation, the investigation will be assigned to either:
 - Supervisor of the employee
 - Internal Affairs Unit
 - Contracted Outside Investigator

Citizen Complaint Investigation

- A thorough and detailed investigation is conducted which includes evidence collection and interviews.
- The investigation must be completed within one year of the date the Police Department became aware of the allegation. (Government Code 3304).
- The completed investigation is forwarded through the chain of command.
- The Chief of Police confirms the final disposition, findings of the case, and issues corrective action.

Post Investigation

- Per California Penal Code 832.7(e)
 - The Police Department shall ensure that the complainant is provided written notification of the disposition within 30 days of the final disposition.

 The investigation is retained pursuant to the Antioch Police Department Records Retention Policy.

Transparency

SB 1421

- Requires public disclosure of investigations with sustained findings of:
 - Dishonesty
 - Perjury
 - Use of force that results in great bodily injury or death
 - Sexual assault
 - Discharge of a firearm at a person.

Transparency

• SB 16

- Requires public disclosure of investigations with sustained findings of:
 - Unreasonable or Excessive use of force
 - Failing to intervene against another officer using excessive or unreasonable force
 - Unlawful arrest
 - Unlawful searches

Transparency

• In our commitment to transparency the Antioch Police Department uploads all applicable SB 1421 and SB 16 records to our NextRequest portal allowing unfettered access to the public to view these records without making a request.
