#### 1. APPROVAL OF SALES TAX CITIZENS' OVERSIGHT COMMITTEE MEETING MINUTES OF FEBRUARY 23, 2023

On motion by Committee Member Mundhenk, seconded by Committee Member Raulston the Sales Tax Citizens' Oversight Committee members present unanimously approved the Minutes of February 23, 2023.

### 2. MEASURE W FINANCIAL INFORMATION FOR FISCAL YEAR ENDED JUNE 30, 2023

On motion by Committee Member Odom, seconded by Committee Member Raulston the Sales Tax Citizens' Oversight Committee members present unanimously received and filed the report.

Finance Director Merchant presented the staff report dated January 25, 2024.

In response to Chairperson Jones, Finance Director Merchant explained that the Police Department FY23 Actual summary showed \$19M as revenue and \$50M in expenditures. She clarified that the remainder of revenue came from the General Fund, which consisted primarily of property and sales tax. She commented that Measure W paid for all expenditures for Youth

Network Services. She reported Youth Network Services was managed by Youth Services Manager Cabral and would be the contact for financial/program information for that division. She stated she would inform the Department Heads that Chairperson Jones would be contacting them regarding information for the Sales Tax Citizens' Oversight Committee annual report.

Chairperson Jones questioned if there was data with regards to new Antioch Police Department technology.

Finance Director Merchant responded that the data provided this evening was related to last fiscal year and she did not recall if that technology was in place prior to June 2023.

Chairperson Jones stated she would be following up with the Antioch Police Department regarding the intended use of their new technology.

In response to Committee Member Odom, Finance Director Merchant explained that the encumbrances were purchase orders for a contract of goods/services. With regard to the Statement of District Tax Distribution, Finance Director Merchant explained that the current advance was based on an estimate of what they would collect and in September they would do a true-up.

#### 3. ANNUAL REPORT FROM THE SALES TAX CITIZENS' OVERSIGHT COMMITTEE TO THE ANTIOCH CITY COUNCIL

Finance Director Merchant presented the staff report dated January 25, 2024, recommending the Sales Tax Citizens' Oversight Committee discuss and begin the draft report to the Antioch City Council.

Committee Member Odom stated she believed last year's report had been very informative and important.

Following discussion, the Sales Tax Citizens' Oversight Committee agreed to the following:

- The completed report would be provided to staff no later than March 6, 2024, for a presentation to Council on March 12, 2024
- > The subcommittee would consist of Chairperson Jones and Committee Member Odom
- The Sales Tax Citizens' Oversight Committee would schedule a meeting on February 29, 2024, to review, discuss and finalize the draft report
- > The report would be formatted similar to last year and include updated data from this year
- > Chairperson Jones would contact department heads to retrieve this year's data
- Chairperson Jones would contact Committee Member Odom to schedule a date for the subcommittee meeting to draft the preliminary report

Finance Director Merchant stated she would confirm the location of the February 29, 2024, Sales Tax Citizens' Oversight Committee meeting with the members once she had the information.

In response to Committee Member Raulston, Finance Director Merchant explained the Antioch Police Department cadette program. She confirmed that the only part of the Public Safety and Community Resources Department funded by Measure W was Youth Network Services. She stated she believed more services for the Public Safety and Community Resources Department would be paid for with Measure W in the next fiscal year. She noted the Council directed that the percentage allocations be changed for the two-year budget cycle.

Chairperson Jones requested Finance Director Merchant send her the percentage allocations for Measure W.

Committee Member Raulston reported that the County was currently counting the unhoused which would determine how much funding to ask for from the state.

Finance Director Merchant stated that she did not believe the city contributed funds towards counting the unhoused. She reported that the City had received some grant money, and the remainder of unhoused services was funded through the general fund. She noted that could change next year when allocations changed.




