RECREATION UPDATES

- Last week, the Spring Recreation Guide landed in all Antioch resident mailboxes!
 This new and updated edition features information on job opportunities, spring aquatics, special events, a summer camp preview section and many new activities.
 The layout and design continues to be evaluated and improved with each issue.

- Program proposals were completed for "First Five Contra Costa" spring programming. Activities include Tot Soccer and Swim Lessons.
- The Youth Scholarship/Fee Assistance program has awarded 100% (\$17,000.00) of the funds to qualifying families. Funding was provided by the City of Antioch CDBG and HUD programs and is based solely on need.
- On Monday, the City's glass vendor replaced a window at the Antioch Water Park that was shattered by vandals.
- On Tuesday, The City's electrical contractor installed an additional emergency backup light in the Nick Rodriguez Community Center Theatre. This light will ensure a safe evacuation of the theatre in the event of a power outage or emergency.
- On Wednesday, Maintenance staff evaluated the exterior lighting at the Nick Rodriguez Community Center. Repairs and upgrades will be scheduled in the coming weeks.
- On Thursday, The City's plumbing contractor completed preliminary work for new, water efficient urinals at the Antioch Water Park. Final work will be completed after City staff installs sheet rock and tile.
- Last week, staff prepared for the 2016 opening of the Worth Shaw Sports Complex concession stand. The concession stand operations are seasonal and are coordinated with the tournaments scheduled throughout the year.
- Antioch Water Park season passes are now available on-line for only \$50 per person. Lock in your discounted rate now and BE Cool By THE Pool in 2016!
- Last week, staff continued interviewing for the seasonal Water Park Manager positions. Interviews for all other seasonal positions at the Water Park are being scheduled as applications arrive!
- On Tuesday, staff attended an ActiveNet Training to learn how to better utilize the current registration, point of sale, and facility booking software used by the Recreation Department.
- On Wednesday, staff began to develop a marketing calendar for complement the Recreation Guide, as well as schedule dates for flyers to go to schools, emails blasts to go out to the community, and reminders to be sent for promoting programs and events.
- Last week, staff initiated the design for the 2016 Water Park brochure and informational map to support guests when they are planning their event or party!
- On Friday, staff assisted with the installation of the "Black History Month Exhibit" at the Nick Rodriguez Community Center. The exhibit is a special collaboration between Rua'h Outreach Ministries and the Arts and Cultural Foundation of Antioch, and will be open for public viewing through February 20.

Senior Center Services

Environmental Resources:

Environmental Enforcement: Jan 27-Feb 3: There were 22 actions taken this week. Staff is addressing previously abated homes that have not reestablished service and a new batch from Republic Services.

CDBG:

- Monitoring by Antioch and other Consortium members is underway and will continue.

Housing:

Database construction almost complete.

Homeless:

- The Homeless Point in Time Count has concluded and data is being entered into the Homeless Information Management System.
- The next General Meeting of the Contra Costa Homeless Continuum of Care is April 15, 2016, and all are invited. We will continue with panel presentations about the criminal justice system and homeless persons. Meetings are held in the ZA room at 30 Muir Road, Martinez from 10 am -12 pm.

DROUGHT UPDATES:

Antioch Water Customers used 11.21% less than January 2013. This takes our cumulative total to 30.72 since last summer. We must maintain a minimum reduction of 28% cumulatively in order to stay in compliance with the State's drought regulations. These regulations were set to expire in February, however California is still experiencing severe drought despite recent rains. The State Water Resources Control Board (State Water Board) adopted on February 3, 2016, an extended and revised emergency

regulation to ensure that urban water conservation continues in 2016. The regulation extends restrictions on urban water use through October 2016.

Staff is working in partnership with Contra Costa Water District to offer this free workshop to residents interested in learning more about rebate programs and design assistance for relandscaping. Irrigation Repairs and Service:

- Park Water Reductions: ALL City Parks are in Rain Shutdown.
- Chaparral Park: Water shut down, awaits new backflow.
- Chichibu Park: The main is shut down, awaits repairs.
- Williamson Ranch: The "C" main backflow is currently shut down, pending replacement of valve C-17. "A" & "B" backflows remain charged. All irrigation controllers remain in rain shutdown.
- Prewett Ranch Dr. Replaced 1 valve and removed 1 valve.
- Deer Valley Rd. Repaired 2 inch irrigation mainline.
- Gentrytown Dr. Rebuilt 1 valve.
- Wildhorse Rd. Repaired 4 sprinklers.
- 3rd & I St. Shut off faulty irrigation controller.
- James Donlon Blvd. 1 sprinkler repaired.
- Dallas Ranch Rd. Reprogrammed irrigation controller.
- Davison Dr. Capped 4 sprinklers.
- Country Hills Dr. Rebuilt 1 valve.

PUBLIC WORKS UPDATES

Administration

- Due to the current and predicted El Niño rains, Public Works has procured extra sand bags and sand, as well as ensuring staff is ready for action 24/7. The City website will have additional information about what the City is doing and how the community can better prepare for the possibility of a severe winter.
- In spite of the much needed recent rains, the State has communicated that the drought is still ongoing and mandatory water conservation has been extended to October 2106. The City of Antioch is being required to reduce its 2015-2016 water usage by 28% in using 2013 as the base year. Outdoor water conservation will be the primary focus of the City's program, as well as fines for wasteful practices as identified in the Water Conservation Resolution adopted by the City Council on May 12th. All Antioch customers were mailed a letter explaining the program and prohibitions, as well as 2013 monthly water usage. Examples of prohibitions are: three day per week residential outdoor watering, no watering between the hours of 9:00 a.m. and 5:00 p.m., shut off nozzles required on all hoses, and drinking water available only upon request at restaurants. Contra Costa Water District has

incentives, such as residential high-efficiency clothes washer rebates, water-efficient landscape rebates and smart sprinkler timer rebates. More information on water conservation programs and ideas on how to conserve water can be found at www.ccwater.com or www.antiochwater.com. Customers who are not in compliance with drought restrictions can be reported to the Antioch Drought Hotline at (925) 779-6140.

Engineering & Development Services

- Almondridge East Subdivision 8880, an 81-unit single family home development by KB Homes, located between East 18th Street and Oakley Road, east of Phillips Lane and west of the State Highway 160: Staff is reviewing plot plans for ongoing new home construction. Staff provided a punch list for offsite improvement bond reduction.
- Buchanan Crossings Shopping Center, a 103,139 square foot commercial center on a 13.5-acre site located at the northwest corner of Somersville Road and Buchanan Road: CVS and Grocery Outlet stores are open for business and other building pads are in development and planning stages. Environmental clearances and USBR permitting requirements for the Phase 2 development are in progress. Staff is processing a request for reimbursement for Somersville Road widening.
- City Sports Club, located at 5001 Lone Tree Way: Building and parking lot construction is nearing completion.
- City-owned cell sites, various locations: Staff is performing site visits and review of land leases, 100% construction drawings, consent letters, photo-sims and related technical reports and materials for equipment upgrades.
 - DeNova Homes Mixed Use Project at Hillcrest Ave./Wildflower Dr.: Application for mixed use project consisting of 9.5 acres commercial, 8 acres multi-family, and 2.2 acres single family development. The Planning Commission discussed DeNova's PDP-15-01 application on August 19th. The developer has been reaching out to the neighborhood for input into the project. An application with an updated site plan is anticipated later in February or March.
- Laurel Ranch, a 186-unit housing development by Richland Communities, located at the eastern terminus of existing Laurel Road and west of Highway 4: Staff is reviewing the final development plan and preparing project conditions of approval. Staff is working with the developer to reduce illegal trespassing on the unimproved site.
- Nelson Ranch Subdivision 6893, end of Wildhorse Road: Staff will perform site inspection in response to developer's request for warranty bond release.
- Park Ridge Phase I, a 123-unit housing development by Davidon Homes, located west of Canada Valley Road and east of Highway 4: Staff is processing the 4th submittal map and plan checks.
- Taco Bell, 1706 'A' Street: The new restaurant is now open for business. Staff is working with developer to restrict left-turns into business from "A" Street.
- SR4 (Segment 2) Contra Loma Blvd. Interchange/'G' Street Overcrossing Project: The project has been presented to State for acceptance. The eastbound Contra

- Loma Blvd. on-ramp will remain closed temporarily for SR4 mainline construction. Caltrans is completing punch list items on City property which includes extending the merge on Fitzuren Road.
- SR4 (Segment 3A) 'A' Street/Lone Tree Way Interchange, Cavallo Road/Garrow Drive Undercrossing Project: Work continues on the 'A' St./Lone Tree Way and Cavallo Road Overcrossings and the new Sunset Drive from Bryan Avenue to "A" Street extension. Pedestrians and motorists are advised to exercise caution while travelling through these areas.
- SR4 (Segment 3B) Hillcrest Avenue Interchange and BART Tunnel Project: Work continues on the Hillcrest Avenue Bridge widening, the Pedestrian Overcrossing (POC) and the Maintenance of Works (MOW) Tunnel. The new Slatten Ranch Road westbound (WB) Loop on-ramp is open to traffic and the Hillcrest WB onramp is temporarily closed. New signage is being added to improve the flow for the northbound to eastbound right turn that backs up in the morning commute. Pedestrians and motorists are advised to observe "SR4 WB" detour signs and exercise caution while travelling through this area.
- BART Parking Lot and Maintenance Facility: Staff approved the design for a
 proposed 12" sanitary sewer main from the new Maintenance Facility, north of the
 S.P.R.R. railroad line to the southerly extension of Willow Avenue and is reviewing
 grant deeds for public easement dedications. Staff returned comments to BART's
 Ownership and Maintenance of Utilities Agreement for storm drainage
 improvements.
- The Vineyards at Sand Creek, a proposed 641 unit housing development located on Sand Creek Road between Heidorn Ranch Road and Hillcrest Avenue: The tentative map has been approved by Planning Commission and is on the February 9th City Council Agenda.
- Aviano, an approved 533 unit housing development located west of the current terminus of Hillcrest Avenue, east and north of Dozier-Libby Medical High School. Staff is working with developer on park extension. First phase of construction documents has been submitted for 1st review.

Capital Improvements Division

- Water Main Replacement at Various Locations: D&D Pipelines is installing the new pressure regulating station on Hillcrest Avenue between Arzate Lane and East 18th Street. Pressure and bacteria testing is being performed on recently installed water facilities on Sunset Drive and West Lake Court.
- West Antioch Creek Channel Improvements: Contra Costa County Public Works
 Real Property Division is negotiating terms with the State of California's 23rd District
 Agricultural Association pertaining to land acquisitions within the footprint of the
 Contra Costa Fairgrounds. Staff is scheduled to meet with the U.S. Army Corps of
 Engineers and U.S. Fish and Wildlife to discuss federal permitting in mid-February.
 AT&T has submitted an encroachment permit for the relocation of existing facilities
 within the roadway area.

- Fulton Shipyard Road Sewage Drainage Station: JD Partners has constructed the base of the new facility.
- Water Treatment Plant Disinfection Improvements: The 30-day review period of the project's CEQA document began February 3rd.
- Cathodic Protection Assessment: JDH Corrosion Consultants, Inc. continues to field test existing cathodically protected water facilities throughout the City.
- Water Treatment Plant Electrical Upgrades: TJC and Associates is analyzing the existing electrical facilities at the Water Treatment Plant.
- Country Hills Drive and Vista Grande Drive Water Main Replacement: Construction bids were publically opened on January 12, 2016. The lowest responsive bid was received from A-S Pipelines, Inc., in the amount of \$983,690. The award of this project is scheduled to be considered at the February 9th City Council meeting.
- 2015 Transportation Development Act (TDA) Grant: JD Partners completed the construction of 27 new curb ramps along Bluerock Drive and West Tregallas Road and is working on new ramps along San Joaquin Avenue. The City Council will consider the final acceptance of the project at the February 23rd meeting.
- Transportation Impact Fee Study: Staff is working with the consultant, EPS, to finalize the land use forecasts and the transportation improvement list and network to be used in the traffic model. The final draft Fee Study will be presented to the City Council for public review and comments in May 2016.
- Prewett Water Park Improvements: RHAA is under contract for the design of the
 final improvements at Prewett Water Park. Staff received the project permit
 approvals from the County Health Department and the Fire Department. RHAA is
 working on the final design plans and specifications of the spray ground and the
 playground facility. The bid package for both projects is expected to be out for bid
 in February 2016; construction is expected to be completed by September 2016.
- North East Annexation Infrastructure Improvements: Staff is drafting a Request for Proposal for consulting services to provide engineering services and to prepare preliminary plans, estimates and studies for the planning and the design of infrastructure improvements needed to serve the newly annexed Area 1 and 2B.
- Pavement Management Technical Assistance Program (P-TAP) Grant: The City was awarded a grant from MTC for consulting services to assist the City in implementing and maintaining the annual Pavement Management Program System by inspecting the pavement conditions of arterial, collector and residential streets and provide us with design recommendations for pavement rehabilitation projects.
- 2016 CalRecycle Rubberized Pavement Grant: CalRecycle has issued the Notice of Funding Availability for the Rubberized Pavement Grant Program. Staff has submitted a grant application for \$250,000 for the 2016 Pavement Management Program, which included potential streets to receive Rubberized Cape Seal treatments.
- 2016 Transportation Development Act (TDA) Grant: MTC is soliciting applications for 2016/2017 TDA grants for Pedestrian and Bicyclist improvement projects. The City Council approved a resolution of support for the \$130,000 grant funding application at the January 12th meeting; the Parks and Recreation Commission

- approved a resolution of support at their January 21st meeting. The grant application includes funding for curb ramp upgrades to meet ADA requirements, installation of new sidewalks at needed locations and for bicyclist improvements along Cavallo Road, "A" Street, "G" Street, Putnam Street and Carpinteria Drive.
- Traffic Signal Improvements at Wild Horse Road/Folsom Drive and W. Tenth Street/L Street: Staff is preparing plans and specifications for a new traffic signal at Wild Horse Road/Folsom Drive and a traffic signal modification at W. Tenth Street/L Street. The bid package is expected to be out for bid in April 2016.
- Staff is received 13 statements of qualifications and proposals from traffic
 engineers, civil engineers, and landscape architects/planners for on-call services
 and the L Street Path to Transit Corridor. Staff will be reviewing the documents and
 determine if interviews are necessary.

Water Treatment Plant

- Cleaned Solar Bees out on the municipal reservoir. Solar Bees circulate the water in the reservoir; cleaning the Solar Bees prevents weeds from restricting the circulation. Also cleaned the staff gage on the tower. This is reoccurring and ongoing.
- Worked in "A" plant's basin repairing drive gears, tightening flight chains and greasing all drive units.
- Cleaned Act-Flow chemical feed pump suction lines and cleaned the settlers in the units.
- Repaired the ASCO valves on the control valves at Lone Tree pump station.

Water Distribution

- Water crews had 233 stops for water service including disconnections.
- Water crews had a total of 95 USA tickets completed for utility location.
- Meter reading has started for the month of February and is on schedule.
- There were four drought notices issued this week.
- Water crews continue to monitor water meters, conservation and usage at all City buildings and parks.
- Water Distribution personnel continue to respond to drought hotline inquiries.
- Water field techs responded to customer calls regarding water related issues city wide.
- Water crews replaced a 6" meter and backflow on Lone Tree Way.
- Water crews attended GPS Training.
- Water crews repaired two 6" main line valves on W. Tregallas Rd.
- Water crews repaired two large main line valves on El Rey St.
- Water crews performed preventative maintenance on several main line valves from the Water Treatment Plant.
- Central Stores staff removed graffiti and discarded debris from Amtrak platform.
- Central Stores staff removed graffiti and household debris from Fulton Shipyard Rd. boat ramp area.

 Central Stores issued 153 line items from inventory to various divisions and filled 18 non-stock requests.

- Tree Removal Permits: A tree removal permit was issued for 43 West 17th St.
- Irrigation: Repaired 16 irrigation leaks on City property.

- Roadside Spraying: Lone Tree Wy., Wild Horse Rd., August Way school pathway, Mesa Ridge Trail, and Indian Hills Trail.

Public Works Operations – Streets Maintenance

- Graffiti Abatement: Removed graffiti from City property in numerous areas.
- Signs: Replaced 26 existing signs due to poor reflectivity.
- Debris: Picked up four yards of debris in the City right of way.
- Potholes: Filled 129 potholes.
- Parks Division: Weather permitting, crews continue to assist the Parks Division with their annual pre-emergent weed spraying.

Public Works Maintenance Operations – Collections Division

- Calls for Sewer Service: Received and responded to 11 calls for service from the public. Responding crews televised 350 linear feet of public sewer laterals connecting to the City's sewer system.
- Sewer Mains: Daily preventative maintenance performed on over 22,400 linear feet of sewer main lines.
- Quarterly Sewer Main Cleaning: The route schedule is under review to increase inspection frequency of identified 'hot spots' and integrate a proactive preventative cleaning schedule for the 'hot spots'.
- Sewer Lateral Maintenance Program (SLMP): Crews repaired four laterals that were severely damaged requiring immediate repair. Crews televised ten laterals.
- Manhole Inspection Program: Crews inspected 95 manholes. Manholes are inspected for loose lids, debris, locking mechanisms, and status of infrastructure for future maintenance and rehabilitation. We are updating the program and processes for integration in our computerized maintenance management system.

- Sanitary Sewer Overflow (SSO) Reduction Program: Staff is working on formal inspection criteria to inspect manholes in rural areas. The use of "SMART Manholes" in strategic areas will be utilized that will alert leadership staff within the division of potential SSOs. This program will also address the need for locking mechanisms.
- Closed Caption Televising (CCTV): Crews televised 8,195 feet of sewer main lines.
 The CCTV Preventative Maintenance crew inspects sewer mains to identify the condition and causes of blockages and SSOs.
- National Pollutant Discharge Elimination System (NPDES): Crews removed 12 yards of trash and debris from various creeks and channels. Inspected and cleaned two spillways with three yards of debris removed from storm trash racks. Inspected and cleaned 1,000 linear feet and removed 15 yards of debris from v-ditches. Cleaned up seven yards of debris from a homeless encampment and one yard of illegal dumping. These activities ensure the City meets the Federal Clean Water Act requirements of municipalities discharging storm water into waterways.

- Preventative Maintenance: Ten services on City vehicles as scheduled.
- Unscheduled Repairs: 46 unscheduled, necessary repairs to City vehicles.

POLICE DEPARTMENT UPDATES

A press release was issued today providing the following information:

On 2/3/16 at approximately 8:20 PM a 37 year old male walked out of an area hospital against doctor's orders after being admitted the day before. The hospital notified the Antioch Police Department. Officers responded and searched for the subject who was wanted on a parolee at large warrant and has a long history of violent crimes and drug offenses. The male was not located at that time.

On 2/5/16 at approximately 3:12 AM an officer checking an occupied vehicle at the east end of E. 6th Street found the parolee and a friend sleeping in the vehicle. While attempting to take the parolee into custody he fought violently with officers. Once the officers were able to restrain him, an ambulance was summoned to the scene to treat him for injuries sustained during the fight with officers. The 37 year old male was transported to an area hospital and later pronounced deceased. The friend in the vehicle did not get involved in the confrontation and is cooperating with the police. Because this is considered an in custody death, the county protocol was invoked. The Contra Costa County District Attorney's Office, the Contra Costa County Crime Lab and the Antioch Police Department will be conducting an investigation into the facts surrounding this incident. No further information will be released at this time regarding the investigation.

- On 2/4/16 at 4:22 am, the victim was heading to his car to go to work in the 2000 block of Glenwood Dr when a tall thin male approached him and brandished a dark colored pistol demanding money. The victim ran from the suspect, who in turn fled northbound on Woodland Drive. The suspect was not located and there was no loss.
- On 2/4/16 at 12:51 am, the victim was stopped on Deer Valley Road at Rocky Point
 Drive for the red light when an old red Honda pulled in front of her and stopped. The
 occupants got out and one was armed with a hammer. They forced the victim from

- On 1/28/16 at 7:51 pm, officers were dispatched to a local hospital for a report of a subject with a gunshot wound to the leg. Upon arrival they discovered victim was actually shot twice, once in the stomach, once in the inner thigh and was pistol whipped. The victim explained that he was leaving an address on W 14th St and was approached by an unknown male who was holding a gun. The male pointed the gun at the victim and demanded his money. The victim pushed the gun down and in doing so, the male shot him in the leg. A struggle began between the two and the victim was shot once more in the stomach. After the shooting, the suspect ran off. Officers responded to the scene and located blood in the street consistent with the victim's statements. The case is still under investigation.
- On 1/28/15 at 9:53 am, officers Hiles saw 22 year old James McCullar riding a 50cc dirt bike on the street without a helmet on Wilbur Av near Cavallo Rd. They attempted a traffic stop on McCullar and he failed to yield and a short slow speed pursuit ensued. McCullar drove in the wrong lane of traffic twice in an attempt to flee then went down Fulton Shipyard Rd. He eventually drove up onto the railroad tracks and the pursuit was terminated. McCullar drove off the tracks and then attempted to drive onto E 6th St where he was stopped by a perimeter officer without incident. The owner of the motorcycle was contacted and stated the motorcycle was stolen 4 years ago and reported to Pleasant Hill PD. After further investigation the owner of the motorcycle remembered she sold one 50cc bike and had one 50cc bike stolen 4 years ago and she could not remember which bike was stolen. McCullar was booked into county jail.
