#### FINANCE DEPARTMENT UPDATES

Request for proposals for business license discovery/recovery services were due January 29<sup>th</sup> at 2p.m. Three proposals were received and will be reviewed by City staff and interviews with firms will be scheduled beginning the second week in February.

All closing documents for the bond refunding transaction were executed on Tuesday by the Mayor, City Clerk, City Manager and Finance Director. The bond refunding transaction will save all property taxing entities considerable money through 2032, at which time the debt will be paid off. Due to the City's AA- bond rating and favorable market conditions, the projected debt service benefit for all taxing entities under the Redevelopment bond is estimated at over \$6 million; the City's share being over \$600.000. In addition, the City will save over \$1 million on the Lone Tree Golf Course Event Center debt over the same period. The transaction is scheduled to close on February 11, so final numbers will be reported next week.

#### **RECREATION UPDATES**

- Last week, the spring 2015 Recreation Guide arrived in Antioch mail boxes. Look for a newly updated edition with user friendly instructions and eye-catching layout that highlights programs, community events and information.
- Staff drafted early promotional materials for the 2015 Summer Day Camp programs. It is never too early to make summer plans for youth and families!
- On February 2, the City's electrical contractor closed out several projects in recreation facilities including rewiring a parking lot light pole, and replacing some failed conduit in a mechanical room at the Water Park with corrosion resistant PVC.
- Last week Water Park staff focused mainly on preventive maintenance. Filter media was changed, annual services were performed, and pools were brushed and vacuumed.
- On Wednesday, 75 yards of California Gold Track Fines field dirt was delivered to the Antioch Community Park. Dirt will be added and mixed with current soil and spread evenly throughout all three ball fields throughout the week.
- On Thursday, a new John Deere 1200A Bunker tractor was ordered to replace the
  old equipment at Community Park. This vital piece of equipment enables staff to
  not only prepare ball fields for game play, but also aids in the grooming of the
  artificial turf fields at the multi-use sports complex. Delivery will be mid-February;
  the purchase made possible by the City's vehicle replacement program.
- On Saturday, swim lessons began in the Water Park dome. Participants ages 6
  months and up enjoyed the indoor atmosphere and heated pool. Younger
  participants in our Parent &Child and Preschool lessons learned to become
  comfortable in the water and practiced water safety skills, while participants ages 6
  and up began working on stroke development.
- Last week, the Antioch Water Park booked 12 Buy Outs for the 2015 season.
   Groups included several schools in Antioch, as well as school groups from out of town and local businesses. Book your summer event before it is too late. Antioch Water Park is where you want to be!

#### Senior Center Services

- In January, 290 memberships were processed into the City ActiveNet system and the Senior Club's membership program.
- Staff completed several building maintenance repairs including replacing the time clock for the exterior building lights, addressing a pipe leak in the kitchen and fixing 3 broken socket covers.
- On Thursday, February 5, 2015 AARP provided the first day of Free tax services to seniors over the age of 60 in addition to general public. Appointments reached capacity at over 40.
- Last week, 406 affordable, healthy meals were served which was an increase of 12 from the previous week.

• On February 5, ten seniors participated in the monthly *Get up and Go with the Director* walking group in downtown Antioch.

#### **PUBLIC WORKS UPDATES**

### Administration

• PG&E has begun work on their 27-mile Contra Costa to Moraga 230 Kilovolt transmission line upgrades. This 27-mile project will begin in Antioch. Work which will involve raising transmission towers and replacing existing lines began in January and is scheduled to continue through May in Antioch. Crews and contractors will use helicopters and truck-mounted cranes to perform the work. Work will generally occur Sunday through Saturday 7:00 a.m.—5:00 p.m. PG&E will be utilizing a portion of Chichibu Park and another site near the Mira Vista Hills Reservoir off Cambridge Drive during much of the construction in Antioch as staging and construction locations for their operations. ### **Engineering & Development Services**

- Almondridge East Subdivision 8880 (81-unit single family home development by KB Homes), located between East 18<sup>th</sup> Street and Oakley Road, east of Phillips Lane and west of the State Highway 160: Staff is reviewing plot plans for new home construction.
- Buchanan Crossings Shopping Center, a 103,139 square foot commercial center on a 13.5-acre site located at the northwest corner of Somersville Road and Buchanan Road: Staff is plan checking revised onsite plans and is processing recordation of the parcel map, appurtenant easements, right-of-way dedications and quitclaim deed, and permit application with the USBR.
- Cellular Providers on City-owned Property: Metro PCS has requested decommissioning of their City Park and Via Dora sites. American Tower has requested consent letters for three of their City-owned cell sites. Verizon Wireless is applying for a new cell site on City property near Folsom Drive. AT&T wants to negotiate a lease modification for their City-owned James Donlon site.
- Contra Loma Estates HOA Privatization: Contra Loma Estates HOA has applied for a permit to privatize their interior roads and install security gates and fencing at the entrances to their subdivision. Staff has requested additional documentation. Planning Commission and City Council approval is required.
- Delta Bowl Parking Lot: Staff is plan checking a new parking lot.
- Golden Bow Estates HOA Privatization (PW 652): Golden Bow Estates HOA has applied for a permit to privatize their interior roads and install security gates and

- fencing at the entrance to their subdivision. Planning Commission and City Council approval is required.
- Nelson Ranch Unit 1 Subdivision 6893 (102-unit single family home development by Standard Pacific Housing) located northeasterly of Wild Horse Road and Ridgeline Drive and southwesterly of State Route 4: Staff has approved the Wild Horse Road Extension plans.
- Wilkinson-VanSandt LLA (PW 443-06-14): Application has been made for a lot line adjustment between 4316 and 4325 Berryessa Ct.
- The SR4 (Segment 3A) 'A' Street/Lone Tree Way Interchange, Cavallo Road/Garrow Drive Undercrossing Project: Bridge construction is underway by the SR4 Contractor at the Lone Tree Way/"A" Street and Cavallo Road undercrossings.
- eBART Parking Lot and Maintenance Facility: The Contractor has requested permit final on the encroachment permit for Slatten Ranch Road improvements. Staff is reviewing plans and easement dedications for a proposed 12" sanitary sewer main, from the new Maintenance Facility north underneath the S.P.R.R. railroad line and along the extension of Willow Avenue from Oakley Road.
- SR4 Lone Tree Way Widening, Sand Creek Road Interchange Project: The Contractor expects to complete the installation of stamped concrete, irrigation and landscaping in the Lone Tree Way/SR4 "Bypass" median by mid-February.
- Davidon Homes Park Ridge, Phase I, consisting of 123 residential units located west of Canada Valley Road and east of Highway 4: plans and maps have been resubmitted for second review.
- Laurel Ranch, 109 unit housing development at Highway 4 and Laurel Road: Engineering staff is preparing comments for the preliminary development plan review by City Council.
- Wal-Mart expansion: Staff is processing easements and vacation of existing easements.
- Deer Valley Business Park, commercial development fronting Country Hills Drive between Lone Tree Way and Deer Valley Road: Engineering is processing abandonment of existing easement.
- The Vineyards at Sand Creek, a proposed 641 unit housing development located on Sand Creek Road between Heidorn Ranch Road and Hillcrest Avenue: Staff continues to meet with the developer to discuss various site and infrastructure issues.
- Aviano, a proposed 533 unit housing development located on Sand Creek Road west of future Hillcrest Avenue: Staff continues to meet with the developer to discuss various site and infrastructure issues. The revised tentative map has been submitted for review and staff is updating conditions of approval.
- Lakeview Center, commercial development at Lone Tree Way and Golf Course Road: Staff is processing abandonment of existing raw water main easement and accepting new easement.
- The Ranch, a proposed 1,667 unit housing development located between Deer Valley Road and Empire Mine Road: Staff is preparing comments for preliminary development plan.

# Capital Improvements Division

- Sanitary Sewer Main Replacement at Various Locations: RGW Construction is installing new sanitary sewer service laterals on Deodar Avenue and Chestnut Avenue.
- Williamson Ranch Plaza Water Main Replacement: D.R. Lemings is installing new water main facilities on the western side of Williamson Ranch Plaza.
- Sunset Booster Pump Station Replacement: Kimley-Horn is finalizing project plans and developing project specifications.
- Raw Water Pipeline Inspection & Assessment: A proposal from Brown and Caldwell to perform comprehensive inspections and provide detailed assessments of the City's raw water pipelines is scheduled to be considered at the February 10<sup>th</sup> City Council meeting.
- Community Block Grant Downtown Roadway Pavement Rehabilitation: Project bids were publically opened on January 20<sup>th</sup>. The low bid was received from MCK Services in the amount of \$611,125. The award of this project is scheduled to be considered at the February 10<sup>th</sup> City Council meeting.
- Ninth Street Roadway Improvements: Project bids were publically opened on January 20<sup>th</sup>. The low bid was received from MCK Services in the amount of \$645,330. The award of this project is scheduled to be considered at the February 10<sup>th</sup> City Council meeting.
- Rubberized Cape Seal Program: The City Council awarded the 2015 Pavement Maintenance Cape Seal project to American Pavement Systems. Construction is scheduled to start June 8, 2015 and be completed by July 31, 2015.
- 2015/2016 Transportation Development Act (TDA) grant: Staff submitted the final grant application to MTC to install 35 new curb ramp at locations along "A" Street, Blue Rock Drive and West Tregallas Road.
- Safe Routes to School Grant (Cavallo/Garrow/E. Tregallas curb ramps): Staff has completed the design and is soliciting bids on a project to install 85 curb ramps and provide sidewalk pedestrian improvements along Cavallo Road, Garrow Drive, East Tregallas Road and Drake Street. Construction documents are available for purchase at a cost of \$75 per set. The public bid opening for this project is scheduled for February 10, 2015, at 2:00 P.M. in the City Council Chambers located at 200 "H" Street. Construction is scheduled to start in April 2015.
- Transportation Impact Fee Study: The City Council approved EPS consultant services to develop a Transportation Development Impact Fee study. The study is scheduled to start in February 2015 and completed within a 12 month period.
- Antioch Fishing Pier Shade Structure: SRP Company completed construction of the project. City Council will consider acceptance of the project at the February 10, 2015 meeting.
- Preventative Pavement Maintenance Program: Staff has identified a list of streets for pavement "Dig Out" repairs to repair pothole and pavement failure areas.
   Construction documents are available for purchase at a cost of \$50 per set. Copies

may be obtained by logging on <a href="https://www.blueprintexpress.com/antioch">www.blueprintexpress.com/antioch</a> or by calling BPXpress Reprographics at (707) 745-3593. The public bid opening for this project is scheduled for February 10, 2015, at 2:00 P.M. in the City Council Chambers located at 200 "H" Street. Construction of the project is scheduled for April 2015.

 Cavallo Road and Country Hills Drive Pavement Rehabilitation: Staff is working on the design. Construction is scheduled for May 2015.

### Traffic Engineering

- Engineering and Traffic Surveys: Staff net with TJKM Consultants to review and finalize the recommendations for speed limit changes. The proposed changes will be presented to the City Council for adaption. These surveys are required on major streets in order for the police department to use radar for speed enforcement.
- Staff is coordinating the installation of an electric vehicle recharging station at the City Hall parking lot, 200 "H" Street. Installation is anticipated in mid February. The station will be part of the "ChargePoint" system and available to the public.

### Water Treatment Plant

- Cleaned solar bees out on the reservoir. Also cleaned the staff gage on the tower.
   This is reoccurring and ongoing.
- Began programming the motorized control valve at Hillcrest pump to operate from SCADA to take water from the MPP.
- Completed repairing ASCO valves at Lone Tree Pump Station.
- Started installing new sample lines from the pipe gallery to the lab on second floor.

# Water Distribution

- There were 327 stops for water service including disconnections.
- There were a total of 52 USA tickets completed for utility location.
- Meter reading has started for the month of February.
- Annual backflow test program continues and is on schedule.
- Water crews are preparing for the meter testing program.
- Water crews are continuing to maintain the backfill material area and dumpster area at Fulton Yard.
- Water crews replaced a sewer lateral on Lisa Ct.
- Water crews replaced a six inch fire hydrant on Marie Ct.
- Water crews continue assisting the Streets Division with Water Division paving project.
- Water crews replaced a one inch water service on Chestnut Dr.
- Water staff second shift continues fire hydrant preventative maintenance program.
- Water Division staff replaced irrigation main on James Donlon Blvd.
- Stores staff has completed retooling of Collections Division service vehicle.
- Stores staff has completed dismantling lamp generators, which now are recycled on an "as needed" basis.
- Stores staff continues removing debris from Fulton Shipyard Rd. launch ramp.
