The LOI allows Everett & Jones to start their due diligence process. They are a family owned business with a dedicated clientele. Their brand has expanded into the distribution of their barbeque sauces carried in a number of grocery stores and brewing their very special “Saucy Sistah” Ale, an amber beer served only at their restaurants. The vacant city owned property is the former Humphrey’s on the Delta, located at One Marina Plaza. This site is nestled between the City Marina and boat launch overlooking breathtaking views of the San Joaquin River and adjacent to historic Rivertown.

Delta Fresh Foods Coming Soon: A family owned company, Delta Fresh Operators LLC, will open soon in the recently closed Fresh and Easy building at Lone Tree Way and Golf Course Road. RECREATION UPDATES

- Last week, 60 youth in grades 1 & 2 wrapped up their Junior Warriors youth co-ed basketball league in the gymnasium at the Antioch Community Center. All participants received certificates signed by Stephen Curry, provided by the Golden State Warriors! Volunteer coaches recognized each and every team player and encouraged them to keep active – a basic skills camp begins in March and will promote continued enjoyment of this great game.

- On-line registration for spring activities has begun. Walk-in registration begins February 17 so check your mail box or log into the City website and get ready to **Soar Into Recreation!**
- Last week, staff posted summer Camp Leader positions through the LMC & DVC College Central Employer Services to recruit qualified staff to work with youth enrolled in summer day camp programs.
- Staff began drafting promotional materials for the 2016 Summer Day Camp programs. Distribution to the Antioch Unified School District students begins in mid April.
- On Wednesday, the City's Fire Sprinkler vendor completed periodic inspections at all Recreation sites. All systems passed the required inspections.
- On Wednesday, Recreation Maintenance staff researched LED lamps for the Nick Rodriguez Community Center Multi-Use Room. LED technology allows the City to save money related to ongoing maintenance costs as well as electricity.
- Water Park staff continues to prepare for Opening Day 2016. Key projects are on track, maintenance upgrades have started and regulatory requirements continue to be met.
- Residents have started purchasing their Antioch Water Park season passes. Lock in your discounted rate now – only \$50 and **BE COOL BY THE POOL** in 2016!
- Last week, a new reservation system was implemented for Water Park Buyouts that will expedite the process for hosting private events at the Water Park. Open dates are going fast so plan now for a family reunion, company picnic or unique celebration at the Water Park.
- The re-hire process for returning water park employees continues; scheduling fingerprinting appointments and completing personnel documents. Water Park staff started interviewing candidates for seasonal Deck Crew positions.
- Summer jobs at the Water Park are still available; staff continues marketing to local schools. Interviews are being scheduled so turn in your application now; staff is preparing for the arrival of many new candidates in March.
- On Wednesday, staff met with the Sports Legends/Antioch Historical Society to plan a summer event called "Family Sports Day." Look for more information about this unique event coming in August at the sports museum.
- Last week, staff initiated program planning efforts for a large spring kick-off for the Antioch Council of Teens.
- On Tuesday, the "Black History Month Exhibit" opened for the week at the Nick Rodriguez Community Center. Public viewing continues so bring the entire family any afternoon Tuesday through Saturday, ending February 20th.

Senior Center Services

- On Thursday, AARP was on site working with older adults who need assistance with their 2015 tax return. All available appointments were filled for the week.
- On Thursday, the Senior Club hosted a special Valentine’s Day celebration. Seniors enjoyed receiving valentine hearts, as well as singing and dancing. The Senior Club also raffled off a small TV as a door prize.
- To date the Senior Club has received new and renewal membership applications from 605 older adults.

Environmental Enforcement: Feb 4-11: There were 28 actions taken this week. Staff is addressing previously abated homes that have not reestablished service and a new batch from Republic Services.

CDBG:

- Monitoring by Antioch and other Consortium members is underway and will continue.

Housing:

- A TEFRA hearing for Casa Blanca Apartments was held Feb 9th, and approved by Council. They submitted their application to the California Tax Credit Allocation Committee for the March round.
- Staff prepared and submitted to the State Tax Credit Allocation Committee the "Local Reviewing Agency Project Evaluation Forms" for Casa Blanca Apartments, Delta View Apartments, and Tabora Gardens for consideration in the March allocation round of funding 4% tax credits.

Homeless:

- The Homeless Point in Time Count has concluded and data is being entered into the Homeless Information Management System. A report is expected to be available by the end of March.
- The next General Meeting of the Contra Costa Homeless Continuum of Care is April 15, 2016, and all are invited. We will continue with panel presentations about the criminal justice system and homeless persons. Meetings are held in the ZA room at 30 Muir Road, Martinez from 10 am -12 pm.

DROUGHT UPDATES:

Antioch Water Customers used 11.21% less than January 2013. This takes our cumulative total to 30.72 since last summer. We must maintain a minimum reduction of 28% cumulatively in order to stay in compliance with the State's drought regulations. These regulations were set to expire in February, however California is still experiencing severe drought despite recent rains. The State Water Resources Control Board (State Water Board) adopted on February 3, 2016, an extended and revised emergency regulation to ensure that urban water conservation continues in 2016. The regulation extends restrictions on urban water use through October 2016.

Irrigation Repairs and Service:

- Park Water Reductions: All park water is off except City Park.
- City Park: The soccer turf field is undergoing renovation for field improvement.
- Chaparral Park: The main water backflow has been replaced, and is now on.
- Chichibu Park: The main is off, awaiting repairs.
- Williamson Ranch: The "C" main backflow is now on. Shrub valve C-17 was replaced with a new valve.

- L St. - Repaired 3 sprinklers and capped 1.5 inch mainline to quick coupler.
- James Donlon Blvd - Repaired 6 sprinklers and rebuilt 1 valve.
- Pyrite Ct. - Repaired 2 sprinklers.
- Davison Dr. - Capped 6 sprinklers.
- Laurel Rd. – Repaired 3 sprinklers.
- Hayward Ct. - Reprogrammed irrigation controller.
- 2nd/I St. - Replaced 2 valves.
- 3rd/I St. - Replaced 2 valves.

PUBLIC WORKS UPDATES

Administration

- Due to the current and predicted El Niño rains, Public Works has procured extra sand bags and sand, as well as ensuring staff is ready for action 24/7. The City website will have additional information about what the City is doing and how the community can better prepare for the possibility of a severe winter.
- In spite of the much needed recent rains, the State has communicated that the drought is still ongoing and mandatory water conservation has been extended to October 2106. The City of Antioch is being required to reduce its 2015-2016 water usage by 28% in using 2013 as the base year. Outdoor water conservation will be the primary focus of the City's program, as well as fines for wasteful practices as identified in the Water Conservation Resolution adopted by the City Council on May 12th. All Antioch customers were mailed a letter explaining the program and prohibitions, as well as 2013 monthly water usage. Examples of prohibitions are: three day per week residential outdoor watering, no watering between the hours of 9:00 a.m. and 5:00 p.m., shut off nozzles required on all hoses, and drinking water available only upon request at restaurants. Contra Costa Water District has incentives, such as residential high-efficiency clothes washer rebates, water-efficient landscape rebates and smart sprinkler timer rebates. More information on water conservation programs and ideas on how to conserve water can be found at www.ccwater.com or www.antiochwater.com. Customers who are not in compliance with drought restrictions can be reported to the Antioch Drought Hotline at (925) 779-6140.

Engineering & Development Services

- Almondridge East Subdivision 8880, an 81-unit single family home development by KB Homes, located between East 18th Street and Oakley Road, east of Phillips Lane and west of the State Highway 160: Staff is reviewing plot plans for ongoing new home construction. Staff provided a punch list for offsite improvement bond reduction.
- Buchanan Crossings Shopping Center, a 103,139 square foot commercial center on a 13.5-acre site located at the northwest corner of Somersville Road and Buchanan Road: CVS and Grocery Outlet stores are open for business and other building

pads are in development and planning stages. Environmental clearances and USBR permitting requirements for the Phase 2 development are in progress. Staff is processing a request for reimbursement for Somersville Road widening.

- City Sports Club, located at 5001 Lone Tree Way: Building and parking lot construction is nearing completion.
- City-owned cell sites, various locations: Staff is performing site visits and review of land leases, 100% construction drawings, consent letters, photo-sims and related technical reports and materials for equipment upgrades.
- DeNova Homes Mixed Use Project at Hillcrest Ave./Wildflower Dr.: Application for mixed use project consisting of 9.5 acres commercial, 8 acres multi-family, and 2.2 acres single family development. The Planning Commission discussed DeNova's PDP-15-01 application on August 19th. The developer has been reaching out to the neighborhood for input into the project. An application with an updated site plan is anticipated later in February or March.
- Laurel Ranch, a 186-unit housing development by Richland Communities, located at the eastern terminus of existing Laurel Road and west of Highway 4: Staff is reviewing the final development plan and preparing project conditions of approval. Staff is working with the developer to reduce illegal trespassing on the unimproved site.
- Nelson Ranch Subdivision 6893, end of Wildhorse Road: Staff will perform site inspection in response to developer's request for warranty bond release.
- Park Ridge Phase I, a 123-unit housing development by Davidon Homes, located west of Canada Valley Road and east of Highway 4: Staff is processing the 5th submittal map and plan checks.
- Taco Bell, 1706 'A' Street: The new restaurant is now open for business. Staff is working with developer to restrict left-turns into business from "A" Street.
- The Vineyards at Sand Creek, a proposed 641 unit housing development located on Sand Creek Road between Heidorn Ranch Road and Hillcrest Avenue: The tentative map has been approved by Planning Commission and was approved by the City Council at their on February 9th meeting.
- Aviano, approved 533 unit housing development located west of the current terminus of Hillcrest Avenue, east and north of Dozier-Libby Medical High School: Staff is working with developer on park extension. First phase of construction documents have been submitted for 1st review.

Capital Improvements Division

- Water Main Replacement at Various Locations: D&D Pipelines is installing the new pressure regulating station on Hillcrest Avenue between Arzate Lane and East 18th Street. Bacteriological testing of the systems is being performed on recently installed water facilities on Sunset Drive and West Lake Court.
- West Antioch Creek Channel Improvements: Contra Costa County Public Works Real Property Division is negotiating terms with the State of California's 23rd District Agricultural Association pertaining to land acquisitions within the footprint of the

Contra Costa Fairgrounds. Staff is scheduled to meet with the U.S. Army Corps of Engineers and U.S. Fish and Wildlife to discuss federal permitting in mid-February.

- Fulton Shipyard Road Sewage Drainage Station: JD Partners has completed construction of the new facility.
- Water Treatment Plant Disinfection Improvements: The 30-day review period of the project's CEQA document began February 3rd. Staff is reviewing the 90% draft project plans and specifications provided by CDM Smith.
- Cathodic Protection Assessment: JDH Corrosion Consultants, Inc. continues to field test existing cathodically protected water facilities throughout the City.
- Water Treatment Plant Electrical Upgrades: TJC and Associates is analyzing the existing electrical facilities at the Water Treatment Plant.
- Country Hills Drive and Vista Grande Drive Water Main Replacement: Construction bids were publically opened on January 12, 2016. The lowest responsive bid was received from A-S Pipelines, Inc., in the amount of \$983,690. The City Council awarded the project to A-S Pipelines, Inc. at the February 9th meeting.
- 2015 Transportation Development Act (TDA) Grant: JD Partners completed the construction of 27 new curb ramps along Bluerock Drive and West Tregallas Road and is working on new ramps along San Joaquin Avenue. The City Council will consider the final acceptance of the project at the February 23rd meeting.
- Transportation Impact Fee Study: Staff is working with the consultant, EPS, to finalize the land use forecasts and the transportation improvement list and network to be used in the traffic model. The final draft Fee Study will be presented to the City Council for public review and comments in May 2016.
- Prewett Water Park Improvements: RHAA is under contract for the design of the final improvements at Prewett Water Park. Staff received the project permit approvals from the County Health Department and the Fire Department. RHAA has submitted the final design plans and specifications of the spray ground and the playground facility. The bid packages for both projects are expected to be out for bid in February 2016; construction is expected to be completed by September 2016.
- North East Annexation Infrastructure Improvements: Staff is drafting a Request for Proposal for consulting services to provide engineering services and to prepare preliminary plans, estimates and studies for the planning and the design of infrastructure improvements needed to serve the newly annexed Area 1 and 2B.
- 2016 Transportation Development Act (TDA) Grant: MTC is soliciting applications for 2016/2017 TDA grants for Pedestrian and Bicyclist improvement projects. The City Council approved a resolution of support for the \$130,000 grant funding application at the January 12th meeting; the Parks and Recreation Commission approved a resolution of support at their January 21st meeting. The grant application includes funding for curb ramp upgrades to meet ADA requirements, installation of new sidewalks at needed locations and for bicyclist improvements along Cavallo Road, "A" Street, "G" Street, Putnam Street and Carpinteria Drive.
- Traffic Signal Improvements at Wild Horse Road/Folsom Drive and W. Tenth Street/L Street: Staff is preparing plans and specifications for a new traffic signal at

Wild Horse Road/Folsom Drive and a traffic signal modification at W. Tenth Street/L Street. The bid package is expected to be out for bid in April 2016.

- Staff received 13 statements of qualifications and proposals from traffic engineers, civil engineers and landscape architects/planners for on-call services and the L Street Path to Transit Corridor. Staff will be reviewing the documents and determine if interviews are necessary.

Water Treatment Plant

- Cleaned Solar Bees out on the municipal reservoir. Solar Bees circulate the water in the reservoir; cleaning the Solar Bees prevents weeds from restricting the circulation. Also cleaned the staff gage on the tower. This is reoccurring and ongoing.
- Cleaned the Acti-Flow units, pumps and tube settlers.
- Started the arch flash study. Powered down all electrical units at both "A" and "B" plants and inspected all electrical breakers, types of wires and heaters.
- Installed new 24 volt power supply units to both the leak detectors

Water Distribution

- Water crews had 269 stops for water service including disconnections.
- Water crews had a total of 72 USA tickets completed for utility location.
- Meter reading has started for the month of February and is on schedule.
- There were four drought notices issued this week.
- The State Water Board has Extended Emergency Water Conservation Regulations through October 2016.
- Water crews continue to monitor water meters, conservation and usage at all City buildings and parks.
- Water Distribution personnel continue to respond to drought hotline inquiries.
- Water field techs responded to customer calls regarding water related issues city wide.
- Water crews replaced a 1" water service on Cats Eye Street.
- Water crews prepped a 12" water main for valve installation at the water treatment plant.
- Water crews repaired two 8" main valves on Knollpark Circle.
- Water crews repaired an 8" main valve on Sycamore Drive.
- Water crews replaced a valve on Shady Lane.
- Water crews installed a water sample station on St. Andrews Way.
- Water crews performed preventative maintenance on fire hydrants city wide.
- Water staff hauled off green waste for recycles, as well as cleaned up debris at the city's Fulton yard.
- Central Stores staff continues to remove graffiti from Amtrak platform and Fulton Shipyard Rd. boat ramp areas.
- Central Stores staff removed household items and trash from Fulton Shipyard Rd. boat launch facility parking lot.

- Central Stores staff assisted Facilities Maintenance with removal of office furniture that was replaced at Police Dispatch.
- Central Stores staff ordered and received parts for a reduced pressure assembly for Prewett Family Water Park.

Public Works Operations – Parks and Landscape

- Playground and Park Safety Inspections: Completed at Almondridge, Country Manor, Deerfield, Hillcrest and Meadowbrook Parks.
- City Park: In the process of renovating the soccer field turf. Sealed the tot-lot surface to protect and prolong its useful life, and installed a new sand digger for the sandbox.
- Delta Diamond: In the process of renovating the baseball field turf for field improvement.
- Meadowbrook Park: Installed a new basketball net.
- Nelson Ranch Park: Installed a new basketball goal.
- Park Water Reductions: The water is off for all City parks except City Park.
- Tree Removal Permits: No Tree Removal Permits were issued.
- Irrigation: Repaired 27 irrigation leaks on City property.
- Leaf Removal: Hillcrest rights of way, Laurel Rd. medians.
- Roadside Spray: Indian Hills trail, Hidden Glen areas (zone 4544), Almondridge trails, Deerfield corridors, and behind Lowes.
- Spot Spray: Lone Tree, James Donlon, Contra Loma, and Hillcrest medians.
- Debris Removal: Marina.
- Removal of Dumped Christmas Trees: Citywide.

Public Works Operations – Street Maintenance

- Graffiti Abatement: Removed graffiti from City property in numerous areas.
- Signs: Replaced 57 existing signs due to poor reflectivity and installed No Parking signs and 20 Minute Parking signs on the north side of 2nd St. west of K St. to L St.
- Debris: Picked up 12 yards of debris in the City right of way.
- Potholes: Filled 77 potholes.
- Parks Division: Weather permitting, crews continue to assist the Parks Division with their annual pre-emergent weed spraying.

Public Works Utilities – Collections Division

- Calls for Sewer Service: Received and responded to three calls for service from the public. Responding crews televised 735 linear feet of public sewer laterals connecting to the City's sewer system.
- Sewer Mains: Daily preventative maintenance performed on over 26,054 linear feet of sewer main lines.

- Quarterly Sewer Main Cleaning: The route schedule is under review to increase inspection frequency of identified 'hot spots' and integrate a proactive preventative cleaning schedule for the 'hot spots.'
- Sewer Lateral Maintenance Program (SLMP): Crews repaired three laterals that were severely damaged requiring immediate repair. Crews televised 21 lateral(s).
- Manhole Inspection Program: Crews inspected 78 manholes. Manholes are inspected for loose lids, debris, locking mechanisms, and status of infrastructure for future maintenance and rehabilitation. We are updating the program and processes for integration in our computerized maintenance management system.
- Sanitary Sewer Overflow (SSO) Reduction Program: Staff is working on formal inspection criteria to inspect manholes in rural areas. The use of "SMART Manholes" in strategic areas will be utilized that will alert leadership staff within the division of potential SSOs. This program will also address the need for locking mechanisms.
- Closed Caption Televising (CCTV): Crews televised 7,415 feet of sewer main lines. The CCTV Preventative Maintenance crew inspects sewer mains to identify the condition and causes of blockages and SSOs.
- National Pollutant Discharge Elimination System (NPDES): Crews removed 67 yards of trash and debris and 38 shopping carts from various creeks and channels. Inspected and cleaned one spillway with one yard of debris removed from storm trash racks. Inspected and cleaned 100 linear feet and removed 1 yard of debris from v-ditches. Cleaned up four yards of illegal dumping. These activities ensure the City meets the Federal Clean Water Act requirements of municipalities discharging storm water into waterways.

Public Works Operations – Fleet Division

- Preventative Maintenance: 15 services on City vehicles as scheduled.
- Unscheduled Repairs: 55 unscheduled, necessary repairs to City vehicles.

Public Works Operations – Municipal Marina

- New Occupancy: The Marina responded to three berthing enquiries and gave one facility tour.

- Maintenance: Removed hyacinth and debris from the Marina basin. Removed fiberglass overheads on the north and south gate and replaced with new carbon fiber overheads.
