RECREATION UPDATES

- The Arts and Cultural Foundation of Antioch was recognized this week by the California Park and Recreation Society, District 3, for their contributions to the Antioch community. The Arts and Cultural Foundation is a valuable partner to the City. They enrich all of our lives by providing free summer concerts, coordinating art exhibits and sharing local talent with all residents, and assisting small community groups with programs and fundraising efforts. Congratulations!
- On February 25th, several customer service staff completed an American Red Cross CPR/First aid class. This important training provides part-time employees with the correct knowledge and information needed for handling emergency situations and workplace injuries at a variety of community locations.
- Last week, staff entered more than 200 classes and activities into the data base for the summer season. Antioch is where you want to be this year! Affordable, quality programs are available for youth and adults that support healthy lifestyles and social gatherings for friends.
- Last week the new John Deere tractor (used for ball field prepping) arrived in time for the upcoming Adult Summer Softball League. Fees and rosters for this program are still being accepted through Friday March 6th. Softball is a great summer fitness activity for all levels of play!
- On Saturday, the youth Junior Warriors basketball program ended a successful season with final games for all teams. The 220 youth between grades 1 thru 8 enjoyed their experience in a program with a special detailed emphasis on "kids first winning second." The program was such a success that a City of Antioch Summer League Season is in the early planning stages with a target start date of July 1.
- On Thursday and Friday, rehire interviews were held for 2014 Water Park employees looking to advance to a new position for the 2015 season. These interviews included applicants for Junior Lifeguard Instructors, Head Lifeguards, and Water Park Coordinators. Multi-year employees build long-lasting relationships with residents and improve services provided by the City.

- Last week, the Water Park continued to accept applications for the 2015 season. Open positions include lifeguard, swim instructor, concessions cashiers, deck crew, front desk cashier, and concession cooks. Applications can be picked up at the Antioch Community Center. The Water Park is the largest employer of youth and teens in Antioch. This is a great opportunity to gain basic job skills to last a lifetime.
- Last week, aquatics maintenance staff removed a slide pump from service and prepared for the replacement pump to be installed. The new pump will be installed next week complete with new valves and a new strainer assembly.
- On Monday, staff completed some repairs to the water park dome that were caused by recent high winds. Staff is updating the dome inspection program to include a comprehensive high winds response plan.
- **Everyone into the water!** 2015 Water Park Season Passes are on sale now. Purchase before May 22, and save 25%. Passes can be purchased online, or at the Antioch Community Center.
- During the month of February the City of Antioch facilitated 37 rentals at the three recreational and community facilities, including the visiting delegation from Antioch, Turkey, The Black History Arts and Artifacts Exhibit, and the Deer Valley High School annual Leadership Retreat.

Senior Center Services

- On February 24th, 50 members of the Antioch Senior Citizen Club took a field trip to the Big Break Visitor Center at the Delta. Transportation and Naturalist programs were sponsored by East Bay Regional Park District. Participants especially enjoyed the 1,200 square foot interactive map of the Delta that shows visitors how water flows through the region.
- Due to the success and popularity of the collaboration with East Bay Regional Park District, staff will continue to promote the natural resources found right here in the Antioch community. A senior trip is scheduled on May 7th to Black Diamond Mines Regional Preserve.
- Last week, staff met with the Contra Costa Health Services Senior Nutrition Program Operations Manager, to consult on techniques to enhance senior nutrition operations and outreach, current trends and ADA compliance. Future goals and possibilities were also addressed in order to provide additional nutritional services.
- Last week, 412 affordable healthy meals were served, which was an increase of 95 meals from the previous week. No membership or income requirements are required to eat at the C.C. Cafe.
- The Antioch Senior Center March/April 2015 Newsletter was completed; it is in the printing and production phase. Over 400 Seniors and family members with E-mail have already received the newsletter.
- Last week, staff redesigned the Senior Services section of the Antioch Recreation Guide. Look for new and expanded senior services, as well as resources available to the community in the next edition.

Environmental Enforcement: For February 18-25, there were over 92 actions taken on cases. 44 of these actions were site inspections to determine if properties are occupied prior to sending abatement notices. 15 abatement notices were mailed out for lack of garbage service. 9 cases were closed.

Sustainable Contra Costa and the City of Antioch will be holding a hands-on DIY greywater workshop in Antioch on May 17th, 2015 and are looking for a host home.

Requirements:

Laundry room must be adjacent to an exterior wall of the home and within 50 feet of plants that are directly accessible (no large slabs of concrete) for an irrigation line. Homeowner needs to sign a release of liability waiver. In exchange for use of the site, workshop attendees, under the supervision of professional installers/instructors, will install the systems free of charge (no cost for labor, no cost for design).

CDBG & Housing Programs:

CDBG & Neighborhood Stabilization Program (NSP-1)

- Continued writing draft Antioch Consolidated Plan and entering into the HUD computer system.
- Completed all Requests for Reimbursement for second quarter.
- Met with Engineering and MLK contractors to review prevailing wage requirements prior to start of Downtown Roadway Rehabilitation project; as this project contains 3 years of CDBG funding and will assuredly be monitored by HUD/Department of Labor (DOL).

Began scheduling agency interviews for Council Subcommittee. Interviews of the 34 applicants will be conducted April 1 & 8th. Council will receive recommendations and make funding decisions on May 12th.

Housing

- Received payoff of one housing rehabilitation loan; working with a bank on another subordination or possible loan payoff request.
- Processed amortized monthly housing loan repayments for four Antioch clients (part of loan processing duties recently assumed from the County).
- Presented Tabora Gardens project and funding request to Council and received commitment for additional \$1 million in funding, wrote commitment letter to TCAC.

Homeless

- Attended the National Alliance to End Homelessness 2-day training/conference, which was put on in collaboration with HUD. The Secretary of HUD, Julián Castro, spoke and every seminar staff attended featured a HUD presenter. Learned about leading edge approaches to ending homeless for veterans and chronically homeless, as well as additional funding available, which directly pertain to the Consolidated Planning process, and will be useful to Antioch.
- Continued working with Diablo Veteran's Group on Stand Down On The Delta, to be held Sept. 11, 2015, to assist homeless veterans with services and linkage to housing.

PUBLIC WORKS UPDATES

Administration

- PG&E has begun work on their 27-mile Contra Costa to Moraga 230 Kilovolt transmission line upgrades. This 27-mile project will begin in Antioch. Work which will involve raising transmission towers and replacing existing lines began in January and is scheduled to continue through May in Antioch. Crews and contractors will use helicopters and truckmounted cranes to perform the work. Work will generally occur daily between 7:00 a.m. and 5:00 p.m. PG&E has fenced the area they will be utilizing at Chichibu Park. They will also be staging work at another site near the Mira Vista Hills Reservoir off Cambridge Drive during much of the construction in Antioch as staging and construction locations for their operations. - SR4 (Segment 3B) Hillcrest Ave overcrossing/Slatten Ranch Road Project: Hillcrest Avenue NB/SB bridge traffic will have #2-lane closures Wed.-Fri. nights, February 25-28, for overhanging demolition work. Hillcrest Avenue signalized ramp intersections will be put on flashing red Mon.-Wed., March 2-4, for installation of bridge falsework. Freeway will be closed to traffic under the Hillcrest overcrossing and on-/off-ramps will be used as detour route. Flaggers will be provided for pedestrian traffic.

Engineering & Development Services

- Almondridge East Subdivision 8880, an 81-unit single family home development by KB Homes, located between East 18th Street and Oakley Road, east of Phillips Lane and west of the State Highway 160: Staff is reviewing plot plans for new home construction.
 - Buchanan Crossings Shopping Center, a 103,139 square foot commercial center on a 13.5-acre site located at the northwest corner of Somersville Road and Buchanan Road: Revised onsite plans have been approved. Parcel map, appurtenant easements, right-of-way dedications and quitclaim deed were sent to the County Recorder's Office for filing. Grading and construction of improvements has begun. Phase 2 environmental clearance and USBR permit are in process.
 - Cellular Providers on City-owned Property: Metro PCS is decommissioning their Via Dora site. Verizon Wireless is applying for a new cell site near Folsom Drive. AT&T is pursuing a lease modification for their James Donlon site. Crown Castle is seeking to renegotiate a lease for their Putnam Drive site. Metro PCS and Verizon paid for contractor damages to their Via Dora site.
 - Contra Loma Estates HOA Privatization: Contra Loma Estates HOA has applied for a permit to privatize their interior roads and install security gates and fencing at the entrances to their subdivision. Staff has requested additional documentation. Planning Commission and City Council approvals are required.
 - Delta Bowl Parking Lot: Staff is plan checking a new parking lot.
 - Golden Bow Estates HOA Privatization (PW 652): Golden Bow Estates HOA has applied for a permit to privatize their interior roads and install security gates and fencing at the entrance to their subdivision. Planning Commission and City Council approvals are required.
 - Laurel Ranch, a 186-unit housing development by Richland Communities, located at the eastern terminus of existing Laurel Road and west of Highway 4: The developer is preparing a final development plan submittal.
 - Nelson Ranch Unit 1 Subdivision 6893, a 102-unit housing development by Standard Pacific Housing, located northeasterly of Wild Horse Road and Ridgeline Drive and southwesterly of State Route 4: Staff returned signed off-tract Wild Horse Road improvement plans to the developer.
 - Park Ridge Phase I, a 123-unit housing development by Davidon Homes, located west of Canada Valley Road and east of Highway 4: Plans and maps have been resubmitted for second review and landscaping plans have been submitted for design review approval.
 - Taco Bell, 1706 'A' St. (UP14-14): Staff is reviewing a use permit application.
 - Wilkinson-VanSandt LLA (PW 443-06-14): Application has been made for a lot line adjustment between 4316 and 4325 Berryessa Ct.
 - SR4 (Segment 2) Contra Loma Blvd. Interchange/ 'G' Street Overcrossing Project: The traffic has been switch is at Contra Loma Blvd. Punchlist items are being completed for 'G' Street overcrossing.
 - SR4 (Segment 3A) 'A' Street/Lone Tree Way Interchange, Cavallo Road/Garrow Drive Undercrossing Project: Bridge construction is underway at the Lone Tree Way/"A" Street and Cavallo Road undercrossings.

- eBART Parking Lot and Maintenance Facility: The Contractor has requested permit final on the encroachment permit for Slatten Ranch Road improvements. Staff is reviewing plans and easement dedications for a proposed 12" sanitary sewer main, from the new Maintenance Facility north underneath the S.P.R.R. railroad line and along the extension of Willow Avenue from Oakley Road.
- SR4 Lone Tree Way 4-Lane Widening/ Sand Creek Road Interchange Project: Contractor expects to complete the installation of stamped concrete, irrigation and landscaping in the Lone Tree Way/SR4 "Bypass" undercrossing median by mid-March.
- Davidon Homes Park Ridge, Phase I consisting of 123 residential units located west of Canada Valley Road and east of Highway 4: Plans and maps have been resubmitted for second review.
- Wal-Mart expansion: Staff is processing easements and vacation of existing easements.
- Deer Valley Business Park, commercial development fronting Country Hills Drive between Lone Tree Way and Deer Valley Road: Staff is processing abandonment of existing easement.
- The Vineyards at Sand Creek, a proposed 641 unit housing development located on Sand Creek Road between Heidorn Ranch Road and Hillcrest Avenue: Staff continues to meet with the developer to discuss various site and infrastructure issues.
- Aviano, a proposed 533 unit housing development located on Sand Creek Road west of future Hillcrest Avenue: Staff continues to meet with the developer to discuss various site and infrastructure issues. The revised tentative map has been submitted for review and staff is updating conditions of approval.
- The Ranch, a proposed 1,667 unit housing development located between Deer Valley Road and Empire Mine Road: Staff is preparing comments for preliminary development plan.

Capital Improvements Division

- Sanitary Sewer Main Replacement at Various Locations: RGW Construction is installing new sanitary sewer service laterals on Deodar Avenue and Chestnut Avenue and installing new sanitary sewer main on Birch Avenue.
- Williamson Ranch Plaza Water Main Replacement: D.R. Lemings has completed the installation of a new water main on the western side of Williamson Ranch Plaza. Pressure and bacteriological testing is being performed on the pipeline. Tie-in connections are expected to commence next week.
- Curb, Gutter and Sidewalk Repair Program: Anchor Concrete continued to remove and replace deteriorating, damaged and uneven concrete throughout the city. Over the past week a total of 231 square feet of sidewalk and 33 lineal feet of curb and gutter were repaired.
- Community Block Grant Downtown Roadway Pavement Rehabilitation: A preconstruction conference was held on February 23rd. The asphalt and concrete rehabilitation on West Second Street from 'J' to 'L' Streets, West Third Street,

between 'I' and 'J' Streets, West Fifth Street from 'J' to 'L' Streets and 'K' Street from West Second and West Tenth Streets is expected to commence in early March.

- Ninth Street Roadway Improvements: A Pre-construction conference was held on February 23rd. The asphalt and concrete rehabilitation on West Ninth Street from 'A' to 'H' Streets is expected to commence in early March.
- Marina Boat Launch Facility, Third Boarding Float: Project plans and specifications are available for purchase at a cost of \$75 per set. Copies may be obtained by logging on <u>www.blueprintexpress.com/antioch</u> or by calling BPXpress Reprographics at (707) 745-3593. The public bid opening for this project is scheduled for April 7, 2015, at 2:00 p.m. in the City Council Chambers located at 200 "H" Street.
- West Antioch Creek Channel Improvements: The City has received the initial response from the Ironhouse Sanitary District regarding disposal of sediment at areas under their jurisdiction. As expected, the City has been requested to coordinate additional testing operations with the Regional Water Quality Control Board. The Contra Costa County Public Works Real Property Division is continuing work related to the property and easement acquisitions.
- Water Treatment Plant Disinfection Improvements: Requests for Proposals have been sent to various engineering consulting firms to perform comprehensive feasibility studies and alternative analysis on various disinfection processes to replace the existing chlorine gas pre-treatment and post-treatment currently utilized at the City's Water Treatment Plant. Consultant responses are due March 31st.
- Rubberized Cape Seal Program: The City Council awarded the 2015 Pavement Maintenance Cape Seal project to the low bidder, American Pavement Systems. Construction is scheduled to start June 8, 2015, and be completed by July 31, 2015.
- 2015/2016 Transportation Development Act (TDA) grant: Staff met with the Countywide Bicycle Advisory Committee to field review the grant application to MTC to install 35 new curb ramp locations along "A" Street, Blue Rock Drive and West Tregallas Road.
- Safe Routes to School Grant (Cavallo/Garrow/E. Tregallas curb ramps): Staff opened bids for the installation of 85 curb ramps and sidewalk improvements along Cavallo Road, Garrow Drive, East Tregallas Road and Drake Street. The City Council awarded the construction contract at the February 24th meeting. Construction is scheduled to start in April 2015.
- Transportation Impact Fee Study: The kick-off meeting was held February 24th and the study is scheduled to be completed within a 12 month period.
- Preventative Pavement Maintenance Program: Staff has identified a list of streets for pavement "Dig Out" repairs to repair pothole and pavement failure areas. Staff opened bids for the project on February 17th. The City Council will consider awarding the construction contract at the March 10th meeting. Construction of the project is scheduled for April 2015.
- Cavallo Road and Country Hills Drive Pavement Rehabilitation: Project plans and specifications are available for purchase at a cost of \$75 per set. Copies may be

obtained by logging on <u>www.blueprintexpress.com/antioch</u> or by calling BPXpress Reprographics at (707) 745-3593. The public bid opening for this project is scheduled for March 17, 2015, at 2:00 p.m. in the City Council Chambers located at 200 "H" Street. Construction is scheduled for May 2015.

• Prewett Park Improvements: Staff has solicited requests for proposals for consultant services for the design of the final improvements at Prewett Park, which will include a splash/spray park, multi-age group outdoor playground, lighted basketball sport court with security fencing, group picnic area with a shade structure, and a digital marquee monument sign. Construction is anticipated to start in January 2016.

Traffic Engineering

- Engineering and Traffic Surveys: Staff is proposing several speed limit changes and cleanup of the municipal code section 4-5.1501 (Speed Limits) based on the Engineering and Traffic Surveys recently completed. The Ordinance was introduced at the February 24th City Council meeting. The Council requested additional speed limit changes that will be incorporated into the Ordinance and presented to the Council on the March 10th City Council meeting for adoption.
- Staff is coordinating the installation of an electric vehicle recharging station at the City Hall parking lot, 200 "H" Street. Installation is anticipated in early March. The station will be part of the "ChargePoint" system and available to the public.

Water Treatment Plant

- The one year warranty inspection for Larkspur tank was performed on February 20th. The paint had a few spots that needed touching up and this work was completed the same day.
- Donlon tank's one year warranty inspection will be performed on February 27th.
 WTP crews are working on removing any excess water on the bottom floor of the tank so that the contractor can touch up any areas that will need it.

Water Distribution

- There were 227 stops for water service including disconnections.
- There were a total of 61 USA tickets completed for utility location.
- Meter reading for the month of February is now complete.
- Annual backflow test program continues and is on schedule.
- Water crews have started the meter testing program to monitor water conservation and usage.
- Water crews are continuing to maintain the backfill material area and dumpster area at Fulton Yard.
- Water crews replaced a two inch backflow on West 4th Street.
- Water crews repaired a six inch valve on Vista Grande Drive.
- Water staff second shift continues citywide fire hydrant preventative maintenance program.
- Stores staff continues updating MSDS/SDS files for Corp Yard.

- Stores staff ordered material for Collections bypass system update.
- Stores staff continues removing debris from Amtrak Station.

Public Works Maintenance Operations – Parks and Landscape

- Playground and park safety inspections: Completed at Canal, Eagleridge, Marchetti, Markley Creek and Mira Vista Hills Parks.
- City Park was vandalized on Wednesday, February 18th, between 8:30 and 10:30 am. A porcelain urinal was broken and completely dislodged from the wall in the men's restroom. This has necessitated a complete closure of the restrooms until a replacement can be ordered and installed. Any information in this regard can be forwarded to Antioch Public Works at 779-6950.
- PG&E continues to update clearance of their high voltage lines near established City trees. Five trees at Chaparral Park will be removed for line safety reasons.
- Irrigation leaks were attended to and repaired.
- Annual Roadside Spray Program: Initiated and ongoing with the Streets Division.
- Spot Spraying: Laurel Rd., Canada Valley Rd., James Donlon medians, Buchanan Rd. medians, Via Dora Dr., Sagebrush Dr. and downtown area planters.
- Trim crews worked on Laurel Road.
- Tree Limb Removal: Marina and Dist. 1A.

Public Works Maintenance Operations - Street Maintenance

- Annual Weed Abatement Spray Program: Initiated and ongoing with the Parks Division.
- Debris: Five yards removed from the rights of way.
- Graffiti removed from City property in numerous areas.
- Potholes: Five potholes filled.
- Saw Service Cuts: Cut 1,020 feet of asphalt in preparation for paving service cut repairs.
- Pave Service Cuts: 21 service cuts paved.
- Signs: 14 signs replaced due to poor reflectivity.

Public Works Maintenance Operations – Collections Division

- Requests for Service: Received and responded to 11 calls for service from the public. Responding crews televised 27 laterals and cleaned over 14,644 linear feet of sewer lines.
- Crews repaired a public sewer lateral on Sunset Drive.
- Crews removed 0.8 acres of green waste from Roger's Point.
- Crews continue to assist the Streets Division in paving sewer asphalt repairs.
- Sewer Mains: Daily preventative maintenance performed on over 7,490 linear feet of sewer main lines.
- Quarterly Sewer Main Cleaning: The route schedule is under review to increase inspection frequency of identified 'hot spots' and integrate a proactive preventative cleaning schedule for the hot spots.

- CIP Projects: Crews televised 7,016 feet of sewer main lines and 20 public sewer laterals in preparation of CIP's Pavement Management Cape Seal project.
- Overflow Emergency Response Trailer: The design and build of the overflow response trailer is in process, this equipment supports Overflow Emergency Response Plan (OERP) and Sewer System Management Plan (SSMP) programs.
- Manhole Inspection Program: Manholes are inspected for loose lids, debris, locking mechanisms and status of infrastructure for future maintenance and rehabilitation. We are updating the program and processes for integration in our computerized maintenance management system.
- CCTV (Closed Caption Televising): The CCTV preventative maintenance program is under development for inspection of sewer mains to identify the condition and causes of blockages and SSOs.
- NPDES (National Pollutant Discharge Elimination System): Removed 61 yards of debris and trash out of various creeks and channels. These activities ensure the City meets the federal Clean Water Act requirements of municipalities discharging storm water into waterways.

Public Works Maintenance Operations – Fleet Maintenance

- Preventative Maintenance: 13 services on City vehicles as scheduled.
- Unscheduled Repairs: 45 unscheduled necessary repairs to City vehicles.

<u>Marina</u>

- Received and responded to three new inquiries and gave one tour of the facility.
- Diablo Power and Sail Squadron held their "America's Boating Course" at the Antioch Public Works' training room educating boaters while promoting the Antioch Marina.

POLICE DEPARTMENT UPDATES
