RECREATION UPDATES

- Last Week, staff removed the Dome from the Lap Pool and stored it for the spring and summer seasons.
- On Monday and Tuesday, staff made multiple repairs related to vandalism including the reinstallation of seating in the grand plaza and miscellaneous graffiti abatement.
- Throughout the week staff continued preparation work for the fast approaching
 Water Park season. Some highlights from this week's work include the installation
 of a new split rail fence to guide patrons to the safest possible direction of travel, as
 well as a facility walk through with the City's landscape maintenance vendor to plan
 for pre-season maintenance activities.

- Everyone into the water! 2015 Water Park Season Passes are on sale now.
 Purchase before May 22, and save 25%. Passes can be purchased online, or at the Antioch Community Center.
- The Recreation registration information states that nearly 1,100 participants have enrolled in classes and activities in the winter 2015 quarter. Spring classes are filling now – it is easy to sign up on-line!
- Reports indicate that the facility rental program increased revenue 27% compared to the revenues at this same time in 2014. Staff has updated informational materials and rental applications to improve customer service.
- Last week, contractor agreements were drafted and mailed to all Instructors teaching classes and programs for the summer 2015 session. Start planning your "staycation" now; Antioch is where you want to be!
- Last week, youth dance classes wrapped up their winter session and many parents stopped in the Community Center to see the final classes. Dancers were preparing for the special recital scheduled for March 7, 2015.
- Play Ball! Forty-six adult softball teams have signed up to play in the summer league. Friends and family can cheer their favorite player without leaving town.
- Last week, four proposals were submitted by qualified design teams in response to the RFP for design services for the final phase of Prewett Community Park. Staff is reviewing each proposal.

Senior Center Services

- Last week, staff interviewed candidates to fill the part-time Maintenance Helper position located at the Antioch Senior Center. A candidate was selected and recommended to Human Resources.
- On Tuesday, the Chinese Senior Peer Counseling group hosted a Chinese New Year Celebration. Participants had a joyful time watching a traditional dragon dance, poem readings, and partaking in Chinese New Year cuisine.
- The Antioch Senior Center March/April 2015 Newsletter was completed and mailed out to over 400 participants. E-mail distribution has been submitted to over 400 senior participants.
- Last week, 381 affordable, healthy meals were served. No membership or income requirements are required to eat at the C.C. Café.
- On Tuesday, City Staff attended the Antioch Senior Citizen's Club Board of Directors meeting. Staff provided input and direction on various topics such as upcoming Club activities, volunteer recognition, and fundraising opportunities.
- On Thursday, 8 people joined the "Get Up and Go with the Director" walk. The
 group strolled to City Park and stopped by several historic homes, including the
 Belshaw Mansion. A first-time walker joined the group after hearing that walking is

- Housing Element The City has been notified by the State Department of Housing and Community Development that our 2015-2023 Revised Draft Housing Element of the General Plan meets the requirements of State housing element law. The next steps are that the Planning Commission will hold a public hearing on the Revised Draft and an environmental Negative Declaration (ND) on March 18, 2015 to consider public input, and a recommendation that the City Council adopt the Housing Element and ND. The City Council would next conduct a public hearing on April 14, 2015 to consider public input, the Planning Commission recommendation, and adoption of the ND and Housing Element. CDBG & Housing Programs - Our Housing staff is working with staff from the Association of Bay Area Governments (ABAG) on reporting the status of affordable and market rate housing production during 2007 – 2014 for the Regional Housing Needs Allocation (RHNA). The RHNA is the state-mandated process to identify the total number of housing units (by affordability level) that each jurisdiction must accommodate in its General Plan Housing Element. As part of this process, the California Department of Housing and Community Development (HCD) identifies the total housing need for the San Francisco Bay Area for a multi-year period (in this case, from 2007 to 2014). ABAG and the Metropolitan Transportation Commission (MTC) must then develop a methodology to distribute this need to local governments in a manner that is consistent with the development pattern included in the Sustainable Communities Strategy (SCS). Once a local government has received its final RHNA, it must show how it plans to accommodate its portion of the region's housing need in its Housing Element.

PUBLIC WORKS UPDATES

Administration

- PG&E has begun work on their 27-mile Contra Costa to Moraga 230 Kilovolt transmission line upgrades. This 27-mile project will begin in Antioch. Work which will involve raising transmission towers and replacing existing lines began in January and is scheduled to continue through May in Antioch. Crews and contractors will use helicopters and truck-mounted cranes to perform the work. Work will generally occur daily between 7:00 a.m. and 5:00 p.m. PG&E has fenced the area they will be utilizing at Chichibu Park. They will also be staging work at another site near the Mira Vista Hills Reservoir off Cambridge Drive during much of the construction in Antioch as staging and construction locations for their operations. - A nighttime (10 p.m.–5 a.m.) full closure of the Contra Loma Blvd. undercrossing is scheduled for March 9-12 to install bridge girders.

Engineering & Development Services

- Almondridge East Subdivision 8880, an 81-unit single family home development by KB Homes, located between East 18th Street and Oakley Road, east of Phillips Lane and west of the State Highway 160: Staff is reviewing plot plans for new home construction.
- Buchanan Crossings Shopping Center, a 103,139 square foot commercial center on a 13.5-acre site located at the northwest corner of Somersville Road and Buchanan Road: Staff is reviewing a second revision to the approved plans and construction submittal documents. Parcel map, appurtenant easements, right-of-way dedications and quitclaim deed sent to the County Recorder's Office for filing. Grading and construction of improvements begun. Phase 2 environmental clearance and USBR permit in process.
- Cellular Providers on City-owned Property: Metro PCS is decommissioning their Via Dora site. Verizon Wireless is applying for a new cell site near Folsom Drive. AT&T is pursuing a lease modification for their James Donlon site. Crown Castle is seeking to renegotiate a lease for their Putnam Drive site and has reimbursed the City for contractor damages at the Via Dora site.
- City Sports Club, located at 5001 Lone Tree Way: At the developer's request, staff returned "at risk" plan check comments and approved lot merger and easement vacation documents pending a Planning Commission hearing.
- Contra Loma Estates HOA Privatization: Contra Loma Estates HOA has applied for a permit to privatize their interior roads and install security gates and fencing at the entrances to their subdivision. Staff has requested additional documentation. Planning Commission and City Council approvals are required.
- Delta Bowl Parking Lot: Staff is plan checking a new parking lot.
- Golden Bow Estates HOA Privatization (PW 652): Golden Bow Estates HOA has applied for a permit to privatize their interior roads and install security gates and fencing at the entrance to their subdivision. Planning Commission and City Council approvals are required.
- Laurel Ranch, a 186-unit housing development by Richland Communities, located at the eastern terminus of existing Laurel Road and west of Highway 4: The developer is preparing a final development plan submittal.
- Nelson Ranch Unit 1 Subdivision 6893, a 102-unit housing development by Standard Pacific Housing, located northeasterly of Wild Horse Road and Ridgeline Drive and southwesterly of State Route 4: Revisions to include the Wild Horse Road undercrossing in the 2011 State Freeway Maintenance Agreement are in progress. Developer is removing graffiti from sound walls along SR4.
- Oakley Knolls Subdivision 9353, a 31-lot development by Discovery Builders, located north of Oakley Road 1,300 feet west of Phillips Lane: Staff is preparing conditions of approval for the tentative map application.
- PG&E Lot Line Adjustment, located at the southwest corner of Somersville Road/Buchanan Road intersection: Staff approved lot line adjustment documents for recording purposes.

- Taco Bell, 1706 'A' St.: Staff prepared conditions of approval for a use permit application.
- Wilkinson-VanSandt LLA: Application has been made for a lot line adjustment between 4316 and 4325 Berryessa Ct.
- SR4 (Segment 2) Contra Loma Blvd. Interchange/'G' Street Overcrossing Project: Punchlist items are being completed for the 'G' Street bridge and a nighttime (10 p.m.–5 a.m.) full closure of the Contra Loma Blvd. undercrossing is scheduled for March 9-12 to install bridge girders.
- SR4 (Segment 3A) 'A' Street/Lone Tree Way Interchange, Cavallo Road/Garrow Drive Undercrossing Project: Bridge construction is underway at the Lone Tree Way/"A" Street and Cavallo Road undercrossings. A nighttime (10 p.m.–5 a.m.) full closure of the 'A' St./Lone Tree Way undercrossing is scheduled for March 5th for bridge work.
- SR4 (Segment 3B) Hillcrest Ave. Overcrossing/Slatten Ranch Road Project: Staff is meeting with CCTA and engineer to resolve curb return design issues.
- eBART Parking Lot and Maintenance Facility: The Contractor has requested permit final on the encroachment permit for Slatten Ranch Road improvements. Staff is reviewing plans and easement dedications for a proposed 12" sanitary sewer main from the new Maintenance Facility north underneath the S.P.R.R. railroad line and along the extension of Willow Avenue from Oakley Road.
- SR4 Lone Tree Way Four-Lane Widening/ Sand Creek Road Interchange Project: Contractor expects to complete the installation of irrigation and landscaping in the Lone Tree Way/SR4 "Bypass" undercrossing median by mid-March.
- Davidon Homes Park Ridge, Phase I consisting of 123 residential units located west of Canada Valley Road and east of Highway 4: plans and maps have been resubmitted for second review.
- Wal-Mart expansion: processing easements and vacation of existing easements.
- Deer Valley Business Park, commercial development fronting Country Hills Drive between Lone Tree Way and Deer Valley Road: processing abandonment of existing easement.
- The Vineyards at Sand Creek, a proposed 641 unit housing development located on Sand Creek Road between Heidorn Ranch Road and Hillcrest Avenue: Staff continues to meet with the developer to discuss various site and infrastructure issues.
- Aviano, a proposed 533 unit housing development located on Sand Creek Road west of future Hillcrest Avenue: Staff continues to meet with the developer to discuss various site and infrastructure issues. The revised tentative map has been submitted for review and staff is updating conditions of approval.
- The Ranch, a proposed 1,667 unit housing development located between Deer Valley Road and Empire Mine Road: Staff is preparing comments for preliminary development plan.

Capital Improvements Division

- Somersville Road Widening: The developer is working with PG&E to resolve electrical power issues. The traffic signal and street lights will be energized as soon as the issue is resolved.
- Sanitary Sewer Main Replacement at Various Locations: RGW Construction is installing new sanitary sewer service laterals on Birch Avenue and performing pressure testing on recently installed pipelines.
- Williamson Ranch Plaza Water Main Replacement: D.R. Lemings is performing bacteriological testing of the new water main on the western side of Williamson Ranch Plaza. Tie-in connections are expected to commence next week.
- Piping Reconfiguration of Canal Pumps 2 and 4 and Pump 2 Replacement: Con-Quest Contractors has installed the new tee on the raw water pipeline adjacent the Canal West Pumping Station. Tapping saddles have been mounted on the discharge piping at the Canal East Pumping Station in preparation of next week's line stop installation.
- Curb, Gutter and Sidewalk Repair Program: Anchor Concrete continued to remove and replace deteriorating, damaged and uneven concrete throughout the City. Over the past week one storm drain catch basin top, 377 square feet of sidewalk, and 127 lineal feet of curb and gutter were repaired. One new curb ramp was constructed.
- Raw Water Pipeline Inspection & Assessment: PSC performed closed circuit televising of the raw water pipeline adjacent the Canal West Pumping Station.
- Community Block Grant Downtown Roadway Pavement Rehabilitation: Contract
 documents and material submittals are under review for the asphalt and concrete
 rehabilitation on West Second Street from 'J' to 'L' Streets, West Third Street,
 between 'I' and 'J' Streets, West Fifth Street from 'J' to 'L' Streets and 'K' Street
 from West Second and West Tenth Streets. Work on this project is scheduled to
 commence in the next week.
- Ninth Street Roadway Improvements: Contract documents and material submittals are under review for the asphalt and concrete rehabilitation on West Ninth Street from 'A' to 'H' Streets. Work on this project is scheduled to commence in the next week.
- Marina Boat Launch Facility, Third Boarding Float: Project plans and specifications are available for purchase at a cost of \$75 per set. The public bid opening for this project is scheduled for April 7, 2015, at 2:00 p.m. in the City Council Chambers located at 200 "H" Street.
- West Antioch Creek Channel Improvements: RMC Water and Environment has developed a draft technical memorandum in response to the comments provided by the Contra Costa Flood Control District. The Contra Costa County Public Works Real Property Division is continuing work related to the property and easement acquisitions.

- Water Treatment Plant Disinfection Improvements: Requests for Proposals have been sent to various engineering consulting firms to perform comprehensive feasibility studies and alternative analysis on various disinfection processes to replace the existing chlorine gas pre-treatment and post-treatment currently utilized at the City's Water Treatment Plant. Consultant responses are due March 31st.
- Rubberized Cape Seal Program: The City Council awarded the 2015 Pavement Maintenance Cape Seal project to the low bidder, American Pavement Systems. Construction is scheduled to start June 8, 2015, and be completed by July 31, 2015.
- 2015/2016 Transportation Development Act (TDA) grant: Staff met with the Countywide Bicycle Advisory Committee to field review the grant application to MTC to install 35 new curb ramp locations along "A" Street, Blue Rock Drive and West Tregallas Road.
- Safe Routes to School Grant (Cavallo/Garrow/E. Tregallas curb ramps): Staff opened bids for the installation of 85 curb ramps and sidewalk improvements along Cavallo Road, Garrow Drive, East Tregallas Road and Drake Street. The City Council awarded the construction contract at the February 24th meeting to JJR Construction. Construction is scheduled to start in April 2015.
- Transportation Impact Fee Study: The kick-off meeting was held February 24th and the study is scheduled to be completed within a 12 month period.
- Preventative Pavement Maintenance Program: Staff has identified a list of streets for pavement "Dig Out" construction to repair pothole and pavement failure areas. Staff opened bids for the project on February 17th. The City Council will consider awarding the construction contract at the March 10th meeting. Construction of the project is scheduled for April 2015.
- Cavallo Road and Country Hills Drive Pavement Rehabilitation: Project plans and specifications are available for purchase at a cost of \$75 per set. Copies may be obtained by logging on www.blueprintexpress.com/antioch or by calling BPXpress Reprographics at (707) 745-3593. The public bid opening for this project is scheduled for March 17, 2015, at 2:00 p.m. in the City Council Chambers located at 200 "H" Street. Construction is scheduled for May 2015.
- Prewett Park Improvements: Staff received four proposals for consultant services for the design of the final improvements at Prewett Park, which will include a splash/spray park area, multi-age group outdoor playground, lighted basketball sport court with security fencing, group picnic area with a shade structure, and a digital marquee monument sign. Construction is anticipated to start in January 2016.

Traffic Engineering

 Engineering and Traffic Surveys: Staff is proposing several speed limit changes based on the Engineering and Traffic Surveys recently completed and cleanup of the municipal code section 4-5.1501 (Speed Limits). The Ordinance was introduced at the February 24th City Council meeting. The Council requested additional speed limit changes that will be incorporated into the Ordinance and presented to the Council on the March 10th City Council meeting for adoption. • Staff is coordinating the installation of an electric vehicle recharging station at the City Hall parking lot, 200 "H" Street. Installation is anticipated in early March. The station will be part of the "ChargePoint" system and available to the public.

Water Treatment Plant

- The WTP is taking treated water from CCWD's MPP connection at the Hillcrest pump station.
- "A" plant has been taken out of service so that work can be performed in "A" clear well.
- The river pump has been in service for the last couple of weeks, providing raw water to the Municipal reservoir.
- Cleaned solar bees out on the reservoir. Also cleaned the staff gage on the tower.
 This is reoccurring and ongoing.

Water Distribution

- There were 211 stops for water service including disconnections.
- There were a total of 52 USA tickets completed for utility location.
- Meter reading for the month of March has started.
- Annual backflow test program continues and is on schedule.
- Water crews have started meter testing program to monitor water conservation and usage.
- Water crews are continuing to maintain the backfill material area and dumpster area at Fulton Yard.
- Water field tech continues responding to customer related calls citywide.
- Water crews replaced a two-inch meter and valve on "G" St.
- Water crews are repairing a 30" main line valve at the Water Treatment Plant.
- Water crews are installing a new 10" backflow device on Golf Course Rd.
- Water staff second shift continues citywide fire hydrant preventative maintenance program.
- Stores staff continues updating MSDS/SDS files for corp yard.
- Stores staff replaced stolen trash cans and removed debris from boat ramp.
- Stores staff continues removing graffiti from Amtrak.

<u>Public Works Maintenance Operations – Parks and Landscape</u>

- Diablo West Park, 2000 Prewett Ranch Dr., and Gentrytown Park, 2800 Carmona Way, were the recipients of new roof replacements this week. The old roofs had completed their time and were in need of replacement. Stop by and check them out.
- City Park, 1000 A St., has a brand new tire swing with new chains and hangers. It was replaced with absolutely no "swing down time".
- Markley Creek Park had the play surface under the playground swings repaired and is back in use.

- Chaparral Park at 5100 Prewett Ranch Drive had its old swing hangers removed and replaced with new ones for safety purposes.
- Knoll Park at 5000 Country Hills Drive has two new swing chains and new swing hanger bushings, replacing the old ones for safety.
- Tree Removal Permits: Processed and approved at 1919 Chestnut Ave.
- Irrigation leaks were attended to and repaired.
- Annual Roadside Spray Program: Initiated and ongoing with the Streets Division.
- Spot Spraying: Laurel Rd., Delta Fair Blvd., Country Hills Dr., Buchanan Road medians, Vista Grande Dr. and Prewett Ranch Dr.
- Trim: Laurel Rd. and Wildhorse Dr.
- Tree Limb Removal: Lone Tree Way and Country Hills Dr.
- Tree Removals: Roanwood Ct. and Dewlap Ct.

Public Works Maintenance Operations – Street Maintenance

- Annual Weed Abatement Spray Program: Initiated and ongoing with the Parks Division.
- Debris: 37 yards removed from the rights of way.
- Graffiti removed from City property in numerous areas.
- Potholes: Four potholes filled.
- Saw Service Cuts: Cut 1,020 feet of asphalt in preparation for paving service cut repairs.
- Pave Service Cuts: 13 service cuts paved.
- Signs: 33 signs replaced due to poor reflectivity.

<u>Public Works Maintenance Operations – Collections Division</u>

- Calls for Sewer Service: Received and responded to 12 calls for service from the public, responding crews televised 42 public sewer laterals connecting to the City's sewer system.
- Sewer Mains: Daily preventative maintenance performed on over 18,734 linear feet of sewer main lines.
- Quarterly Sewer Main Cleaning: The route schedule is under review to increase inspection frequency of identified 'hot spots' and integrate a proactive preventative cleaning schedule for the hot spots.
- CIP Projects: Crews televised 3,184 feet of sewer main lines and 41 public sewer laterals in preparation of CIP's Pavement Management Cape Seal project.
- Training: Crews were trained on bypass pumping, sump pumps, how to operate and trouble shoot the City Hall lift station and were fit tested for respirators.
- Overflow Emergency Response Trailer: The design and building of the overflow response trailer is in process. This equipment supports OERP/SSMP programs.
- Manhole Inspection Program: Crews inspected 32 manholes. Manholes are inspected for loose lids, debris, locking mechanisms and status of infrastructure for future maintenance and rehabilitation. We are updating the program and processes for integration in our computerized maintenance management system.

- CCTV (Closed Caption Televising): The CCTV Preventative Maintenance program is under development for inspection of sewer mains to identify the condition and causes of blockages and SSOs.
- NPDES (National Pollutant Discharge Elimination System): Crews removed 22 yards of debris and trash out of various creeks and channels. These activities ensure the City meets the federal Clean Water Act requirements of municipalities discharging storm water into waterways. Proactive preventative maintenance is restricted to the months of April through October.

Public Works Maintenance Operations - Fleet Maintenance

- Preventative Maintenance: 16 services on City vehicles as scheduled.
- Unscheduled Repairs: 53 unscheduled necessary repairs to City vehicles.

POLICE DEPARTMENT UPDATES

 On 3/2/15 at 1115pm Officer Moraga and Officer Green were travelling south on Somersville Road when they heard gun shots coming from the area of Hudson Court. The officers noticed a vehicle leaving the area with no head lights on and driving at a high rate of speed. The officers followed this vehicle and attempted a traffic stop when a pursuit ensued. The vehicle eventually lost control and drove into the detached garage of 1732 Mahogany Way. Three people from the vehicle were taken into custody. (Richard Ludlow (18 years), Tony Belfield (33 years) and Kimberly Saunders (36 years)) Approximately 30 minutes later while still dealing with these 3 subjects, we received a call of an unresponsive male on Hudson Court. Officers arrived and located Christopher Monico (21 years) deceased on the sidewalk in front of the apartment complex with a gunshot wound to his face. A sawed-off shotgun was found near the Double Dragon restaurant. The shotgun had been thrown from the vehicle during the pursuit. All 3 subjects were arrested for the murder of Monico.

- On 3/3/15 at 1214pm the US Marshalls asked APD for code 3 cover in the area of 17th Street and G Street. They had been in town conducting surveillance trying to track down a wanted homicide suspect. They conducted a traffic stop on a vehicle that they believed the homicide suspect was a passenger in. The person they believed was the homicide suspect fled the traffic stop on foot. Officers from Antioch, Oakley, and Concord arrived to assist and Antioch High School was locked down. While Concord PD K-9's were doing a yard to yard search they located the suspect who fled from them in the backyard of 621 West 15th Street where he was taken into custody without incident. A loaded firearm and narcotics were found where the suspect had been hiding. The subject taken into custody was not their homicide target, but a secondary wanted target who is 17 years old.
- On 3/5/15 at 0938 am, officers responded to the 1100 block of Cardiff Court for a burglary in-progress. The homeowner came home and found 4 men inside of her home. She was able to give responding officers a vehicle description and a direction of travel. An officer was able to spot the suspect vehicle before it got onto west bound Highway 4. The vehicle had been reported stolen out of San Leandro. When officers tried to initiate a traffic stop on Highway 4, the vehicle took off at a high rate of speed and a pursuit ensued. Eventually CHP took over for APD and the pursuit was terminated when the vehicle lost control and crashed near the Treat Blvd. exit in Walnut Creek. 3 subjects were taken into custody after the crash and all of the victim's stolen property was recovered. A loaded firearm was found in the center console of the stolen vehicle. Those arrested were a 16 year old juvenile, Robnell Bellott (21 years), and Alvin Johnson (18 years)

CITY MANAGER'S NOTES

On Tuesday, I attended the quarterly "Delta Six" lunch with Mayor Harper, which was hosted this time by the City of Pittsburg. Delta Six is comprised of the Mayors and City Managers of the cities of Antioch, Brentwood, Oakley and Pittsburg, and our two County Supervisors and their Chiefs of Staff. The main topics of discussion were the establishment of an "East County Justice Center" to serve victims of domestic violence, human trafficking and other violence against women and children. West and Central County will soon be served by new centers in Richmond and Concord (Richmond relocating and expanding, and Concord opening on March 19th). There will be presentations to all four City Councils in the coming weeks.

On Wednesday, I attended a meeting on how to structure a City managed program using volunteers to provide for a Trap-Neuter-Release (TNR) program while not allowing rouge feeding of feral cats. The goals will include reducing the feral cat population along the waterfront, reducing impacts on the natural habitat and public places and eliminating rogue feeding. Additional meetings to work out details with Homeless Animal Response Program (HARP) and others are planned.

On Thursday, I attended the Mayor's Conference, which was hosted this month by the City of Martinez. Mayor Harper, as Vice Chair, chaired the executive committee meeting and the general meeting. Mayor Pro Tem Ogorchock also attended the general meeting.
