Our office received 9 California Public Records Act requests this week and forwarded them to the appropriate departments for a response.

The California Primary Election will be held on Tuesday, June 7th. If you have recently moved to Antioch or want to change your registration, Voter Registration forms are available at the Antioch City Clerk's Office on the first floor of City Hall. The forms are hanging on the wall and no postage is required to mail them. Antioch voters will be interested in two City of Antioch ballot measures and the races for District 3 and District 5 County Supervisor, along with the State Assembly, State Senate, Congressional, Senatorial and Presidential primaries. Get involved, register, study the issues, question the candidates and make your vote count!

The City Clerk was contacted by the County Elections Office to discuss the possibility of setting up an early voting station at the Prewett Water Park. The Prewett Community Center was ruled out because offices for Assemblyman Jim Frazier and Congressman Jerry McNerney were located there. The County Elections Office is considering setting up 6 early voting stations around the County. Secretary of State Alex Padilla discussed this initiative with the League of California Cities' Administrative Services Policy Committee, on which City Clerk Arne Simonsen has been a member for the past three years.

On March 7th, Joy Motts (representing the proponent, Jim Lanter) submitted the affidavit of publication of the notice of intention and ballot title & summary (EC 9206) to the City Clerk along with two copies of the draft petition. On March 9th, the City Clerk sent a letter and email to the proponent for changes to the draft petition to comply with the Elections Code requirements. On March 10th, a revised draft with the requested changes was submitted to the City Clerk who approved their petition for circulation.

The City Clerk administered the Oath of Office to newly appointed Eduardo Cendejas (Sales Tax Citizens' Oversight Committee) and Robert Kilbourne Sr. (Economic Development Commission).

The City Clerk received the ballot arguments and City Attorney's Impartial Analysis for the two City Ballot Measures that will appear on the June 7th Primary ballot.

RECREATION UPDATES

- Last week, returning employees working at the Antioch Water Park continued with the re-hiring process. Staff will be ready to provide the best water experience for guests of all ages. Purchase your annual pass now so that you can **BE COOL BY** THE POOL in 2016!
- The Recreation Department is still looking for seasonal recreation leaders, lifeguards, and maintenance workers. Encourage the young adult in your family to apply. Staff will provide training for lifeguard certifications!
- On Thursday, staff visited Antioch high school campuses to recruit summer staff.
- If you have a middle school student interested in learning leadership skills and getting work experience have them join the new Recreation Department volunteer program. Applications will be available at the end of March. The Water Park has excellent volunteer experiences that will prepare these teens for life.
- Last week, staff finalized the 2016 Water Park Brochure; it will be delivered to the printer next week and then distributed throughout the community.
- On Saturday, the first group of lifeguard candidates completed their skills test.
- On Monday, Recreation Maintenance Staff completed installation work on the new Lap Pool boiler.
- On Tuesday, a factory representative was on site to complete the start up process for the new Lap Pool Boiler. A few issues arose and will need to be corrected by the factory before the boiler can be put into service. All worked completed by the City passed inspection by the factory. Staff will schedule a building inspection once the factory representative has completed the necessary additional work.
- On Wednesday, Recreation and Public Works staff collaborated on the future of the City's Public Access Defibrillation (PAD) Program. There will be some key changes to improve this emergency response program.
- Last week, staff met to exchange ideas and begin planning for the 2016 Adventures in Fun and Fitness Summer Drop-In Park Program for children 1st -6th grade. This valuable playground program features nutrition education, fun fitness activities and arts & crafts that will be held at City Park & Contra Loma Estate parks beginning July 2016. New supervisory staff this year will be incorporating exciting components including a new, "Let's Move" campaign designed to increase both the amount and range of children's physical activity.

- A new monthly e-mail campaign utilizing a newsletter format is being released in the
 month of March. These beautifully designed newsletters will promote events and
 activities, and is specifically made to look great on any screen, desktop, tablet or
 smartphone! Social media buttons are incorporated right onto the newsletter in
 addition to links that take you right into program registration. E-mail's are now being
 tracked to see who's clicked, opened and shared our newsletter.
- Last week, Recreation staff attended the California Park and Recreation Society statewide education and training conference; learning new skills, picking up new program ideas and networking with colleagues from around the State.

Senior Center Services

- Last week, 420 affordable healthy meals were served through the C.C. Café. Lunch and socialization help prevent heart attacks, depression, asthma and congestive heart failure. No membership or income requirements are required to eat at the C.C. Cafe. All supplies are provided by the County for participating cafes. Staff collects the daily nutrition deposits and submits them to finance.
- On Tuesday, staff attended the Board Meeting for the Senior Citizen's Club. They discussed programs and activities such as volunteer appreciation day, the senior picnic, and St. Patrick's Day festivities.
- Last week, staff connected with various service agencies including Clear Captions, senior center without walls, crime prevention strategies, and opportunities for reverse mortgage.
- On Thursday, AARP was on site to work with seniors on their 2015 tax returns. All available appointments were filled.
- To date the Senior Club has received new and renewal membership applications from 670 Seniors. Membership is only \$20 for the year; sign up friends and family who enjoy meeting new friends and staying active and healthy.

CDBG:

- The CDBG Council Subcommittee will meet at the end of March to make their recommendations for second year renewal funding. The 2016-17 Action Plan will go before the City Council May 10th.
- Consortium members met with the consultant hired to update the HUD-required Analysis of Impediments to Fair Housing Choice for the 2016-20 period.

Housing:

 Housing Consultant was trained on the new CDS Housing Loan Compliance system and has begun the process of entering additional information on each loan to complete all fields.

Homeless:

 The next General Meeting of the Contra Costa Homeless Continuum of Care is April 15, 2016, and all are invited. We will continue with panel presentations about the criminal justice system and homeless persons. Meetings are held in the ZA room at 30 Muir Road, Martinez from 10 am -12 pm.

Drought Updates:

In February, Antioch Water Customers used 16% less than in 2013. This takes our cumulative total to 29.79% since last summer. We must maintain a minimum reduction of 28% cumulatively in order to stay in compliance with the State's drought regulations. These regulations were set to expire in February, however California is still experiencing severe drought despite recent rains. The State Water Resources Control Board (State Water Board) adopted on February 3, 2016, an extended and revised emergency regulation to ensure that urban water conservation continues in 2016. The regulation extends restrictions on urban water use through October 2016.

Last Week's Irrigation Repairs and Service:

Citywide Parks: All Parks water is off.

Chichibu Park: A leaking hose bib was shut down pending repair.
 City Park: The soccer field turf is undergoing a complete renovation, and is temporarily closed to the public.

- Delta Diamond: The baseball field turf and infield is in the process of renovation at Gentrytown Park. The field is temporarily closed to the public. Water is off.
- Marchetti Park: A leaking toilet was repaired.
- Markley Creek Park: The doggie drinking fountain, stuck on, was repaired.
- Recycled Water Parks: First quarter inspections were completed at Chichibu, City, Fairview and Mountaire Parks.
- Almond Tree Ct. Repaired 1" irrigation mainline.
- Goldpine Ct. Rebuilt 1" irrigation valve.
- Buchanan Rd. Repaired lateral line.
- Hillcrest Ave. Replaced 1.5" irrigation valve, capped off 1" irrigation valve and repaired a leaking quick coupler.
- Gentrytown Dr. Replaced 1.5" irrigation valve.
- Putnam St. Repaired 4 sprinklers.
- Dallas Ranch Rd. Replaced 1.5" irrigation valve.

PUBLIC WORKS UPDATES

Administration

- Due to the current and predicted El Niño rains, Public Works has procured extra sand bags and sand, as well as ensuring staff is ready for action 24/7. The City website will have additional information about what the City is doing and how the community can better prepare for the possibility of severe storms.
- February 2016 brings us to the end of the initial water conservation mandate issued by the State of California. The City of Antioch was required to conserve 28% based on 2013 usage through the month of February 2016. Thanks to your outstanding efforts, our total cumulative reduction since July 2015 is 29.78%. At the end of January 2016, the State extended its mandatory conservation order through October 2016. Final guidance is still being worked out as the State monitors the snow pack and reservoir levels through this winter. Please continue to conserve this valuable resource and plan on conserving throughout 2016. Outdoor water conservation will be the primary focus of the City's program, as well as fines for wasteful practices as identified in the Water Conservation Resolution adopted by the City Council on May 12th. All Antioch customers were mailed a letter explaining the program and prohibitions, as well as 2013 monthly water usage. Examples of prohibitions are: three day per week residential outdoor watering, no watering between the hours of 9:00 a.m. and 5:00 p.m., shut off nozzles required on all hoses, and drinking water available only upon request at restaurants. Contra Costa Water District has incentives, such as residential high-efficiency clothes washer rebates, water-efficient landscape rebates and smart sprinkler timer rebates. Engineering & Development Services

- Almondridge East Subdivision 8880, an 81-unit single family home development by KB Homes, located between East 18th Street and Oakley Road, east of Phillips Lane and west of the State Highway 160: Staff is reviewing plot plans for ongoing new home construction and provided a punch list for offsite improvements (bond reduction purposes).
- Buchanan Crossings Shopping Center, a 103,139 square foot commercial center on a 13.5-acre site located at the northwest corner of Somersville Road and Buchanan Road: CVS and Grocery Outlet stores are open for business and other building pads are in development and planning stages. Environmental clearances and USBR permitting requirements for the Phase 2 development are in progress. Staff is processing a request for reimbursement for Somersville Road widening.
- City Sports Club, located at 5001 Lone Tree Way: A temporary certificate of occupancy has been issued.
- City-owned cell sites, various locations: Staff is performing site visits and review of land leases, 100% construction drawings, consent letters, photo-sims and related technical reports and materials for equipment upgrades and site modifications.
- Laurel Ranch, a 186-unit housing development by Richland Communities, located at the eastern terminus of existing Laurel Road and west of Highway 4: Staff is reviewing the final development plan and preparing project conditions of approval. Staff is working with the developer to reduce illegal trespassing on the unimproved site.
- Nelson Ranch Subdivision 6893, end of Wildhorse Road: Staff performed a site inspection and provided a punch list in response to the developer's request for warranty bond release.
- Oakley Knolls Subdivision 9353, a 31-lot development by Discovery Builders, located north of Oakley Road 1,300 feet west of Phillips Lane: Staff met to discuss conditions of approval for a tentative map application.
- Park Ridge Phase I, a 123-unit housing development by Davidon Homes, located west of Canada Valley Road and east of Highway 4: The subdivision map check has been completed by the City's consultant. The developer has blocked illegal access to the property with K-rail.
- SR4 (Segment 2) Contra Loma Blvd. Interchange/'G' Street Overcrossing Project: The project has been presented to the State for acceptance. The eastbound Contra Loma Blvd. on-ramp will remain closed temporarily for SR4 mainline construction.
- SR4 (Segment 3A) 'A' Street/Lone Tree Way Interchange, Cavallo Road/Garrow Drive Undercrossing Project: Work continues on the 'A' St./Lone Tree Way interchange, the Cavallo Road Overcrossing, and the new Sunset Drive from Bryan Avenue to "A" Street extension. Slope paving and sidewalk reconstruction is underway. Pedestrians and motorists are advised to exercise caution while travelling through these areas.
- SR4 (Segment 3B) Hillcrest Avenue Interchange and BART Tunnel Project: Work continues on the Hillcrest Avenue Bridge widening, the Pedestrian Overcrossing

- (POC) and the Maintenance of Works (MOW) Tunnel. Pedestrians and motorists are advised to exercise caution while travelling through this area.
- BART Parking Lot and Maintenance Facility: Staff approved the design for a
 proposed 12" sanitary sewer main from the new Maintenance Facility, north of the
 S.P.R.R. railroad line to the southerly extension of Willow Avenue and is reviewing
 grant deeds for public easement dedications. Staff returned comments to BART's
 Ownership and Maintenance of Utilities Agreement for storm drainage
 improvements.
- Quail Cove, a proposed 32 unit housing located on the south side of Prewett Ranch Drive west of Heidorn Ranch Road: Staff met to discuss conditions of approval for a tentative map application.
- Aviano, an approved 533 unit housing development located west of the current terminus of Hillcrest Avenue, east and north of Dozier-Libby Medical High School: Staff is working with developer on Chaparral park extension. First phase of construction documents have been resubmitted to City for the 2nd plan check.
- Working with consultant on finalizing sewer study for the Sand Creek Focus Area.

Capital Improvements Division

- Water Main Replacement at Various Locations: D&D Pipelines is completing the remaining punch list items.
- West Antioch Creek Channel Improvements: A request for authorization to execute a purchase agreement with the Twenty-Third District Agricultural Association for right of way and easements within the footprint of the Contra Costa Fairgrounds is scheduled to be considered at the City Council meeting on March 22nd. Contra Costa Real Property Division is developing a revised purchase agreement for the properties located at 1400 and 1420 West 10th Street. U.S. Fish and Wildlife is continuing to review the project's biological assessment. Staff and RMC Water and Environment met to review the 100% draft project plans and specifications. RMC is revising the documents accordingly.
- Zone I Transmission Pipeline Rehabilitation at HWY 4: RMC Water and Environment has begun preliminary design activities. Geotechnical borings in the location of the insertion and receiving pit are expected to be performed later this month.
- Urban Water Management Plan Treatment: Staff is performing a water loss audit in accordance with AWWA standards.
- Water Treatment Plant Electrical Upgrades: A draft Electrical Field Reconnaissance memorandum submitted by TJC and Associates is under review by Capital Improvements and Water Treatment Plant staff.
- Brackish Water Desalinization Plant: The State Water Resources Control Board is reviewing the application for a State Revolving Fund loan for the next phases of planning, engineering, and environmental certification.
- Water Treatment Plant Disinfection Improvements: A response to public comments received on the CEQA document is being prepared. Staff and CDM Smith met to

- review the 90% draft project plans and specifications. CDM Smith is revising the documents accordingly.
- Country Hills Drive and Vista Grande Drive Water Main Replacement: A-S
 Pipelines, Inc. is compiling the required documentation for the execution of the
 contract for the installation of new domestic water facilities on Country Hills Drive
 from Vista Grande Drive to Canada Valley Road and Vista Grande Drive from Lone
 Tree Way to Country Hills Drive.
- Transportation Impact Fee Study: Staff is working with the consultant, EPS, to finalize the land use forecasts and the transportation improvement list and network to be used in the traffic model. The final draft Fee Study will be presented to the City Council for public review and comments in May 2016.
- Prewett Water Park Improvements: RHAA completed the design of the final improvements at Prewett Water Park. On March 8, staff received four bids for the Spray Ground and seven bids for the playground. The low bid for both projects was submitted by Sierra Valley Construction. The City council will consider awarding the construction contracts on March 22. Both projects are expected to be completed in September 2016.
- North East Annexation Infrastructure Improvements: Staff is drafting a Request for Proposal for consulting services to provide engineering services and to prepare preliminary plans, estimates and studies for the planning and the design of infrastructure improvements needed to serve the newly annexed Area 1 and 2B.
- Pavement Management Technical Assistance Program (P-TAP) Grant: The city
 was awarded grant funding from MTC for AMS consulting services to assist the City
 in implementing and maintaining the annual Pavement Management Program
 System by inspecting the pavement conditions of arterial, collector and residential
 streets and provide us with design recommendations for pavement rehabilitation
 projects. AMS Consulting will start the pavement survey and inspection work in
 April.
- 2016 CalRecycle Rubberized Pavement Grant: The City was awarded \$250,000 of grant funding for the 2016 Pavement Management Program, which will include potential streets recommended to receive Rubberized Cape Seal treatments.
- 2016 Transportation Development Act (TDA) Grant: MTC solicited applications for 2016/2017 TDA grants for Pedestrian and Bicyclist improvement projects. The City Council approved a resolution of support for the \$130,000 grant funding application at the January 12th meeting; the Parks and Recreation Commission approved a resolution of support at their January 21st meeting. The grant application includes funding for curb ramp upgrades to meet ADA requirements, installation of new sidewalks at needed locations and for bicyclist improvements along Cavallo Road, "A" Street, "G" Street, Putnam Street and Carpinteria Drive. Notification of grant awards is expected in May.

Water Treatment Plant

- Cleaned Solar Bees out on the municipal reservoir. Solar Bees circulate the water in the reservoir; cleaning the Solar Bees prevents weeds from restricting the circulation. Cleaned the staff gage on the tower.
- The Water Treatment Plant (WTP) held HAZWOP classes on March 2nd and 9th at "B" plant. This class is for handling hazardous material and is open to outside agencies.
- At Dallas Ranch Pump Station, staff removed the #2 control valve from service to clean and rebuild.

Water Distribution

- Water Distribution staff had 327 stops for water service including disconnections.
- Water Distribution staff had a total of 59 USA tickets completed for utility location.
- Water Distribution meter reading has started for the month of March and is on schedule.
- Water Distribution staff issued three drought notices this week.
- The State Water Board has Extended Emergency Water Conservation Regulations through October 2016.
- Water Distribution staff continues to monitor water meters, conservation and usage at all City buildings and parks.
- Water Distribution staff continues to respond to drought hotline inquiries.
- Water Distribution staff responded to customer calls regarding water maintenance issues city wide.
- Water Distribution staff repaired a fire hydrant on Larkspur Drive.
- Water Distribution staff replaced a 2" backflow on James Donlon Blvd. at Country Hills Drive.
- Water Distribution staff replaced a broken curb stop on Lone Tree Way.
- Water Distribution staff continue state mandated annual backflow testing.
- Water Distribution staff performed preventative maintenance on fire hydrants city wide.
- Water Distribution staff hauled off green waste for recycles as well as cleaned up debris at the City's Fulton yard.
- Water Distribution Operators attended training in preparation for State Water Distribution Exam on March 19th.
- Central Stores staff continues to remove graffiti from Amtrak platform and Fulton Shipyard Rd. boat ramp areas.
- Central Stores staff assisted Vehicle Shop with entry of information for three new fleet vehicles into the FuelMaster passive fueling system.
- Central Stores staff placed orders for new employee uniforms and personal protective equipment.

Public Works Operations – Parks and Landscape

- Playground and Park Safety Inspections: Completed at Antioch Community, Canal, Gentrytown, Hillcrest and Village East Parks. A follow-up inspection was completed at Williamson Ranch Park.
- Chichibu Park: Shut down a leaking hose bib pending repair.
- City Park: The soccer field turf is undergoing a complete renovation and is temporarily closed to the public.
- Gentrytown Park Delta Diamond: The baseball field turf and infield is undergoing renovation and is temporarily closed to the public. Water is off.
- Harbour Park: Replaced 12 missing valve box lids.
- Marchetti Park: Repaired a leaking toilet.
- Markley Creek Park: Repaired the dog drinking fountain.
- Recycled Water Parks: Completed first quarter inspections at Chichibu, City, Fairview and Mountaire Parks.
- Williamson Ranch Park: Replaced two lamps in the women's restroom.
- Tree Removal Permits: Tree Removal Permits were issued to PG&E for 4023 Banbury Way and 4342 Mink Court.
- Irrigation: Repaired 12 irrigation leaks on City property.
- Leaf Removal: James Donlon Blvd. rights of way.
- Spot Spray: Somersville Rd. and James Donlon Blvd.
- Trim Crews: Hillcrest Pump Station, Bear Ridge Pump Station, and the Silverado Trail.
- Weed: Mira Vista Pump Station.
- Accident Sites Inspections: Inspected eight accident sites on City rights of way.

Public Works Operations – Street Maintenance

- Graffiti Abatement: Removed graffiti from City property in numerous areas.
- Signs: Replaced 90 existing signs due to poor reflectivity.
- Lane Delineators: Replaced 1,326 raised pavement markers at various locations.
- Debris: Picked up one yard of debris in City rights of way.
- Potholes: Filled ten potholes.
- Striping: Painted 139 stencils and 905 feet of 12 inch crosswalks.

Public Works Utilities – Collections Division

- Calls for Sewer Service: Received and responded to seven calls for service from the public. Responding crews televised 70 linear feet of public sewer laterals connecting to the City's sewer system.
- Sewer Mains: Daily preventative maintenance performed on over 21,440 linear feet of sewer main lines.
- Quarterly Sewer Main Cleaning: The route schedule is under review to increase inspection frequency of identified 'hot spots' and integrate a proactive preventative cleaning schedule for the 'hot spots'.

- Sewer Lateral Maintenance Program (SLMP): Crews repaired two laterals that were severely damaged requiring immediate repair. Crews televised one lateral.
- Manhole Inspection Program: Crews inspected 79 manholes. Manholes are inspected for loose lids, debris, locking mechanisms, and status of infrastructure for future maintenance and rehabilitation. We are updating the program and processes for integration in our computerized maintenance management system.
- Sanitary Sewer Overflow (SSO) Reduction Program: Staff is working on formal inspection criteria to inspect manholes in rural areas. The use of "SMART Manholes" in strategic areas will be utilized that will alert leadership staff within the division of potential SSOs. This program will also address the need for locking mechanisms.
- Closed Caption Televising (CCTV): Crews televised 4,199 feet of sewer main lines.
 The CCTV Preventative Maintenance crew inspects sewer mains to identify the condition and causes of blockages and SSOs.
- National Pollutant Discharge Elimination System (NPDES): Crews removed 34 yards of trash and debris, 18 shopping carts and a mattress from various creeks and channels. Sprayed one acre and weed abated .9 acres of entry way access to channels. These activities ensure the City meets the Federal Clean Water Act requirements of municipalities discharging storm water into waterways.

Public Works Operations – Fleet Division

- Preventative Maintenance: 15 services on City vehicles as scheduled.
- Unscheduled Repairs: 65 unscheduled, necessary repairs to City vehicles.

Public Works Operations – Municipal Marina

- New Occupancy: The Marina has approved one permanent application, responded to four berthing inquiries and gave one facility tour.
- Maintenance: Painted curbs in the Marina parking lot. Removed debris and logs from the Marina basin. Secured the sink in the public restroom as well as various other repairs. In the process of repairing the pump-out at the fuel dock.
- The <u>Lady Washington</u> and <u>Hawaiian Chieftain</u> will return this Wednesday March 2nd - 9th to offer battle and adventure sails to the public. Weekday evening value priced tickets are available. More information can be found at: http://historicalseaport.org.

- On 3/3/16 at 8:44 pm, 32 year old Louis Braggs was contacted after officers responded to the report of a subject brandishing a handgun in the area of West 10th St and J St. Upon arrival, Braggs was located nearby on 801 West 8th St. He matched the description of the subject with the gun. During a search, he was found to be in possession of a meth pipe and air soft handgun. He was booked at APD and later cite released.
- On 3/3/16 at 10:29 pm, officers were dispatched to a report of a vehicle into the water at the Antioch Marina. 22 year old David Quintanilla who works as marina security called 911 to advise that a female had driven her car off of the boat ramp and into the water. - On 3/3/16 at 5:17 pm, officers were called to a report of a large group of juveniles arguing at the Jacobsen Park locate at 1600 Jacobsen St. An area check was conducted and at the time no one was fighting. Most of the juveniles began leaving upon seeing the officer. A short time later, many of the juveniles returned and began fighting again. This time a male subject pulled out a gun and fired one round. Everyone scattered and left the area prior to our arrival. At

the time of this writing, we have not identified any victims and no reported gunshot victims arrived at area hospitals.
